**Enrollment Criteria:**

A student may be enrolled in the Extended Day Program summer camp that is:

- Able to be independent in daily self-care needs, such as toileting, feeding, and dressing themselves.
- No danger to him/herself or others.
- Able to participate in group activities with an adult/student ratio of 1 adult to 20 students.
- Able to remain within the program location and under supervision without running away

**REGISTERING PARENT ACKNOWLEDGEMENT**

By registering my child(ren) for the Extended Day summer camp, I confirm that I have read over and understand the summer camp guidelines. I confirm that my child meets the enrollment criteria. I understand that late fees are applied for late pick-ups and late payments. I understand the hours of camp are 6:30am-5:00pm. Drop off is 6:30am-8:00am and pick-up is 3:30pm-5:00pm. I understand the camp is not prorated and each student receives one absence week per camp session. I understand that if my child is currently in Extended Day and received 2 or more incident forms, summer camp is on a trial basis. If it is determined that my child is not consistently meeting the enrollment criteria, they will no longer be able to attend camp. A student's ability to attend a field trip may be removed as a consequence to not following program guidelines. I have read and understand the summer camp guidelines. My signature on the application form confirms my agreement to the program guidelines.

### Extended Day Program Summer Camp Guidelines

Thank you for utilizing the Extended Day Program Summer Camp. Below you will find information and guidelines that are specific for camp this summer. We ask that you read the information carefully to ensure that you and your child follow the guidelines.

- The program will operate Monday thru Friday from 6:30am-5:00pm.
- Students that were in grades K-5 during the 2024-2025 school year and meet the enrollment criteria are eligible to enroll in summer camp.
- Breakfast and lunch are provided by School Nutrition Services.
- Students will need to bring an afternoon snack.
- Students are to bring a water bottle to camp daily to keep in their assigned area.
- Parents or the designated adult must present their ID during the pick-up process.
- Only persons listed on the registration form can pick up the child.
- All persons picking up students must be 18 years of age or older.
- Changes to the pick-up list are not accepted over the phone.
- Student drop-off will take place between 6:30am-8:00am and student pick-up will take place between 3:30pm-5:00pm.
- Weekly payments are accepted on Mondays during drop-off by check or money order on site. Parents can also pay online at [www.myschoolbucks.com](http://www.myschoolbucks.com)
- On Tuesday, payments are considered late, and a \$12 late fee will apply.
- If a child is picked up after 5:00pm, a late fee of \$10.00 for every 15 minutes late will be applied to the account per child.
- Any staff member or student that is sick or not feeling well are to remain home.
- There will be on site guest presentations and field trips.
- If the minimum numbers of students needed for a camp site to operate is not reached another site will be offered.
- Each student is provided a t-shirt for field trips. T-shirts are distributed the first week of camp.
- On the days of field trips, all students need to arrive by 7:30am and wear their Extended Day summer camp t-shirt.
- All Extended Day summer camp staff members attend field trips.

**Summer activities may include the following: Super Cool Science Activities, Rockstar101, Movies, Bowling, Medieval Times, Green Meadows Farm, Environmental Center, Wild Florida, and Orisi Risi. Activities are subject to change.**

**Weekly Camp Fee:** \$125.00/\$120 for each additional child (camp fees are not prorated based on attendance. Week one is \$75 due to 3-day camp week)

\*Registration includes the enrollment fee and fee for the first week of camp. Once the application is received and processed; the parent will be contacted to make payment and confirm the child's spot in camp.
