Methods of Payment

Payments can be made on Fridays (morning and afternoon) and Mondays (morning) to the site lead by check or money order. Payments are accepted daily in the main office in person or via phone. Payments can be made online at www.myschoolbucks.com

Payment Policy

Payments are due by the Friday prior to the week of service. Late payment fees are assessed as follows: Program fees are past due as of 6:30am on Tuesday (or the second day of the week) of service. Past due and late fees must be paid no later than Friday of the week of service. The past due rate is \$12. Failure to comply may result in your child(ren) being withdrawn from the program.

Late Pick Up Fee Policy

All children are to be picked up no later than 6:00pm. If a child is picked up after 6:00pm, a late pick-up fee is applied to the account. If the child is picked up late three or more times, your service may be subject to cancellation.

First 15 minutes late: \$10.00 per child / First 30 minutes late: \$20.00 per child / First 45 minutes: \$30.00 per child / Over 1 hour late: \$40.00 per child.
