This Addendum is being issued to clarify areas, statements, requests, and specifications in the original document that the District felt needed an extra explanation, to answer questions that have been submitted by prospective bidders, or to correct mistakes or errors.

1. Questions & Answers:

- a. Q. Confidentiality of Financials.
A. ***Bidder must state under what Florida Statute the Financial would be exempt from Public Records Law.***
- b. Q. What funding source will be used to cover the rental of these units?
A. ***2 mils funding.***
- c. Q. What type of lease(s) would the Board be entertaining?
A. ***Municipal.***
- d. Q. What is the make-up of the committee that will be evaluating the written responses and the oral interviews?
A. ***As of today, the committee is made up of the Executive Director of Contract Services [Sam Henderson {Voting Member}], Health and Safety Specialist [Mark Cavinee {Voting Member}] Foremen from Maintenance [Chip Bishop {Voting Member} & David Pridemore {Voting Member}], Chief Building Inspector [Pete Caporlingua {Voting Member}] and/or others as deemed appropriate [Tom Salley, Maintenance Supervisor Non-Voting Member] and Neil D. McDonald, Purchasing Supervisor {Non-Voting Member}].***

2. Combination of Rental Terms: Bidders may bid other combinations of rental terms and units; i.e., 3 years with a different buy-out amounts, 5 years with a different buy-out amounts, 10 years with a different buy-outs, and so on. Bidders are also encouraged to bid other items that could be "rented"; i.e., rental of ramps & steps, as an example.
