This Addendum is being issued to clarify areas, statements, requests, and specifications in the original document that the District felt needed an extra explanation, to answer questions that have been submitted by prospective bidders, or to correct mistakes or errors.

1. QUESTIONS & ANSWERS:

- a. Q: What will the salary be for a Licensed Speech Pathologist?
A: **This is not a simple question to answer. The "base" salary schedule for a Licensed Speech Pathologist w/CCCs and a bachelor's degree with no experience is \$36,000. With additional years of experience and advanced degrees, and "supplements" that COULD go to \$61,892.**
- b. Q: Are there other areas within the District that might need or want our service?
A: **There could be. It must be understood that the main focus of this bid is for Licensed Speech Pathologist. If the bidding firm would like to quote pricing of other positions in other areas, the Board may consider this pricing.**
- c. Q: What is the Budget amount for this contract?
A: **At this time there is no set budget; the allocations would be at the school level. The current need would be for several full time and several part-time therapists. These needs could vary throughout the school year.**
