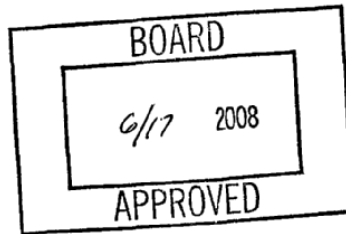


The School Board of Osceola County, Florida, meeting in official session on June 17, 2008, voted to award the above mentioned solicitation to your company.
