The following questions were received in regards to the above mentioned bid:

QUESTION: Can our Tech do a walk thru where the Repeaters will be located and where the antennas are going to be mounted before June 27?

ANSWER: Site visits will be conducted with a project manager from the Technology Services department on an as needed basis. At that time it will be determined where the repeaters and antenna will be mounted. Since this is a term contract, there will be a variety of different locations over the course of the contract.

QUESTION: Are the Repeaters replacing older repeaters? **ANSWER:** The majority of repeaters will be for new schools. However existing repeaters will be replaced on an as needed basis.

QUESTION: What model or models of radios does Osceola School District have at this time that will need to be reprogrammed?

ANSWER: The School District has currently tried to standardize on the two-way radios that are purchased for new schools, ICOM F-24 UHF is currently being purchased for new schools. However the School District also has many locations that still have multiple models of ICOM, Kenwood and Motorola two-way radios.
