This addendum is issued to make corrections to the Request for Qualifications Package.

On Page 3 - Scope of Services is amended to read as follows:

- 10. Fire Alarm System Replacement** ~~A/E shall be required to coordinate with Owner's Fire Alarm System Design Consultant. Scope of work shall include the removal of the existing fire alarm system and the design and installation of all fire alarm devices throughout the campus. Also includes the installation of conduit to support the re-wiring of all devices. Wiring shall include the installation and termination of fiber optic cable to allow for the connection of remote buildings. A/E shall be responsible for including the required components to properly interface the HVAC System with the Fire Alarm System.~~

On Page 11 – Proposed Project Staff and Functions is amended to read as follows:

Tab 11 Proposed Project Staff and Functions (25 points)

Respondents shall express the general and specific project related experience and capability of in-house staff and sub-consultants and their functions as it relates to this project.

Respondents should name the actual staff to be assigned to this project, describe their ability and experience, job skills, education, training, experience and portray the function of each within their organization and their proposed role on this project. Replies must include current GSA Standard Form 330 AIA-A305 form with information on all professional level personnel who would be assigned to the Project. Proposed project staff should be present for oral presentations and/or interview.
