### Addendum #6

This addendum is being issued to clarify and or answer any questions regarding the subject Bid.

#### Question:

The specs on the current bid call for the laptop to ship with Windows XP and Windows Vista Ultimate License, Can we ship with Windows XP instead and provide the Windows Vista Business license instead? Is the district planning to upgrade to Windows Vista Ultimate in the future and that's why you are specifying Ultimate? Using Vista Business license saves the district money, so if there is no plan to upgrade then it would make more economic sense to go with the Vista Business License..

#### Answer:

#### Question:

On the last Bid 08-B-125-CB for Elementary School "J", and on the current Bid 09-B-017-CB for laptops you specified 5 Year on-site Warranty Labor and Parts. We were surprised to find out that the winning bid by Lenovo specified 5 Years Depot, not on-site and is considerably less expensive. Was that an oversight or is the District OK with 5 years Laptop Depot Warranty on this current Bid and going forward?

#### Answer:

Lenovo is providing on-site service.

#### Question:

On the last Bid 08-B-125-CB for Elementary School "J", and on the current Bid 09-B-017-CB calls for a 12-Cell Battery, HP uses a 6-cell rated at 7 hours and 15 minutes maximum battery life, will that be an acceptable substitute? In the previous Bid 08-B-125-CB for Elementary School "J", Lenovo didn't use a 12-Cell battery and they still won the bid.

#### Answer:

No, we have not changed our specifications or requirements for the 12 cell battery. A 12-cell battery is still required.
