Question: Do only the high schools have tracks?

Answer: No, but they are the only sites that are getting rubberized surfacing.

- Question: How many high schools are currently have in the District, do they all have rubberized tracks, if so what type of surfacing is currently on them?
- **Answer:** We currently have seven (7) high schools and to the best of the Purchasing Departments knowledge with the following surfacing:
 - Celebration High School- Currently Just Asphalt
 - Gateway High School- Latex, repair and reconditioned in Sept. 2007
 - Harmony High School- Latex, repair and reconditioned in Dec. 2005
 - Liberty High School- Latex, repair and reconditioned in Jan. 2008
 - Osceola High School- Latex, repair and reconditioned June 2004
 - Poinciana High School- Latex, repair and reconditioned in Jan. 2008
 - Saint Cloud High School- Latex, last repair and reconditioning unknown
- Question: How many schools in the District are currently requiring repair or resurfacing?
- Answer: There are three (3) schools that currently require repair or resurfacing. Liberty High School and Celebration High School need resurfacing. Gateway High School needs repairs.
- Question: Is the District requiring that the successful bidder must be a Certified Track Builder (CTB)?
