Page 6, Section 1.05, Products #3, Second Sentence Reads: Design for wind load of 110 mph per ANSI A58.1, 1982 ed., exposure "C" with importance factor of 1.11 = 120 mph and 35 psi live load.

As the District has locations that fall in two different wind load requirements, therefore the District has standardized and requires the most stringent of the two. Change to read: Design for wind load of 110 mph per ANSI A58.1, 1982 ed., exposure "C" with importance factor of **1.15** = 120 mph and 35 psi live load **or based on the new 2007 Florida Building Code due out in early spring whichever is the most stringent.**
