The filters shall have a minimum efficiency reporting value (MERV) of 8 when evaluated under ASHRAE Standard 52.2-2007. They shall have a MEERV-A of 8 when evaluated under Appendix J of the same Standard.

#### On page 5, Section 1.03 C add:

Provide product laboratory test report for each depth listed including all details as prescribed in ASHRAE Standard 52.2 – 2007 including Appendix J. Date of the tests must be within the last two (2) years.

#### On page 5, Section 1.03 D add:

The filter shall have a minimum efficiency reporting value (MERV) of 14 when evaluated under ASHRAE Standard 52.2 – 2007. They shall have a MERV-A of 14 when evaluated under Appendix J of the same Standard. Provide product laboratory test report for each depth listed including all details as prescribed in ASHRAE Standard 52.2 – 2007 including Appendix J. Date of the tests must be within the last two (2) years.

#### On page 5, Section E change to read:

Provide one (1) filter sample of each of the following sizes:

24 X 24 X 1

24 X 24 X 2

13 X 271/2 X 1

24 X 24 X 12

To correct a couple errors on the Price Sheet and add some omitted filter sizes the price sheet has been revised. Remove the original price sheet and replace with the Revised Price Sheet dated 5/4/09. See Attachment 2 the Revised Price Sheet.
