This Addendum is being issued to clarify areas, statements, requests, and specifications in the original document that the District felt needed an extra explanation or to answer questions that have been proposed by prospective bidders.

#1 Questions and Answers from submitted, written questions and questions from the Pre-Conference Meeting held March 10, 2009:

1. **QUESTION:** Performance Bonds: Will 100% Performance Bond be required for each of the four (4) different school sites?
ANSWER: *Yes.*
2. **QUESTION:** Conduit Runs: How much infrastructure has been completed to date?
ANSWER: *To date, 80% of the infrastructure has been completed. The conduit runs will be complete at all four (4) schools prior to the Audio Systems being installed.*
3. **QUESTION:** Electrical Semantics of the Schools: Are plans available for the bidders to review for these projects? If so, where?
ANSWER: *Yes, and plans are available for review in the School District's Purchasing Department.*
4. **QUESTION:** Audio Systems: Are these "stand alone" systems per classrooms?
ANSWER: *Yes.*

5. **QUESTION:** Oral Presentations: How much time will we have for Oral Presentations?
ANSWER: *Respondents will be given ninety (90) minutes to setup audio equipment to be demonstrated, computer for presentation if needed, presentation, question and answer part of presentation, and tear-down of all equipment.*
6. **QUESTION:** How many classrooms, for this project, will be receiving the systems in each of the four (4) schools?
ANSWER: *There are sixty-one (61) classrooms in the elementary schools and sixty-five (65) classrooms in the middle school. However, the School Board will also include a system in each of the four (4) school's media centers; the system for the media centers shall be a "zoned" system, a system that could be actively used for the whole media center or split into two (2) zoned sectors.*
7. **QUESTION:** Is there a break down in regards to how many 50 watt systems vs. 30 watt systems?
ANSWER: *No. Bidders should price both systems; the 30 watt and the 50 watt.*
8. **QUESTION:** Where will the receiver/amplifier be located – on a separate shelf or in an AV cart/cabinet?
ANSWER: *The receiver/amplifier will be located on top of the storage cabinet.*
9. **QUESTION:** What is the configuration of the audio inputs (e.g., computer, DVD/VCR, tuner) to be connected to the receiver/amplifier?
ANSWER: *The configuration of the audio inputs is as addressed in the solicitation.*
10. **QUESTION:** Will the "short" listed companies be permitted to install a system and integrate with the audio input technologies that will be installed in the four (4) schools for the Oral Presentation?
ANSWER: *No.*
11. **QUESTION:** Refer to page 29, Section 4.02.D, "Ownership Interests". What information is the District looking for?
ANSWER: *The main business interests of the firm.*
