QUESTION: Does St. Cloud High School have any asbestos or other hazardous materials that would require Asbestos Surveys, Asbestos Monitoring during renovation or an on-site CIH?

ANSWER: There are no friable products present to the District's knowledge. If any is uncovered during operations, the District will handle the abatement, as the General Construction Manager contract specifically mandates this course of action due to insurance reasons.

QUESTION: What licenses are required for the roofing inspector?

ANSWER: The roofing inspector needs to be a Certified Building Inspector by the Department of Business and Professional Regulations as required under Florida Statute 468.
