All questions concerning the validity, operation, interpretation, construction and enforcement of any terms, covenants or conditions of this Contract shall in all respects be governed by and determined in accordance with the laws of the State of Florida without giving effect to the choice of law principles thereof and unless otherwise preempted by federal law.

- 22. ACCEPTANCE: Products purchased as a result of this invitation may be tested for compliance with specifications. Items delivered not conforming to specifications may be rejected and returned at bidder's expense. Those items and items not delivered by the delivery date specified in accepted offer and/or purchase order may be purchased on the open market. Any increase in cost may be charged against the bidder.
- **23. SAFETY WARRANTY:** Any awarded supplier/provider including dealers, distributors, and/or manufacturers shall be responsible for having complied with all Federal, State, and local standards, regulations, and laws concerning the product or service specified, and the use thereof, applicable and effective on the date of manufacture or use or date in service including safety and environmental standards as apply to both private industry and governmental agencies.

- 24. WARRANTY: The offeror agrees that, unless otherwise specified, the product and/or service furnished as a result of this invitation and award thereto shall be covered by the most favorable commercial warranty the offeror gives to any customer for comparable quantities of such products and/or services and that the right and remedies provided herein are in addition to and do not limit any rights afforded to the School Board by any other provision of the invitation/offer.
- **25. AWARD:** As the best interest of the School Board may require, the School Board reserves the right to make award(s) by individual item, group of items, all or none, or a combination thereof; on a geographical basis and/or on a district wide basis with one or more supplier(s) or provider(s); to reject any and all offers or waive any irregularity or technicality in offers received. Offerors are cautioned to make no assumptions unless their offer has been evaluated as being responsive. Any or all award(s) made as a result of this invitation shall conform to applicable School Board Rules, State Board Rules, and State of Florida Statutes.
- **26. VIOLATIONS:** Any violation of any of the stipulations, terms, and/or conditions listed and/or included herein may result in the offeror/bidder being removed from the School Board Bid list and the offeror/bidder being disqualified from doing business with the School Board for a period of time to be determined on a case-by-case basis.
- **27.** For purposes of this Invitation and evaluation of responses hereto the following shall apply: unit prices shall prevail over extended prices; written matter shall prevail over typed matter; numbers spelled in word form shall prevail over Arabic numerals ("one" over "1"). When not inconsistent with context words used in the present tense include the future, words in the plural number include the singular number, and words in the singular number include the plural number. The word "shall" is always mandatory and not merely directory.
- 28. GENERAL INFORMATION ABOUT THE DISTRICT: The District and its governing board were created pursuant to Section 4, Article IX of the Constitution of the State of Florida. The District is an independent taxing and reporting entity managed, controlled, operated, administered, and supervised by School District Officials in accordance with Chapters 1000-1013, Florida Statutes. The Board consists of five elected officials responsible for the adoption of policies, which govern the operation of the District public schools. The Superintendent of Schools is responsible for the administration and management of the schools and it's departments within the applicable parameters of state laws, State Board of Education Rules, and School Board policies. The Superintendent is also specifically delegated the responsibility of maintaining a uniform system of records and accounts in the District by Section 1010.01, Florida Statutes as prescribed by the State Board of Education.

The District is coterminous with Osceola County. The annual budget for the District for 2007-2008 school year totals \$999,422,956, including an operating budget of \$461,355,469, and a capital budget of \$401,140,409. The District operates thirty-nine schools, which includes twenty -one (21) elementary schools, seven (7) middle schools, eight (8) high schools, two (2) K thru 8 schools, and one (1) 6th thru12th grade school. The District is also responsible for twelve alternative educations sites, and seven charter schools. The total full-time K-12 projected enrollment of public school students for August 2007 is 53,070. 29. UNIFORM COMMERCIAL CODE: The Uniform Commercial Code (Florida Statues, Chapter 672) shall prevail as the basis for contractual obligations between the awarded Contractor and the School District of Osceola County for any terms and conditions not specifically stated in this InvitationTo Bid.

SCHOOL BOARD – The term "School Board" herein refers to the School Board of Osceola County, Florida, and its duly authorized representatives and any school, department, or unit within the School District.

USING AGENCY – The term "using agency" used herein refers to any school, department, committee, authority, or another unit in the School District using supplies or procuring contractual services as provided for in the Purchasing Department of the School District.

The purpose of this Invitation To Bid (ITB) is to solicit competitive sealed Bids to furnish Fire Alarm System Inspections, Testing, Monitoring and Installation for the use of The School District of Osceola County, Florida.

1.0 SCOPE

1.1 This Specification establishes the minimum requirements for this solicitation, listed and described in the body of these specifications, to be used as noted, by The School District of Osceola County.

1.2 AWARD TERM

The School Board's goal is to promote partnership relationships within the policies and procedures of public procurement. Pursuant toward that end, the successful bidder(s) shall be awarded a contract for an initial three year term with one subsequent two year renewal.

The award term recommendation will be that which is determined to be in the best interest of the School Board. All renewals will be contingent upon mutual written agreement and, when applicable, approval of School Board.

2.0 PRODUCTS OR SERVICES TO BE PROVIDED, AND APPLICABLE SPECIFICATIONS

The purpose of the Invitation To Bid is to provide the District with qualified Contractor(s) to perform all operations in connection with remote station monitoring, inspection, testing, and installation of Fire Alarm Systems for the School District of Osceola County, Florida. The intent of this Invitation To Bid is to assure that the Life Safety/Fire Detection and other related systems servicing the District's facilities are properly monitored, inspected, tested, and installed in compliance with NFPA 72, NEC 70 Florida Administrative Rules, and SREF codes. The District intends to utilize this contract for the performance of: 1) inspection and testing, and 2) monitoring of the District's existing fire alarm systems, as well as the 3) design and installation of new systems, due to but not limited to; renovations, additions, relocation of portables, and the installation of additional portables throughout the District. The awarded Bidder must have the ability to upgrade existing systems to ensure they meet current standards; interface new or existing fire alarm systems with other alarm and notification systems (burglar detection, intercom, etc.); and keep existing (older) fire alarm systems operational during a retrofit process. The awarded Bidder shall provide a web-based reporting system for creating, updating, and maintaining all service work, inspections, and maintenance performed.

2.1 SERVICING PERSONNEL

The awarded Bidder's key personnel must have a minimum of five (5) years experience installing, servicing, maintaining, and repairing fire alarm systems for educational facilities within the State of Florida. The awarded Bidder(s) shall have employees that meet the following requirements for the term(s) of this contract:

- 1. One (1) Professional Engineer on staff or on retainer, certified by the Florida Bureau of Professional Engineers.
- 2. Minimum (1) NIČET level 4 (Senior Engineering Technicians) on staff. Two preferred.
- 3. Two (2) NICET level 3 (Engineering Technicians) on staff.
- 4. Four (4) NICET level 2 (Associate Engineering Technicians) or higher on staff.
- 5. Two (2) Technicians certified on Silent Knight Control Panels, Model #IFP-1000 & 2000
- 6. All service and inspection personnel shall be in compliance with Florida Statutes 4898 and certified as Fire Alarm System Agents.
- 7. Bidder must provide the following information in its bid submittal for each employee assigned to perform services under this contract:
 - A. Photograph of the employee
 - B. Name of the employee
 - C. NICET certificate number and grade
 - D. Alarm Company's Name, address and phone number
 - E. Contractor License holder's signature

- F. Employee's signature
- 8. Provide proof of Continuing Education requirements upon request of the Osceola County School Board.
- 9. Fire Alarm Service Agent (FASA) Card must be available at all times with each employee performing work under this contract.

If the Bidder's personnel status changes after the award of this solicitation, the awarded Bidder(s) is required to notify the District. If the awarded Bidder(s) is unable to maintain the required staff, the District may terminate the award for failure to continue to meet the minimum requirements of the Invitation To Bid.

2.2 FIRE ALARM SYSTEM "LOGBOOKS"

Documentation - The awarded Bidder(s) shall update each "Fire Alarm System Logbook" when the system is inspected, tested, maintained, repaired, upgraded, altered, etc. This logbook shall contain at minimum the following:

- 1. Documentation to record all work performed on the fire alarm system. This form shall contain the following information;
 - A. Date and Time of repair/inspection/test etc.,
 - B. Name and address of protected property,
 - C. Service entity's name, address and phone number,
 - D. Name of Service Technician/Inspector,
 - E. Description and location of equipment in the building where repair work was performed,
 - F. Type of repair work performed on the system,
 - G. Drawings of the fire alarm system showing the location of each device in the system and the number assigned to each device in the system,
 - H. When work is performed on any device in a fire alarm system, the device number shall be listed in the Fire Alarm System Logbook, and
 - I. System operating instructions.

2.3 INSPECTIONS AND REPORTING

The awarded Bidder shall perform all visual inspections of the system and connected devices in accordance with NFPA 72 (2002 edition) chapter 10, Table 10.3.1. The awarded Bidder shall ensure visually that there are no adverse changes that may affect the system performance.

1. The awarded Bidder shall employ a Bar-Coded system to meet the requirements of District's current fire alarm inspection documentation systems - <u>www.buildingreports.com</u> or equal.

2. Web-based Reporting System

The awarded Bidder shall provide the District with access to a hosted web-based reporting system for creating, updating and maintaining all service work, inspections, and maintenance performed as part of this specification.

3. Inspection Portal and Online Access

The awarded Bidder shall provide the District with a secure hosted Inspection Portal for review of reports and other data used in the web-based reporting system. Inspection Portal must be capable of providing color coded status flags (or other approved status indicator) for immediate notification of inspection results.

- A. Green flag for passed inspections
- B. Yellow flag for inspections with notes and/or recommendations
- C. Red flag for inspections with failures or other discrepancies

4. Inspection Reports/Data

- A. Report will be supplied in each of the following formats:
 - 1. Online Viewable over the Internet in a web page.

- 2. Download Ability to download.
- 3. Email Microsoft Word Document attached to an email.
- B. Hard copy report is required to be submitted by the vendor to the District's Health & Safety Department upon completion of the inspection,
- C. Report Format The inspection report is to include the following sections (or tabs, if hard copy) at a minimum:
 - 1. Inspection Log A listing of every device installed in a building by location, services performed and the time and date of service.
 - Discrepancy Report A listing of any devices that did not pass the inspection. The report should include a description for each device or item.
 - 3. Proposed Solutions Report Solutions for any discrepancies found in the report. This report should include the services to be performed in order to correct any discrepancies found during the inspection.
 - 4. Device Inventory Report An inventory listing of the quantity of devices by manufacturer, model number, and installation date. The inventory report should also group by installation date to allow for consideration of replacement of older devices, if necessary or required elsewhere in this specification.
- D. Delivery of Inspection Reports Reports shall be completed by the vendor and submitted online for access and review by the District within 24 hours of completion of inspection. Printed reports shall be delivered by the awarded Bidder to the District's Health & Safety Department within 72 hours after completion of inspection. The awarded Bidder shall also provide a complete printed report for the School District Fire Alarm System Logbooks.

5. Backup/Archive Services

- A. Awarded Bidder shall provide secure online access to data and reports for a period of at least five years. All data and reports shall be available for access 24 hours a day, 365 days a year for a minimum of 5 years using only a standard Internet browser.
- B. After the initial 5 year period, a data archive shall be available for a minimum of 2 years. After this period, data shall be made available on a CD/DVD or other suitable media for archival purposes and delivered to the District upon request.
- C. Data for the system shall be backed up daily onto other hard drive media. Tape backup systems are not permitted for data back-ups.

2.4 TESTING

All Fire Alarm System tests must be scheduled in advance with the School Principal or Site Administrator only. All horn tests (sounding of horns) must be conducted after 4:30 PM; personnel at each site must receive advance notice of all Fire Alarm System tests.

2.5 TESTING PROCEDURES

Fire Alarm System Testing shall be in accordance with NFPA 72 (2002 Edition) Section 10.4.2.2. The awarded Bidder shall provide dedicated Inspection Team(s) to perform all tests and inspections. The team(s) shall be comprised of a minimum of two (2) dedicated, NICET certified Inspection Technicians. The awarded Bidder shall provide the team(s) with all the necessary Fire Alarm Inspection tools and test equipment. Inspection personnel shall be formally trained on Fire Alarm System Inspection procedures by a nationally recognized training provider.

Before proceeding with testing, all persons and facilities that will receive an alarm, supervisory, or trouble signal as a result of a test shall be notified by the awarded Bidder to prevent unnecessary response. All building occupants shall also be notified. At the conclusion of testing those previously notified shall be further notified that testing has been concluded.

2.6 EQUIPMENT/DEVICE TESTING

- 1. **Horn Tests-** Sounding of horns must be conducted after 4:30 PM; personnel at each site must be noticed in advance of such tests. All tests must be scheduled in advance with the School Principal or Site Administrator only.
- 2. **Control Equipment-** Awarded Bidder shall test all functions of the system in various alarm and trouble modes, including but not limited to:
 - A. Open circuit conditions, 2) Grounds and 3) Power outage.
 - B. All tests shall be in accordance with the system manufacturer's instructions.
 - C. Remove fuse(s) and verify rating and supervision.
 - D. The integrity of single or multiple circuits providing interface between two or more control panels shall be verified. Interface equipment connections shall be tested by operating or simulating operation of the equipment being supervised. Signals required to be transmitted shall be verified at the control panel.
 - E. Lamp and LEDs shall be illuminated.
 - F. The primary (main) power supply shall be tested by disconnecting all secondary (standby) power. The primary (main) power supply shall be tested under maximum load, including all alarm appliances requiring simultaneous operation. All secondary (standby) power shall be reconnected at the end of the test. Redundant power supplies shall be tested separately.
- 3. **Remote Annunciators** Remote Annunciators must be verified for proper operation and identification. Where necessary, verify proper operation under fault conditions.
- 4. Initiating Devices-
 - A. Pull stations must operate per the manufacturer's specifications and instructions. Key operated pre-signal devices shall be tested for pre-signal and general alarm circuits.
 - B. Each smoke detector shall be tested in place with verification of smoke entry into the sensing chamber and alarm response. Testing with smoke or listed aerosol acceptable to the manufacturer, or other means acceptable to the detector manufacturer shall be permitted as an acceptable test method. Verify that each detector is within its listed and marked sensitivity range by testing using either:
 - 1. A calibrated test method, or
 - 2. The manufacturer's calibrated sensitivity test instrument, or
 - 3. Listed control equipment arranged for the purpose of smoke and/or heat detection.

Note: The detector sensitivity shall not be tested or measured using any spray device that administers an unmeasured concentration of aerosol into the detector.

- C. All air duct detectors shall be tested and inspected to ensure the device will sample the air stream. The test shall be in accordance with the manufacturer's instructions. All air duct detectors shall be cleaned before testing to avoid false alarms.
- D. Heat detectors such as fixed-temperature, rate-of-rise, rate compensation, restorable line or spot type (except pneumatic tube) type detectors shall be tested with a heat source per manufacturer's recommendations for response within one (1) minute. Precautions shall be taken to avoid damage to the non-restorable fixed-temperature element of any combination heat-of-rise/fixed temperature device. Fixed temperature, non-restorable spot type detectors: determine age of installed devices.
- E. Water flow devices for "Wet Pipe Systems": functional testing and inspections of water flow and pressure switches. (Static testing only, no water will flow through the system).

F. Supervisory devices- control valve switch: operate valve and verify signal receipt within the first two revolutions of the hand wheel or within one-fifth of the travel distance, or manufacturer's specifications. High or Low Pressure Switch: operate switch and verify that signal is obtained where the required pressure is increased or decreased 10psi from the required pressure level.

5. Alarm Notification Devices-

- A. Audible Measure sound pressure levels with sound level meter meeting ANSI S-1.4a, Sound Level Meters, Type 2 requirements. Measure and record levels throughout protected area.
- B. Speakers Measure sound pressure levels with sound level meter meeting ANSI S-1.4a, *Sound Level Meters*, Type 2 requirements. Measure and record levels throughout protected area. Verify voice clarity.
- C. Visible Test in accordance with manufacturer's instructions. Verify device locations are per approved layout and confirm that no floor plan changes affect the approved layout.
- 6. Secondary (Standby) Power Supply- Awarded Bidder shall disconnect all primary (main) power supplies and verify that required trouble indication for loss of primary power occurs. Measure or verify system's standby and alarm current demand and using manufacturer's data, verify whether batteries are adequate to meet standby and alarm requirements. Operate general alarm systems for a minimum of five (5) minutes and emergency voice communication systems for a minimum of fifteen (15) minutes. Reconnect primary (main) power supply at end of test.

7. Batteries, General Tests-

- A. Inspect batteries for corrosion or leakage. Check and ensure tightness of connections. If necessary, clean and coat the battery terminals or connections. Visually inspect electrolyte level in lead acid batteries.
- B. Batteries shall be replaced and disposed of at no additional charge to the District in accordance with the manufacturer's recommendations.
- C. With the battery charger disconnected, load test the batteries per the manufacturer's recommendations. The voltage level shall not fall below the levels specified. An artificial load equal to the full alarm load connected to the battery shall be permitted to be utilized in conducting this test.
- D. Specific Tests:
 - 1. Sealed Lead-Acid Types:
 - With the batteries fully charged and connected to the charger, verify the batteries are within the tolerance specified by the manufacturer.
 - Under load, the float voltage shall not fall below 2.05 volts per cell.
- 8. **Interfaced Equipment** Interfaced equipment connections shall be tested by operating or simulating the equipment being supervised. Signals required to be transmitted shall be verified at the control panel. Test frequency for the interfaced equipment shall be the same as the frequency required by the applicable NFPA standard(s) for the equipment being supervised.

9. Special Procedures-

- A. Alarm Verification: verify time delay and alarm response for smoke detector circuits identified as having alarm verification.
- B. Addressable Systems:
 - 1. Verify communication between sending and receiving units under both normal and standby power.

- 2. Verify communication between sending and receiving units under open and short-circuit trouble conditions.
- 3. Verify communication between sending and receiving units.
- 4. Verify communication between sending and receiving units in all directions when multiple communication pathways are provided.
- 5. When redundant central control equipment is provided, verify switchover and all required functions and operations of secondary control equipment.
- 6. Verify all system functions and features in accordance with manufacturer's instructions.
- 7. Clean Dust Detectors on an Annual basis to avoid false alarms.

10. Any device found to be defective or in need of an upgrade due to age shall be immediately reported to the District Representative in writing.

2.7 TESTING FREQUENCY

Testing shall be performed in accordance with the schedules in NFPA 72, Table 10.4.3

The successful Bidder shall test the system, sub-systems, and connected devices in accordance with NFPA 72 chapter 10 Table 10.4.2.2 and adhere to School Board supplied schedules.

2.8 REMOTE MONITORING

- 1. The awarded Bidder shall provide remote monitoring of the fire alarm systems installed throughout the District, as required by Florida Statutes and NFPA.
- 2. The District currently has twenty-six (26) monitored fire alarm systems, as additional fire alarm systems come on line they will be added to this contract.
- 3. The awarded Bidder shall provide a single invoice to the District on a monthly basis for all monitoring accounts.
- 4. Internal Control panel communicators shall be used if available.
 - A. Awarded Bidder shall supply pricing to program internal communicators for nonmonitored systems.
 - B. If the control panel has no internal communication capabilities, the awarded Bidder shall submit a written quote to install a Silent Knight, non-proprietary communicator (or equal). Price shall include all equipment, labor, permitting fees and programming.

2.9 RESPONSE TIME

"Trouble" conditions shall be reported to the District Representative within four (4) hours after receipt of notification by the awarded Bidder. All maintenance service shall be completed within twenty-four (24) hours after receipt of the notification by the awarded Bidder. The District's representative shall be notified immediately of any repairs requiring longer completion time.

- Emergency response, referring to "alarm" conditions, shall be provided IMMEDIATELY after notification by the District's representative via radio or phone call, 24 hours a day, 7 days a week, 365 days a year.
- IMMEDIATE response shall be provided during normal business hours for "Alarm" conditions. If "Alarm" conditions occur after hours, emergency response shall be on an as "As Needed Basis" and shall be billed per project.

2.10 RETROFIT DESIGN, INSTALLATION, EMERGENCY SERVICE, & MAINTENANCE The following are the minimum requirements for Retrofit Design, Installation, Emergency Service & Maintenance. The services shall include, but not be limited to:

- Retrofit Design
- New Fire Alarm Installations
- Fire Alarm Installation for Classroom Additions
- Fire Alarm Installation for New Portable & Relocations
- To upgrade existing Fire Alarm Systems to current standards
- Interface Fire Alarm Systems with other Alarm Systems
- Keep older systems operational during the retrofit process
- Training
- Repairs
- 24/7 Emergency Service and
- Maintenance

2.11 DESIGN AND INTEGRATION

The services shall include project management of system development that the District considers important. The services include, but are not limited to the following:

- System Design
- Management of systems integration
- Programming, Orientation and Training
- Modernization of legacy systems
- Development and integration with security systems, and critical infrastructures.

2.12 STANDARDIZATION OF DISTRICT COMPONENTS

The District has standardized on Silent Knight (Fahrenhyt) Fire Alarm Panel/Control Equipment **ONLY.** All individual devices (smoke detectors, horns, strobes, etc) must be Silent Knight compatible. Bidder(s) must include certifications from the Manufacturers represented and authorized to be a Service provider. In addition, Respondent must indicate if it is an authorized Silent Knight Engineered Systems Distributor (ESD). There are twenty-one (21) sites that currently have Silent Knight Fire Alarm Systems.

2.13 CODES AND SCHOOL DISTRICT STANDARDS

All installations must meet state and local codes including the National Electric Code (NEC), National Fire Protection Agency (NFPA 70), (NFPA 72) along with State Regulations for Educational Facilities (SREF) and The School District of Osceola County Fire Alarm Standards, which requires that <u>all fire alarm system wiring shall be installed in conduit</u>, and any old system to be retrofit or upgraded must be maintained and operational until the new system is ready to be activated (the school/department must have an operational system at all times).

2.14 EMERGENCY SERVICE, MAINTENANCE, & SYSTEM UPGRADES

The District reserves the right to utilize the awarded Bidder to provide any and all necessary labor for the upgrade, repair, and maintenance of all Fire Alarm Systems, including damages which occur due to acts of nature or vandalism. The District shall order services on an as needed basis. As new projects/installations/upgrades are required, the District's Facilities and Maintenance Department will request a proposal. The proposal shall list the deliverables, to include but not be limited to; scope of work, labor and material costs, payment schedules, and start and completion dates for the specific project. This type of project will be considered a Fixed Price Project. Upon receipt and approval of the proposal, the District will issue a Purchase Order and Notice to Proceed for the proposed services.

The pricing for a Fixed Price Project will be based on:

- 1. Discount % Off the Manufacturer's Suggested Retail Price (MSRP) Published Price Sheet for all equipment,
- 2. Cost Plus % markup for all miscellaneous installation materials,

3. Labor installation costs using the hourly rates included in your response to this solicitation and incorporated in the final contract document.

The awarded Bidder shall provide a firm discount % off MSRP published price list for all equipment covered under the scope of this Invitation To Bid. Discounted Prices must include all shipping & handling charges. The published MSRP may be updated annually. The annually updated MSRP must be provided to the Purchasing Representative and the Maintenance Department.

The cost plus % markup for all miscellaneous material shall include, but not be limited to: conduit, wire, fiber, connectors, fittings, boxes, etc. The cost plus % must include any overhead, administrative fees, shipping & handling. Contractors shall make their invoices to suppliers available to the District when requested.

The Contractor will maintain an adequate inventory of any and all necessary peripheral devices, fire alarm control components, and related materials required to ensure minimal system down time at no additional charge.

Fire Alarm System Control Components are defined as follows:

- 2. Fire Alarm Annunciator Panels
- 3. Fire Alarm Transponder Panels
- 4. Status Command Centers
- 5. Video Display Terminals
- 6. Notification Appliance Circuit and Signal Expander Panels

2.15 WET AND DRY PORTABLE INSTALLATIONS

The District reserves the right to utilize the awarded Bidder to provide Fire Alarm System installations for wet and dry portables. Installation for the wet and dry portables must include; devices and wiring in raceways from junction box(s) (which may be located near an adjacent portable) to the new portable. The District shall order services on an "as-needed" basis. To be included in the submittal, the Bidder must provide a total turn-key price for the following types of installations. A detailed proposal for all materials and labor required to complete the project must be provided. This pricing must be held for the term of the contract.

2.16 WORK ORDER REQUIREMENTS

The following items are REQUIRED to be included in every Work Order issued by the District. All parties to a transaction are responsible for ensuring compliance with this section:

- 1. Every work order must name the District's Representative, who shall be the main point of contact for all issues related to the Services performed under that work order. The District Representative is the only person authorized to make or approve any changes in the requirements of a work order. In the event the awarded Bidder makes any changes at the direction of any person other than the assigned District Representative, the changes will be considered to have been without authority and no adjustment will be made in the work order price to cover any increase in costs occurred as a result thereof. The District Representative is a single point of contact for the awarded Bidder, and has the authority to obtain decisions on behalf of the District. The District's Representative will be responsible for the performance of the following functions, some of which may be delegated to other District staff:
 - A. Provide a liaison between the District and the awarded Bidder,
 - B. Review, verify and approve invoices from the awarded Bidder,
 - C. Resolve any contractual problems,
 - D. Ensure the timely review by the District of all planning documents,
 - E. Report on project progress to District management,
 - F. Meet with the awarded Bidder to convey information about schedule, timing and content of upcoming deliverables, as well as raising problems and frustrations,
 - G. Meet with the awarded Bidder and inform District management on the awarded Bidder's difficulties and frustrations,
 - H. Facilitate resolution of problems,
 - I. Functions as the source of all materials sent to the awarded Bidder,
 - J. Receives all deliverables from the awarded Bidder,
 - K. Archives all deliverables received from the awarded Bidder, and
 - L. Review all "Change Orders" looking for communication issues during the problem's lifecycle and follow-up on unresolved issues regarding reproducibility, significance, etc.

2. Completion Dates for Fixed Price Projects, costs to the District for each deliverable and the completion date must be agreed upon in the work order. The completion date shall be based on the awarded Bidder's project plan and the District's needs. The awarded Bidder shall complete each project within the agreed cost and by the estimated completion date, unless the completion date is properly modified.

2.17 TRAINING REQUIREMENTS FOR RETROFITS AND SYSTEM UPGRADES

The awarded Bidder shall provide and appropriately schedule system operation training to select site-based administrative support staff at the completion of system retrofits and system upgrades. The District Representative(s) shall attend all site-based system operation training sessions. If a system manufacturer requires School District staff to be certified in order to maintain new systems, the system manufacturer(s) shall provide factory authorized training and testing for a minimum two (2) School District Maintenance Department personnel. All training required to certify School District Maintenance Department personnel, whether local or at the factory, shall be provided at no additional cost to the School District of Osceola County. Additional training requirements are as follows:

- 1. Schedule training with the District at least seven weeks in advance.
- 2. Provide three (3) copies of all program and data software upon completion of training. Issue a release form to the District for the use of the software.
- 3. Training shall be performed by a factory authorized trainer whose primary function is to train and certify technicians for the manufacturer. Training by any other personnel will not be acceptable. Length of training shall be determined by manufacturer's requirements and agreed upon by the District.
- 4. Provide at the end of the project, four (4) hours of on-site training for School District Maintenance Department personnel at the completion of each project to review sequence of operation, drawings, programming and panel operations.
- 5. Provide training for terminating, splicing and testing of fiber optic cable, as required or as requested by School District Maintenance Department personnel.

2.18 SOFTWARE DOCUMENTATION REQUIREMENTS

To the extent that any software is developed, modified, or otherwise procured under a Work Order, the awarded Bidder is responsible for providing appropriate documentation, based on commercially-accepted software documentation standards. The District may address specific software documentation needs or standards in the appropriate Work Order.

2.19 LICENSES AND PERMITS

It shall be the responsibility of the awarded Bidder to obtain, at no cost to the District, any and all licenses and permits required to complete this contractual service. The licenses and permits shall be readily available for review by the District's designated representative. Where new installation is required a no cost permit provided through the District's permitting office must be applied for by the awarded Bidder.

2.20 DELIVERY TERMS

A. DELIVERY TIME

Orders shall be placed as needed and delivery shall be completed within twenty-four (24) hours after order is placed for emergency parts and within five (5) days for non-emergency parts, to any SDOC location in Osceola County.

B. DELIVERY CHARGES

Bid price must include all delivery charges.

C. DELIVERY AND INSTALLATION CHARGES

Bid price must include all delivery and installation charges.

D. HOURS OF DELIVERY

Deliveries shall be made between the hours of 8:00 a.m. and 3:00 p.m. except on Saturdays, Sundays, or holidays when all school buildings and the Warehouse are closed.

2.21 DAMAGED ITEMS

In the event an item or items is received and it is later determined there is concealed damage when the item or items is unpacked, the item or items must be replaced by the awarded bidder at no cost to the School Board.

2.22 METHOD OF ORDERING

Items shall be order via individual purchase orders on an "as needed" basis for the term of the contract. Invoices must be submitted against each individual purchase order.

2.23 ORDERS

Schools, departments and centers of the School District of Osceola County will issue purchase orders directly to the successful bidder(s) for Fire Alarm System Inspections, Testing, Monitoring and Installation. The successful bidder(s) will be expected to honor these orders according to the discount terms and conditions listed in this bid. Each purchase order will be faxed or mailed to the awarded bidder. The order should be reviewed for correct prices, catalog numbers, extensions, etc.

2.24 EXEMPT FROM THIS BID

Purchases shall not include items available at lower prices on other School District bid awards or on Florida State Contracts. The School District reserves the right to bid separately any item if deemed to be in the best interest of the District.

2.25 SUBSTITUTES

Unapproved substitutes will not be allowed. If items are not available, the school or department noted on the purchase order must be contacted prior to shipment to determine if a substitute is acceptable.

2.26 NO DAMAGES FOR DELAY

Bidder is not entitled to any additional compensation or increase in the contract sum for direct, indirect, impact, or any other damages arising because of any hindrance or delays caused by the owner or any other cause whatsoever. Bidder's only remedy for delay, not caused or exacerbated by the Bidder, shall be an extension of time to complete the Bidder's scope of work. Any extension of time shall be granted at the sole discretion of the School Board, and if granted, shall be in the form of additional days added to the contract.

2.27 BARRICADES

The Bidder shall provide all barricades and take all necessary precautions to protect building and personnel. All work shall be complete in every respect and accomplished in a workmanlike manner and Bidder shall provide for removal of all debris from the School District's property.

2.28 PALLETIZE

Shipment(s) must be palletized. Pallets are available for exchange at the time of delivery, if required.

3.10 PAYMENT DISCOUNTS

A bid price submitted indicating a discount if an invoice is paid within a certain number of days from the date of the invoice can not be considered as a basis for the bid evaluation. All bid prices must be net and not contingent on terms.

3.11 DEFINITION OF RESPONSIVE AND RESPONSIBLE FOR THIS BID

Each bid submittal shall be evaluated for conformance as responsive and responsible using the following criteria:

- A. Proper submittal of ALL documentation as required by this bid. (Responsive)
- B. The greatest benefits to the School District as it pertains to: (Responsible)
 - 1. Total Cost
 - 2. Delivery
 - 3. Past Performance. In order to evaluate past performance, all bidders are required to submit documentation that provides:
 - a. A list of three references with the bid and;
 - b. A list of relevant projects completed within the last 3 years that are the same or similar to the magnitude of this ITB.
 - c. Demonstration of the provision of exceptional quality of service to the School District of Osceola County, Florida and/or other governmental entities for similar services/projects.
 - 4. All technical specifications associated with this bid.
 - 5. Financial Stability: Demonstrated ability, capacity and/or resources to acquire and maintain required staffing.
 - 6. Provide a list of employees that may be assigned to perform services under this contract including their names, license number, level of NICET certification and any additional certification that qualifies them to perform the required work.
 - 7. Provide a website address with a demo of the proposed web-based reporting system, or provide a sample on a CD/DV.
 - 8. Provide a description of the types and frequency of training that will be provided to the District (at no additional cost).
 - 9. Provide certifications from the Manufacturers represented and authorized to be a service provider for.

Bidders are reminded that award may not necessarily be made to the lowest bid. Rather, award will be made to the lowest responsive, responsible, bidder whose bid represents the best overall value to the School District when considering all evaluation factors.

3.12 OTHER AGENCIES

- A. All bidders awarded contracts from this Bid may, upon mutual agreement with the other agency, permit any school district/board, municipality or other governmental agency to participate in the contract under the same prices, terms and conditions, if agreed to by both parties.
- B. Further, it is understood that each school district/board or agency will issue its own purchase order to the awarded bidder(s).

3.13 ASSIGNMENT

The Bidder shall not sell, assign or transfer any of its rights, duties or obligations under the Contract, or under any purchase order issued pursuant to the Contract, without the prior written consent of the School Board. In the event of any assignment, the Bidder remains secondarily liable for the performance of the Contract, unless the School Board expressly waives such

secondary liability. The School Board may assign the Contract with prior written notice to Bidder of its intent to do so. For the purpose of this Contract, "assignment" means any voluntary, involuntary, direct or indirect assignment, sale, or other transfer by Bidder or its owner(s), of any interest in this Agreement, more than ten percent (10%) of the ownership interest in Bidder, or one of a series of transfers that in the aggregate constitute the transfer of more than ten percent (10%) of the ownership interest in Bidder. The term includes, without limitation: (1) transfer of ownership of capital stock or any partnership interest; (2) merger, consolidation, or issuance of additional securities representing more than ten percent (10%) of the ownership interest in Bidder; (3) sale of common stock of Bidder pursuant to a private placement or registered public offering, which transfers more than ten percent (10%) of the ownership interest in Bidder; (4) transfer of any interest in Bidder in a divorce proceeding or otherwise by operation of law; or (5) transfer of more than ten percent (10%) of the ownership interest in Bidder; (4) eath of an owner, by will, declaration of or transfer in trust, or under the laws of intestate succession.

3.14 CONTRACT

- A. The contents of this Bid and all provisions of the successful bidder's Submittal Form shall be considered a contract and become legally binding. A separate contract document, other than the purchase order, will not be issued.
- B. The Director of Purchasing and Warehouse, Superintendent, and Board Chair are the sole Contracting Officers for the School Board, and only they or their designee are authorized to make changes to any contract.
- C. The School Board shall be responsible for only those orders placed by the schools/departments on an authorized signed Purchase Order. The School Board shall not be responsible for any order, change substitution or any other discrepancy on the Purchase Order. If there is any question about the authenticity of a Purchase Order or change order, the bidder should promptly contact the Purchasing Department.

3.15 DISCLOSURE OF BID CONTENT

- A. All material submitted becomes the property of the School Board and may be returned only at the School Board's option. The School Board has the right to use any or all ideas presented in any reply to this Bid. Selection or rejection of any Bid Submittal does not affect this right.
- B. The School Board is governed by the Public Record Law, Chapter 119, Florida Statutes (F.S.). Only trade secrets as defined in Section 812.081(1)(c), F.S. or financial statements required by the School Board as defined in 119.071(1)(c), F.S. (hereinafter "Confidential Materials"), may be exempt from disclosure. If a respondent submits Confidential Materials, the information **must be segregated**, accompanied by an executed Non-disclosure Agreement for Confidential Materials and each pertinent page must be clearly labeled "confidential" or "trade secret." The School Board will not disclose such Confidential Materials, subject to the conditions detailed within the Agreement, which is attached to this solicitation. When such segregated and labeled materials are received with an executed Agreement, the School Board shall execute the Agreement and send the respondent a "Receipt for Trade Secret Information."

RETURN THIS FORM *ONLY* IF CONFIDENTIAL MATERIALS ARE BEING INCLUDED IN THE SUBMITTAL. PLEASE READ THE SECTION IN THE BID DOCUMENT TO DETERMINE IF THIS APPLIES.

3.16 BIDDER'S RESPONSIBILITY

The bidder, by submitting a Bid represents that:

- A. The bidder has read and understands the Invitation To Bid in its entirety and that the Bid is made in accordance therewith, and;
- B. The bidder possesses the capabilities, resources, and personnel necessary to provide efficient and successful service to the School Board, and;
- C. Before submitting a Bid, each bidder shall make all investigations and examinations necessary to ascertain site and/or local conditions and requirements affecting the full performance of the contract and to verify any representations made by the School Board, upon which the bidder will rely. If the bidder receives an award because of its Bid Submittal, failure to have made such investigations and examinations will in no way relieve the bidder from its obligations to comply in every detail with all provisions and requirements of the contract, nor will a plea of ignorance of such conditions and requirements be accepted as a basis for any claim by the bidder for additional compensation or relief.
- D. The bidder will be held responsible for any and all discrepancies, errors, etc., in discounts or rebates which are discovered during the contract term or up to and including five (5) fiscal years following the School Board's annual audit.

3.17 PAYMENT TERMS

A. INVOICING

The successful bidder will be required to submit invoices and reference purchase order numbers on all requests for payment. All statements must reference valid SDOC purchase order numbers. Invoices shall be mailed directly to: Accounts Payable, School District of Osceola County, 817 Bill Beck Blvd., Kissimmee, Florida 34744-4495. A separate invoice must be received for each purchase order number. Payment for partial shipments shall not be made unless specified. Invoices, which do not reference valid SDOC, purchase order numbers or which are erroneous (incorrect contract prices, minimum order charges, etc.) shall be returned to the vendor for resolution of the discrepancies. It is the sole responsibility of the vendor to reconcile the purchase order and the vendor's invoice and to notify the purchasing representative of any discrepancies prior to billing. The school board will only pay the dollar amounts authorized on the purchase order.

- B. The School Board will remit full payment on all undisputed invoices within 45 (forty-five) days from receipt by the appropriate person(s) (to be designated at time of contract) of the invoice(s) or receipt of all products or services ordered.
- C. Pursuant to Chapter 218, Florida Statutes, the School Board will pay interest, not to exceed one percent (1%) per month, on all undisputed invoices not paid within 45 (forty-five) days after receipt of the entire order of the commodity or service, AND a properly completed invoice, whichever is later.
- D. The School Board has the capabilities of Electronic Fund Transfer (EFT). List any additional discounts for payment using Electronic Funds Transfer (EFT) and/or any additional discounts to be applied to such payments.
- E. By submitting a Bid (offer) to the School Board, the bidder expressly agrees that if awarded a contract, the School Board may withhold from any payment, monies owed by the bidder to the School Board for any legal obligation between the bidder and the School Board.

F. PARTIAL PAYMENT

Partial payments in the full amount of the value of items received and accepted may be requested by the submission of a properly executed invoice with support documents if required.

3.18 CERTIFICATES

The School Board reserves the right to require proof that the bidder is an established business and is abiding by the ordinances, regulations, and laws of their community, the county, and the State of Florida, such as but not limited to: Business Tax Receipts, Business Licenses, Florida Sales Tax Registration, Federal Employers Identification Number.

3.19 INSURANCE, LICENSES AND CERTIFICATES

The bidder agrees to provide and maintain at all times during the term of this agreement, without cost or expense to the School Board, policies of insurance insuring the bidder against any and all claims, demands or causes of action whatsoever, for injuries received or damage to property relating to the performance of duties, services and/or obligations of the bidder under the terms and provisions of this agreement. The bidder will provide the School Board with copies of current appropriate business licenses.

3.20 INSURANCE

The bidder shall secure and maintain, at its sole cost and expense during the contract term, the following insurance:

- Commercial General Liability in the amount of \$3 million aggregate / \$1 million per occurrence.
- Liability Auto, in the amount of \$100,000/300,000 / Any Auto
- Workers Compensation As required by Florida law.

Requirements for bidders that qualify for an exemption under the Florida Worker's Compensation law in Chapter 440 Florida Statutes are detailed below:

Incorporated or unincorporated firms with fewer than four employees shall be required to sign a Hold Harmless Agreement relieving the School Board of liability in the event they and/or their employees are injured while providing goods and/or services to the School Board.

Incorporated or unincorporated firms with four or more employees shall be required to provide a copy of their "Notice of Election to be Exempt", along with valid proof of coverage for non-exempt employees.

The Hold Harmless Agreement mentioned above is included as an attachment to this bid. Said Agreements shall be returned with the bid proposal as detailed in the Submittal Requirements.

The School Board reserves the right to request a copy of the complete insurance policy(ies) and any endorsements for the insurance referenced above. A certificate of insurance indicating that the bidder has coverage in accordance with the requirements herein set forth shall be furnished by the bidder to the School Board Representative prior to the execution of the contract and annually upon renewal thereafter. The Bidder shall either cover any subcontractors on its policy or require the subcontractors to obtain coverage to meet all requirements for insurance contained herein.

Bidder agrees that School Board will make no payments pursuant to the terms of the contract until all required proof or evidence of insurance has been provided to the School Board Representative. Bidder agrees that the insurer shall waive its rights of subrogation, if any, against the School Board on Commercial General Liability and Workers Compensation insurance coverage. The ACORD certificate of Liability Insurance, with endorsements shall be completed by the authorized Resident Agent and returned to the Purchasing Department. This certificate shall be dated and show:

- A. The name of the insured bidder, the specified job by name, name of the insurer, the number of the policy, its effective date and its termination date.
- B. Statement that the Insurer will mail notice to the School Board at least thirty (30) days prior to any material changes in provisions or cancellation of the policy.

C. School Board shall be named as an additional insured on Commercial General Liability Insurance.

Loss Deductible Clause: The School Board shall be exempt from, and in no way liable for, any sums of money that may represent a deductible in any insurance policy. The payment of such deductible shall be the sole responsibility of the bidder and/or sub-consultant providing such insurance.

3.21 SAFETY

The bidder shall take the necessary precautions and bear the sole responsibility for the safety of the methods employed in performing the work. The bidder shall at all times comply with the regulations set forth by federal, state, and local laws, rules, and regulations concerning "OSHA" and all applicable state labor laws, regulations, and standards. Bidder shall take all necessary precautions to ensure all materials provided do not include Asbestos. The bidder shall indemnify and hold harmless the School Board from and against all liabilities, suits, damages, costs, and expenses (including attorney's fees and court costs) which may be imposed on the School Board because of the bidder, sub-contractor, or supplier's failure to comply with the regulations.

3.22 DEVIATIONS

All Bid Submittals must clearly and with specific detail, note all deviations to the <u>exact</u> requirements imposed upon the bidder by the specifications. Such deviations must be stated upon the Bid Submittal Form; otherwise the School Board will consider the subject Bid Submittals as being made in strict compliance with said Specifications to bidders, the bidder being held therefore accountable and responsible. Bidders are hereby advised that School Board will only consider Bid Submittals that meet the exact requirements imposed by the specifications; except, however, said Bid Submittals may not be subject to such rejection where, **at the sole discretion of The School Board**, the stated deviation is considered to be equal or better than the imposed requirement and where said deviation does not destroy the competitive character of the Bid process by affecting the amount of the Bid Submittal such that an advantage or benefit is gained to the detriment of the other bidders.

3.23 WAIVER OF CLAIMS

Once this contract expires, or final payment has been requested and made, the awarded bidder shall have no more than thirty (30) calendar days to present or file any claims against the School Board concerning this contract. After that period, the School Board will consider the bidder to have waived any right to claims against the School Board concerning this agreement.

3.24 TERMINATION / CANCELLATION OF CONTRACT

The School Board reserves the right to cancel the contract without cause with a minimum thirty (30) days written notice.

Termination or cancellation of the contract will <u>not</u> relieve the bidder of any obligations for any deliverables entered into prior to the termination of the contract (i.e., reports, statements of accounts, etc., required and not received).

Termination or cancellation of the contract will <u>not</u> relieve the bidder of any obligations or liabilities resulting from any acts committed by the bidder prior to the termination of the contract.

The bidder may cancel the resulting contract with ninety (90) days **written** notice to the Director of Purchasing and Warehouse. Failure to provide proper notice may result in the bidder being barred from future business with the School District.

3.25 TERMINATION FOR DEFAULT

The School District's Contract Administrator shall notify, in writing, the bidder of deficiencies or default in the performance of its duties under the Contract. Three separate documented instances of deficiency or failure to perform in accordance with the specifications contained herein shall constitute cause for termination for default, unless specifically specified to the contrary elsewhere within this solicitation. It shall be at the School Board's discretion whether to exercise the right to terminate. Bidder shall not be found in default for events arising due to acts of God.

3.26 TERMINATION FOR SCHOOL BOARD'S CONVENIENCE

The performance of work under this contract may be terminated in accordance with this clause in whole, or from the time in part, whenever the School Board representative shall determine that such termination is in the best interest of the School Board. Any such termination shall be effected by the delivery to the bidder of a Notice of Termination specifying the extent to which performance of work under the contract is terminated, and the date upon which such termination becomes effective. Upon such termination for convenience, bidder shall be entitled to payment, in accordance with the payment provisions, for services rendered up to the termination date and the School Board shall have no other obligations to bidder. Bidder shall be obligated to continue performance of contract services, in accordance with this contract, until the termination date and shall have no further obligation to perform services after the termination date.

3.27 INCURRED EXPENSES

This ITB does not commit the School Board to award a contract, nor shall the School Board be responsible for any cost or expense which may be incurred by the bidder in preparing and submitting the Submittal called for in this ITB, or any cost or expense incurred by the bidder prior to the execution of a contract agreement.

3.28 MINIMUM SPECIFICATIONS

The specifications listed herein are the <u>minimum</u> required specifications for this ITB. They are not intended to limit competition nor specify any particular bidder, but to ensure that the School District receives quality products and services.

3.29 COMPLIANCE WITH LAWS AND REGULATIONS

The bidder shall be responsible to know and to apply all applicable federal and state laws, all local laws, ordinances, rules, regulations, and all orders and decrees of bodies or tribunals having jurisdiction or authority which in any manner affect the work, or which in any way affect the conduct of the work. Bidder shall always observe and comply with all such laws, ordinances, rules, regulations, orders, and decrees. The bidder shall protect and indemnify School Board and all its officers, agents, servants, or employees against any claim or liability arising from or based on the violation of any such law, ordinance, rule, regulation, order, or decree caused or committed by bidder, its representatives, sub-contractors, sub-consultants, professional associates, agents, servants, or employees. Additionally, bidder shall obtain and maintain at its own expense all licenses and permits to conduct business pursuant to this contract from the federal government, State of Florida, Osceola County, or municipalities when legally required, and maintain same in full force and effect during the term of the contract.

3.30 RECORDS & RIGHT TO AUDIT

The bidder shall maintain such financial records and other records as may be prescribed by the School Board or by applicable federal and state laws, rules, and regulations. The bidder shall

retain these records for a period of three (3) years after final payment, or until the School Board audits them, whichever event occurs first. These records shall be made available during the term of the contract and the subsequent three-year period for examination, transcription, and audit by the School Board, its designees, or other entities authorized by law.

3.31 CHANGES IN SCOPE OF WORK/SERVICE

- A. The School Board may order changes in the work/service consisting of additions, deletions, or other revisions within the general scope of the contract. No claims may be made by the bidder that the scope of the project or of the bidder's services has been changed, requiring changes to the amount of compensation to the bidder or other adjustments to the contract, unless such changes or adjustments have been made by written amendment to the contract signed by the School Board Chair and the bidder.
- B. If the bidder believes that any particular work/service is not within the scope of work/service of the contract, is a material change, or will otherwise require more compensation to the bidder, the bidder must immediately notify the School Board's Representative in writing of this belief. If the School Board's Representative believes that the particular work/service is within the scope of the contract as written, the bidder will be ordered to and shall continue with the work/service as changed and at the cost stated for the work/service within the scope. The bidder must assert its right to an adjustment under this clause within thirty (30) days from the date of receipt of the written order.
- C. The School Board reserves the right to negotiate with the awarded bidder(s) without completing the competitive bidding process for materials, products, and/or services similar in nature to those specified within this ITB for which requirements were not known when the ITB was released.

3.32 MODIFICATIONS DUE TO PUBLIC WELFARE OR CHANGE IN LAW

The School Board shall have the power to make changes in the contract as the result of changes in Florida law and/or ordinances of Osceola County to impose new rules and regulations on the bidder under the contract relative to the scope and methods of providing services as shall from time-to-time be necessary and desirable for the public welfare. The School Board shall give the bidder notice of any proposed change and an opportunity to be heard concerning those matters. The scope and method of providing services as referenced herein shall also be liberally construed to include, but is not limited to, the manner, procedures, operations and obligations, financial or otherwise, of the bidder. In the event any future change in Federal, State or County law or the ordinances of Osceola County materially alters the obligations of the bidder, or the benefits to the School Board, then the contract shall be amended consistent therewith. Should these amendments materially alter the obligations of the bidder, then the bidder or the School Board shall be entitled to an adjustment in the rates and charges established under the contract. Nothing contained in the contract shall require any party to perform any act or function contrary to The School Board and bidder agree to enter into good faith negotiations regarding law modifications to the contract, which may be required in order to implement changes in the interest of the public welfare or due to change in law. When such modifications are made to the contract, the School Board and the bidder shall negotiate in good faith, a reasonable and appropriate adjustment for any changes in services or other obligations required of the bidder directly and demonstrably due to any modification in the contract under this clause.

3.33 RIGHT TO REQUIRE PERFORMANCE

A. The failure of the School Board at any time to require performance by the bidder of any provision hereof shall in no way affect the right of the School Board thereafter to enforce same, nor shall waiver by the School Board of any breach of any provision hereof be taken or held to be a waiver of any succeeding breach of such provision or as a waiver of any provision itself.

B. In the event of failure of the bidder to deliver services in accordance with the contract terms and conditions, the School Board, after due written notice, may procure the services from other sources and hold the bidder responsible for any resulting additional purchase and administrative costs. This remedy shall be in addition to any other remedies that the School Board may have.

3.34 FORCE MAJEURE

The School Board and the bidder will exercise every reasonable effort to meet their respective obligations as outlined in this ITB and the ensuing contract, but shall not be liable for delays resulting from force majeure or other causes beyond their reasonable control, including, but not limited to, compliance with any government law or regulation, acts of God, acts or omissions of the other party, government acts or omissions, fires, strikes, national disasters, wars, riots, transportation problems and/or any other cause whatsoever beyond the reasonable control of the parties. Any such cause will extend the performance of the delayed obligation to the extent of the delay so incurred.

3.35 BIDDER'S PERSONNEL

During the performance of the contract, the bidder agrees to the following:

- A. The bidder shall not discriminate against any employee or applicant for employment because of race, religion, color, sex, age, handicap or national origin, except when such condition is a bona fide occupational qualification reasonably necessary for the normal operations of the bidder. The bidder agrees to post in conspicuous places, visible to employees and applicants for employment, notices setting forth the provisions of this nondiscrimination clause.
- B. The bidder, in all solicitations or advertisements for employees placed by or on behalf of the bidder, shall state that such bidder is an Equal Opportunity Employer.
- C. Notices, advertisements, and solicitations placed in accordance with federal law, rule, or regulation shall be deemed sufficient for the purpose of meeting the requirements of this section.
- D. The bidder shall include the provisions of the foregoing paragraphs A, B, and C, above, in every subcontract or purchase order so that the provisions will be binding upon each bidder.
- E. The bidder and any sub-contractor shall pay all employees working on this contract not less than minimum wage specified in the Fair Labor Standards Act (29 CFR 510-794) as amended.
- F. Any information concerning the School Board, its products, services, personnel, policies or any other aspect of its business learned by the bidder or personnel furnished by the bidder in the course of providing services pursuant to the Agreement, shall be held in confidence and shall not be disclosed by the bidder or any employee or agents of the bidder or personnel furnished by the bidder, without the prior written consent of the School Board.
- G. All employees assigned by the Bidder to the performance of work under this contract shall be physically able to do their assigned work. It shall be the Bidder's responsibility to insure that all employees meet the physical standards to perform the work assigned and are free from communicable diseases. This requirement also includes acceptable hygiene habits of Bidder's employees.
- H. The personnel employed by the Bidder shall be capable employees, age 18 years or above, qualified in this type of work.

- I. It is the Bidder's responsibility to ensure that all employees are legally allowed to work in the United States in accordance with Immigration Policies.
- J. The Bidder's employees shall be required to dress neatly, commensurate with the tasks being performed.
- K. All District facilities are smoke free. Smoking on District grounds is prohibited.
- L. It is the Bidders responsibility to see that every employee on the Bidder's work force is provided and wears an Identification Badge or company shirt/uniform in order to maintain security at the school's facility. It shall be Bidder's responsibility to inform the School District Representative(s) of all new employees promptly at time of employment.
- M. The Bidder shall require employees to be dressed in a uniform with the Firm's name clearly indicated.
- N. The Bidder shall prohibit their employees from disturbing papers on desks, opening desk drawers or cabinets, or using telephone or office equipment provided for official use.
- O. The Bidder shall require their employees to comply with the instructions pertaining to conduct and building regulations, issued by duly appointed officials, such as the building managers, guards, inspectors, etc.
- P. The School District's Representative(s) will determine how the Bidder will receive access to the facility.
- Q. If keys are provided and lost, the Bidder will be responsible for any and all costs associated with replacement keys and re-keying of the facility.
- R. When requested, the Bidder shall cooperate with any ongoing SCHOOL BOARD investigation involving economic loss or damage to SCHOOL BOARD buildings, or SCHOOL BOARD or personal property therein. The SCHOOL BOARD reserves the right to require any employee of the Bidder to submit to a polygraph test if the SCHOOL BOARD has a reasonable suspicion that the employee is or was involved in the incident or activity under investigation. The Bidder shall obtain a waiver from the employee authorizing the release to the SCHOOL BOARD of information acquired by the Bidder from the polygraph test. The SCHOOL BOARD, at its discretion, may require that the Bidder immediately remove the employee under investigation from working within SCHOOL BOARD buildings for the following reasons: 1) The employee's refusal to submit to a polygraph test in the above circumstances, or 2) an employee's refusal to sign the waiver referenced above or 3) an analysis of the polygraph test indicates that the employee is or was involved in the incident under investigation. If the test results show involvement on the part of the Bidder's employee, the Bidder will be obligated to cover the cost of the examination. If the test results indicate that the Bidder's employee was not involved in the incident, when the SCHOOL BOARD will pay for the cost of the examination.
- S. <u>CONTROLLED SUBSTANCE OR ALCOHOL ABUSE ON SCHOOL BOARD</u> <u>PROPERTY:</u> The successful Bidder(s) is hereby notified that the unlawful manufacture, distribution, dispensation, possession or use of a controlled substance or alcohol is prohibited on any school district property, or at any school board activities. Violations may subject the Bidder and/or the Bidder's employee(s) to prosecution, fines, imprisonment and/or cancellation of this or any other contract(s) that this Bidder presently holds. The Bidder(s) are required by this school board to take appropriate disciplinary action in such cases and/or require that the employee(s) satisfactory participation in a rehabilitation program.

- T. Any Bidder's employee convicted of violating a criminal drug statute in the workplace must report the conviction to the employer within five (5) workdays. Bidders (Employers) are required to report such convictions to the school board within ten (10) workdays of receiving this information.
- U. The School District of Osceola County, Florida, is committed to the education and safety of its students and employees. To that end, any bidder awarded a contract will be required to assure that the personnel assigned to the project, do not possess criminal records that would violate the School Board's standards for employment as set forth by the Florida Department of Education. Each bidder must certify that the company and its employees are or will be in compliance with those standards for the project awarded.
- V. The Bidder shall strictly prohibit interaction between their employees and the student(s).
- W. Bidder's employees may not solicit, distribute or sell products while on School District property.
- X. Friends, visitors or family members of the Bidder's employees are not permitted in the work area.
- Y. The Bidder shall adhere to all of the District's security standards.

3.36 COMPLIANCE WITH THE JESSICA LUNSFORD ACT

Recent changes to the Florida Statutes require that all persons or entities entering into contracts with the School Boards/School Districts/Charter Schools who may have personnel who will be on school grounds when students may be present, or who will have contact with students shall comply with the level 2 screening requirements of the Statute and School District Standards. The required level 2 screening includes fingerprinting that must be conducted by the District. Any individual who fails to meet the screening requirements shall not be allowed on school grounds. Failure to comply with the screening requirements will be considered a material default of this contract/agreement.

3.37 CLAIM NOTICE

The bidder shall immediately report in writing to the School Board's designated representative or agent any incident that might reasonably be expected to result in any claim under any of the coverage mentioned herein. The bidder agrees to cooperate with the School Board in promptly releasing reasonable information periodically as to the disposition of any claims, including a resume' of claims experience relating to all bidder operations at the School Board project site.

3.38 BANKRUPTCY / INSOLVENCY

At the time of bid submittal, vendor/firm shall not be in the process of or engaged in any type of proceedings in insolvency or bankruptcy, either voluntary or involuntary, or receivership proceedings. If the vendor/firm is awarded a contract for six (6) months or longer, and files for bankruptcy, insolvency or receivership, the District may, at its option, terminate and cancel said contract, in which event all rights hereunder shall immediately cease and terminate.

3.39 CONTRACT/BIDDER RELATIONSHIP

The School Board reserves the right to award one or more contracts to provide the required services as deemed to be in the best interest of the School Board.

Any awarded bidder shall provide the services required herein strictly under a contractual relationship with the School Board and is not, nor shall be, construed to be an agent or employee of the School Board. As an independent bidder the awarded bidder shall pay any and all applicable taxes required by law; shall comply with all pertinent Federal, State, and local statutes including, but not limited to, the Fair Labor Standards Act, The Americans with Disabilities Act,

the Federal Civil Rights Act, and any and all relevant employment laws. The bidder shall be responsible for all income tax, FICA, and any other withholdings from its employees' or subbidder's wages or salaries. Benefits for same shall be the responsibility of the bidder including, but not limited to, health and life insurance, mandatory Social Security, retirement, liability/risk coverage, and workers' and unemployment compensation.

The independent bidder shall hire, compensate, supervise, and terminate members of its work force; shall direct and control the manner in which work is performed including conditions under which individuals will be assigned duties, how individuals will report, and the hours individuals will perform.

The independent bidder shall not be provided special space, facilities, or equipment by the School Board to perform any of the duties required by the contract nor shall the School Board pay for any business, travel, or training expenses or any other contract performance expenses not specifically set forth in the specifications.

The independent bidder shall not be exclusively bound to the School Board and may provide professional services to other private and public entities as long as it is not in direct conflict and does not provide a conflict of interest with the services to be performed for the School Board.

3.40 NEW MATERIAL

Unless otherwise provided for in this specification, the bidder represents and warrants that the goods, materials, supplies, or components offered to the School District under this Bid solicitation are new, not used or reconditioned, and are not of such age or so deteriorated as to impair their usefulness or safety and that the goods, materials, supplies, or components offered are current production models of the respective manufacturer. If the bidder believes that furnishing used or reconditioned goods, materials, supplies, or components will be in the School Board's interest, the bidder shall so notify the School District Buyer in writing no later than ten (10) working days prior to the date set for opening of Bids. The notice shall include the reasons for the request and any benefits that may accrue to the School District if the Buyer authorizes the Bidding of used or reconditioned goods, materials, supplies, or components.

3.41 DAMAGES

Due to the nature of the services to be provided and the potential impact to the School District for loss of *Fire Alarm Systems*, the bidder cannot disclaim consequential or inconsequential damages related to the performance of this contract. The bidder shall be responsible and accountable for any and all damages, directly or indirectly, caused by the actions or inaction of its employees, staff, or sub-consultants. There are no limitations to this liability.

3.42 CONFLICT OF INTEREST FORM

All bidders shall complete and have notarized the attached disclosure form of any potential conflict of interest that the bidder may have due to ownership, other clients, contracts, or interest associated with this project.

3.43 LITIGATION

Bidders shall submit details of all litigation, arbitration or other claims, whether pending or resolved in the last five years, with the exception of immaterial claims which are defined herein as claims with a possible value of less than \$25,000.00 or which have been resolved for less than \$25,000.00. Notwithstanding the foregoing, all litigation, arbitration or other claims, of any amount, asserted by or against a state, city, county, town, school district, political subdivision of a state, special district or any other governmental entity shall be disclosed. Please indicate for each cease the year, name of parties, cause of litigation, matter in dispute, disputed amount, and whether the award was for or against the Bidder.

3.44 **RESOLUTION OF BID PROTESTS**

The School Board Rule 7.70.V shall be followed as outlined below for the resolution of any bid protests:

- A. The School Board shall follow the procedure specified in Florida Statutes, Section 120.57(3) and as the same may be amended from time to time for the resolution of bid protests.
- B. The Purchasing Department shall provide notice of a decision or intended decision concerning a solicitation, contract award, or exceptional purchase by electronic posting.

The notice shall contain the following statement:

Failure to file a protest within the time prescribed in Section 120.57(3), Florida Statutes, or failure to post the bond or other security required by law within the time allowed for filing a bond shall constitute a waiver of proceedings under Chapter 120, Florida Statutes.

C. Any person who is adversely affected by the intended award of a solicitation or contract by the School Board or the recommendation of the Director of Purchasing or other responsible employee of the School Board shall file with the Director of Purchasing as agent for the School Board a notice of protest in writing within 72 hours after the electronic posting of the award or intended decision, and shall file a formal written protest within ten (10) days after the date he or she has filed the notice of protest. With respect to a protest of the specifications contained in a solicitation, the notice of protest shall be filed in writing within 72 hours after the electronic posting of the solicitation, and the formal written protest shall be filed within ten (10) days after the date the notice of protest is filed. All formal written protests must be filed with a bond payable to the School District equal to 1% of the estimated contract amount (Florida Statute 287.042(2)(c)). Failure to file a notice of protest or failure to file a formal written protest and bond shall constitute a waiver of proceedings under Chapter 120, Florida Statutes. The School Board may, in its discretion, waive any procedural irregularity or defect in procedures so long as any opposing party is not materially prejudiced by such waiver. Saturdays, Sundays, and state holidays shall be excluded in the computation of the 72-hour time periods provided by this paragraph. The notice of protest and formal written protest shall be filed in the Purchasing Department between the hours of 8:00 a.m. and 4:30 p.m. upon any day the office is open for business.

The provisions specified herein constitute the exclusive remedy for any adversely affected party with respect to a bid protest. The formal written protest shall state with particularity the facts and law upon which the protest is based.

D. Upon receipt of the formal written protest which has been timely filed, the Purchasing Director shall stop the bid solicitation process or the contract award process until the subject of the protest is resolved by final agency action, unless the School Board, by duly enacted resolution sets forth in writing the particular facts and circumstances which require the continuance of the bid solicitation process or the contract award process without delay in order to avoid an immediate and serious danger to the public health, safety or welfare.

The School Board finds that a substantial interest in the public welfare is the timely award of contracts when required as a condition of receiving grants or funds from outside sources which will be in addition to the regular school budget.

- E. The Purchasing Director shall schedule a meeting to provide an opportunity to resolve the protest by mutual agreement between the parties within seven (7) days, excluding Saturdays, Sundays, and state holidays, after receipt of a formal written protest and bond.
- F. If the Purchasing Director cannot resolve the protest by mutual agreement within the seven (7) day period referred to in Paragraph E in this Section, the School Board shall conduct an informal administrative hearing, under Section 120.57(2), Florida Statutes, acting as the agency head, where there are no disputed issues of material fact. The informal hearing shall be held with notice of no less than 72 hours, excluding Saturdays, Sundays, and legal holidays within thirty (30) days of receipt of the formal written protest and bond, unless the parties, with the consent of the School Board, agree to extend the time for the hearing. The School Board shall have the right to schedule the hearing subject to these provisions.

3.45 DEFINITIONS

As used in this Bid, the following terms shall have the meanings set forth below:

<u>Bidder</u>: That person or entity, including employees, servants, partners, principals, agents and assignees of the person or entity that has submitted a bid proposal for the purpose of obtaining business with the School District to provide the product and/or services set forth herein.

Contract Administrator: The School District's Director of Purchasing and Warehouse or designee shall serve as Contract Administrator. The Contract Administrator shall be responsible for addressing any concerns within the scope of the contract. Any changes to the resulting contract shall be done in writing and authorized by the Director of Purchasing and Warehouse and/or the School Board Chair.

<u>Contract</u>: The document resulting from this solicitation between the School District and the Bidder, including this bid, along with any written addenda and other written documents, which are expressly incorporated by reference.

<u>Contractor's Project Manager</u>: The Project Manager has responsibility for administering this contract for the successful Bidder(s) and will be designated prior to the issue of the resulting Price Agreement or Purchase Order.

Day: The word "day" means each calendar day or accumulation of calendar days.

Director: The Director is the Director of Purchasing and Warehouse for the School District.

Exceptions to Bid: An exception is defined as the Bidder's inability or unwillingness to meet a term, condition, specification, or requirement in the manner specified in the bid.

<u>Person or Persons</u>: An individual, firm, partnership, corporation, association, executor, administrator, trustee, or other legal entity, whether singular or plural, masculine or feminine, as the context may require.

<u>School Board</u>: The word School Board refers to the elected officials of the School Board of Osceola County, Florida.

<u>School Board's Project Manager(s)</u>: The Project Manager(s) have responsibility for the day-today administration of the resulting contract for the School District and will be designated prior to award of the resulting Purchase Order.

<u>School District:</u> The word School District refers to the entity, The School District of Osceola County, Florida.

NON-DISCLOSURE AGREEMENT

This Agreement is entered into as of the date of the last signature set forth below between the School District of Osceola County, a political subdivision of the State of Florida (the "District"), and the above named Respondent (hereinafter the "Respondent"). The School District of Osceola County and the Respondent are collectively referred to as the "Parties" and may be referred to individually as a Party.

RECITALS

WHEREAS, the Respondent possesses certain confidential trade secret materials that it wishes to disclose to the School District of Osceola County for the purpose of responding to a request for proposal or otherwise conducting business with the School District; and

WHEREAS, the School District desires to review such materials in order to evaluate the District's interest in negotiating and concluding an agreement for the purchase of certain products and services, or otherwise conducting business with the Respondent.

NOW THEREFORE, in consideration of the mutual promises and premises contained herein, the receipt and sufficiency of which are hereby acknowledged, the School District and the Respondent agree as follows:

1. <u>Confidential Materials</u>. The Respondent warrants and represents to the School District that the materials described in the attached <u>Exhibit A</u> (the "Confidential Materials") constitute trade secrets as defined by Section 812.081(1)(c), Florida Statutes, or financial statements required by the School District for projects as defined in 119.071(1)(c), Florida Statutes. Subject to the terms and conditions of this Agreement, the School District agrees not to disclose such Confidential Materials to third parties.

2. <u>Additional Materials</u>. During the course of the negotiations or the business relationship with the School District, the Respondent may disclose additional confidential or trade secret information to the District in which case the restrictions and obligations on the use and disclosure of the Confidential Materials imposed by this Agreement shall also apply to such additional information to the extent permitted by Florida law. Any such additional confidential or trade secret information shall be duly marked and stamped "confidential" or "trade secret" prior to delivery to the School District, and shall be subject to this Agreement and Section 812.081(2), Florida Statutes, only if written receipt is provided by the School District acknowledging receipt of such materials.

- 3. <u>Exclusions</u>. For purposes of this Agreement, the term "Confidential Materials" does not include the following:
 - (a) Information already known or independently developed by the School District;
 - (b) Information in the public domain through no wrongful act of the School District;
 - (c) Information received by the School District from a third party who was legally free to disclose it;
 - (d) Information disclosed by the Respondent to a third party without restriction on disclosure;
 - (e) Information disclosed by requirement of law or judicial order, including without limitation Chapter 119 Florida Statutes; or
 - (f) Information that is disclosed with the prior written consent of the Respondent, but only to the extent permitted by such consent.

4. <u>Non Disclosure by Respondent</u>. In the event that the School District discloses confidential or trade secret information to Respondent, the Respondent agrees to not disclose such information to any third party or copy such information or use it for any purpose not explicitly set forth herein without the School District's prior written consent. Further, upon conclusion of discussions or business transactions between the School District and the Respondent, or at any time upon request of the School District, Respondent agrees to return such information (including any copies) to the School District.

5. <u>Duty of Care</u>. Each Party agrees to treat the other Party's confidential or trade secret information with the same degree of care, but not less than reasonable care, as the receiving Party normally takes to preserve and protect its own similar confidential information and to inform its employees of the confidential nature of the disclosing Party's information and of the requirement of nondisclosure. In the event either Party has actual knowledge of a breach of the nondisclosure requirements set forth in this Agreement, the Party acquiring such knowledge shall promptly inform the other Party and assist that Party in curing the disclosure, where possible, and preventing future disclosures.

6. <u>Limitations of Florida Law</u>. Respondent understands and agrees that its assertion that any item is confidential or a trade secret does not, in and of itself, render such material exempt from the Florida Public Records Law, Chapter 119 of the Florida Statutes, and that the School District's ability to prevent disclosure of confidential and trade secret information may be subject to determination by a Florida court that such materials qualify for trade secret protection under Florida law. In the event a third party makes a public records request for the Confidential Materials or other materials deemed by Respondent to be confidential or a trade secret, the School District may submit the materials to the court for inspection in camera as set forth in Section 119.07(1)(e) Florida Statutes. Respondent further understands that the School District may be required to disclose such information if directed by a court of competent jurisdiction.

7. <u>Indemnification by Respondent</u>. In the event of any litigation instituted by a third party to compel the School District to disclose such materials, Respondent shall, at its sole cost and expense, provide assistance to the School District in defending the denial of the records request, and shall hold the School District harmless from any claim for statutory costs and attorneys fees arising from the School District's refusal to disclose such materials.

8. <u>No Additional Obligations</u>. This Agreement shall not be construed in any manner to be an obligation for either Party to enter into any subsequent contract or agreement.

9. <u>Sovereign Immunity</u>. Nothing in this Agreement shall be deemed as a waiver of immunity or limits of liability of the School District beyond any statutory limited waiver of immunity or limits of liability, which has been or which may be adopted by the Florida Legislature, regardless of the nature of any claim which may arise, including but not limited to a claim sounding in tort, equity or contract. In no event shall the School District be liable for any claim or claims for breach of contract, including without limitation the wrongful disclosure of confidential or trade secret information for an amount which exceeds, individually and collectively, the then current statutory limits of liability for tort claims. Nothing in this Agreement shall inure to the benefit of any third party for the purpose of allowing any claim against the School District, which would otherwise be barred under the Doctrine of Sovereign Immunity or by operation of law.

10. <u>Notice</u>. Whenever either Party desires to give notice unto the other, it must be given by written notice, sent by registered United States mail, with return receipt requested, addressed to the party for whom it is intended, at the place last specified, and the place for giving of notice in compliance with the provisions of this paragraph. For the present, the Respondent designates the address set forth above as its place for receiving notice, and the School District designates the following address for such notice:

This Agreement shall be governed by the laws of the State of Florida, and venue for any action arising out of or relating to the subject matter of this Agreement shall be exclusively in Osceola County, Florida, or the Federal District Court for the Middle District of Florida, Orlando Division.

12. Respondent and the School District hereby expressly waive any rights either may have to a trial by jury of any civil litigation related to this Agreement for any litigation limited solely to the parties of this Agreement.

EXHIBIT A

DESCRIPTION OF CONFIDENTIAL MATERIALS

Notification Regarding Public Entity Crime and Discriminatory Vendor List Requirements And Disqualification Provision

A. Pursuant to Florida Statutory requirements, potential Respondents are notified:

287.133(2)(a) A person or affiliate who has been placed on the convicted vendor list following a conviction for a public entity crime may not submit a bid, proposal, or reply on a contract to provide any goods or services to a public entity; may not submit a bid, proposal, or reply on a contract with a public entity for the construction or repair of a public building or public work; may not submit bids, proposals, or replies on leases of real property to a public entity; may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity; and may not transact business with any public entity in excess of the threshold amount provided in s. 287.017 for CATEGORY TWO for a period of 36 months following the date of being placed on the convicted vendor list.

287.133(2)(b) A public entity may not accept any bid, proposal, or reply from, award any contract to, or transact any business in excess of the threshold amount provided in s. 287.017 for CATEGORY TWO with any person or affiliate on the convicted vendor list for a period of 36 months following the date that person or affiliate was placed on the convicted vendor list unless that person or affiliate has been removed from the list pursuant to paragraph (3)(f). A public entity that was transacting business with a person at the time of the commission of a public entity crime resulting in that person being placed on the convicted vendor list may not accept any bid, proposal, or reply from, award any contract to, or transact any business with any other person who is under the same, or substantially the same, control as the person whose name appears on the convicted vendor list.

287.134(2)(a) An entity or affiliate who has been placed on the discriminatory vendor list may not submit a bid, proposal, or reply on a contract to provide any goods or services to a public entity; may not submit a bid, proposal, or reply on a contract with a public entity for the construction or repair of a public building or public work; may not submit bids, proposals, or replies on leases of real property to a public entity; may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity; and may not transact business with any public entity.

287.134(2)(b) A public entity may not accept any bid, proposals, or replies from, award any contract to, or transact any business with any entity or affiliate on the discriminatory vendor list for a period of 36 months following the date that entity or affiliate was placed on the discriminatory vendor list unless that entity or affiliate has been removed from the list pursuant to paragraph (3)(f). A public entity that was transacting business with an entity at the time of the discrimination resulting in that entity being placed on the discriminatory vendor list may not accept any bid, proposal, or reply from, award any contract to, or transact any business with any other entity who is under the same, or substantially the same, control as the entity whose name appears on the discriminatory vendor list so long as that entity's name appears on the discriminatory vendor list.

B. By submitting a proposal, the Respondent represents and warrants that the submission of its proposal does not violate Section 287.133, Florida Statutes (2005), nor Section 287.134, Florida Statutes (2005).
