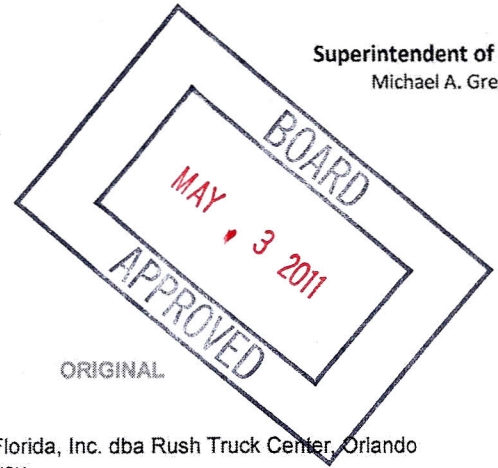

Dear Mr. Drakesmith and Mr. Weaver:




