The delivery of responses to the School District of Osceola County Purchasing Department prior to the specified date and time is solely and strictly the responsibility of the offeror. Any submittal received in the Purchasing Department after the specified date and time will not be considered.</p> <p>Responses shall be submitted on forms provided by the School Board. Additional information may be attached to the submittal. Facsimile submissions are NOT acceptable. No offer may be modified after acceptance. No offer may be withdrawn after opening for a period of sixty (60) days unless otherwise specified.</p> <p>2. - 10. TAXES:** The School District of Osceola County is exempt from Federal and State Tax for Tangible Personal Property. Florida State Exemption Certificate No. 85-8012500806C-9. Vendors or Contractors doing business with the School District of Osceola County shall not be exempted from paying sales tax to their suppliers for materials to fulfill contractual obligations with the District, nor shall any Vendor/Contractor be authorized to use the District's Tax Exemption Number in securing such materials.
- 11. DISCOUNTS:** All discounts except those for prompt payment shall be considered in determining the lowest net cost for evaluation purposes.
- 12. MEETS SPECIFICATIONS:** The offeror represents that all offers to this invitation shall meet or exceed the minimum requirements specified.
- 13. BRAND NAME OR EQUAL:** If items requested by this invitation have been identified in the specifications by a Brand Name "OR EQUAL" description, such identification is intended to be descriptive and not restrictive and is to indicate the quality and characteristics of products that will be acceptable. Offers proposing "equal" products will be considered for award if such products are clearly identified in the offer and are determined by the School Board to meet fully the salient characteristic requirements listed in the specifications.

- 14. SAMPLES:** When required, samples of products shall be furnished with response to the School Board at no charge. Samples may be tested and will not be returned to the offeror. The result of any and all testing shall be made available upon written request.
- 15. SILENCE OF SPECIFICATIONS:** The apparent silence of these specifications or any supplemental specifications as to details or the omission from same of any detailed description concerning any point, shall be regarded as meaning that only the best commercial practices are to prevail and that only materials of first quality and correct type, size, and design are to be used. All workmanship shall be first quality. All interpretations of specifications shall be made upon the basis of this statement.
- 16. GOVERNING LAWS AND VENUE:** All legal proceedings brought in connection with this Contract shall only be brought in a state or federal court located in the State of Florida. Venue in state court shall be in Osceola County, Florida. Venue in federal court shall be in the United States District Court, Middle District of Florida, Orlando Division. Each party hereby agrees to submit to the personal jurisdiction of these courts for any lawsuits filed there against such party arising under or in connection with this Contract. In the event that a legal proceeding is brought for the enforcement of any term of the contract, or any right arising there from, the parties expressly waive their respective rights to have such action tried by jury trial and hereby consent to the use of non-jury trial for the adjudication of such suit.
- All questions concerning the validity, operation, interpretation, construction and enforcement of any terms, covenants or conditions of this Contract shall in all respects be governed by and determined in accordance with the laws of the State of Florida without giving effect to the choice of law principles thereof and unless otherwise preempted by federal law.
- 17. ASSIGNMENT:** Any agreement to purchase issued pursuant to this invitation and award thereof and the monies which may become due hereunder are not assignable except with the prior written approval of the School Board.
- 18. CONTENT OF INVITATION/RESPONSE:** The contents of this invitation, all terms, conditions, specifications, and requirements included herein and the accepted and awarded response thereto may be incorporated into an agreement to purchase and become legally binding. Any terms, conditions, specifications, and/or requirements specific to the item or service requested herein shall supersede the requirements of the "GENERAL CONDITIONS AND INSTRUCTIONS."
- 19. INDEMNIFICATION OF SCHOOL BOARD**
The respondent shall indemnify, hold harmless and defend the School Board, its officers, agents, and employees, from or on account of any claims, losses, expenses, injuries, damages, or liability resulting or arising solely from the respondent's performance or nonperformance of services pursuant to this contract, excluding any claims, losses, expenses, injuries, damage, or liability resulting or arising from the actions of School Board, its officers, agents, or employees. The indemnification shall obligate the respondent to defend, at its own expense or to provide for such defense, at School Board's option, any and all claims and suits brought against School Board that may result from the respondent's performance or nonperformance of services pursuant to the contract.
- 20. PATENTS, COPYRIGHT, AND ROYALTIES:** The supplier/provider, without exception, shall indemnify and save harmless the School Board, its officers, agents and employees from liability of any nature of kind, including cost and expenses for or on account of any copyrighted, registered, patented, or unpatented invention, process, or article manufactured or used in the provision of goods and/or services, including use by the School Board. If the supplier/provider uses any design, device, or materials covered by letters, patent, copyright, or registration, it is mutually agreed and understood without exception that the quoted price shall include all royalties or costs arising from the use of such design, device, or materials in any way involved.
- 21. TRAINING:** Unless otherwise specified suppliers/providers may be required at the convenience of and at no expense to the School Board to provide training to School Board personnel in the operation and maintenance of any item purchased as a result of this invitation.
- 22. ACCEPTANCE:** Products purchased as a result of this invitation may be tested for compliance with specifications. Items delivered not conforming to specifications may be rejected and returned at respondent's expense. Those items and items not delivered by the delivery date specified in accepted offer and/or purchase order may be purchased on the open market. Any increase in cost may be charged against the respondent.
- 23. SAFETY WARRANTY:** Any awarded supplier/provider including dealers, distributors, and/or manufacturers shall be responsible for having complied with all Federal, State, and local standards, regulations, and laws concerning the product or service specified, and the use thereof, applicable and effective on the date of manufacture or use or date in service including safety and environmental standards as apply to both private industry and governmental agencies.
- 24. WARRANTY:** The offeror agrees that, unless otherwise specified, the product and/or service furnished as a result of this invitation and award thereto shall be covered by the most favorable commercial warranty the offeror gives to any customer for comparable quantities of such products and/or services and that the right and remedies provided herein are in addition to and do not limit any rights afforded to the School Board by any other provision of the invitation/offer.
- 25. AWARD:** As the best interest of the School Board may require, the School Board reserves the right to make award(s) by individual item, group of items, all or none, or a combination thereof; on a geographical basis and/or on a district wide basis with one or more supplier(s) or provider(s); to reject any and all offers or waive any irregularity or technicality in offers received. Offerors are cautioned to make no assumptions unless their offer has been evaluated as being responsive. Any or all award(s) made as a result of this invitation shall conform to applicable School Board Rules, State Board Rules, and State of Florida Statutes.
- 26. VIOLATIONS:** Any violation of any of the stipulations, terms, and/or conditions listed and/or included herein may result in the respondent being removed from the School Board Bid list and the /respondent being disqualified from doing business with the School Board for a period of time to be determined on a case-by-case basis.

27. For purposes of this Invitation and evaluation of responses hereto the following shall apply: unit prices shall prevail over extended prices; written matter shall prevail over typed matter; numbers spelled in word form shall prevail over Arabic numerals (“one” over “1”). When not inconsistent with context words used in the present tense include the future, words in the plural number include the singular number, and words in the singular number include the plural number. The word “shall” is always mandatory and not merely directory.
28. **GENERAL INFORMATION ABOUT THE DISTRICT:** The District and its governing board were created pursuant to Section 4, Article IX of the Constitution of the State of Florida. The District is an independent taxing and reporting entity managed, controlled, operated, administered, and supervised by School District Officials in accordance with Chapters 1000-1013, Florida Statutes. The Board consists of five elected officials responsible for the adoption of policies, which govern the operation of the District public schools. The Superintendent of Schools is responsible for the administration and management of the schools and its departments within the applicable parameters of state laws, State Board of Education Rules, and School Board policies. The Superintendent is also specifically delegated the responsibility of maintaining a uniform system of records and accounts in the District by Section 1010.01, Florida Statutes as prescribed by the State Board of Education.
29. **UNIFORM COMMERCIAL CODE:** The Uniform Commercial Code (Florida Statutes, Chapter 672) shall prevail as the basis for contractual obligations between the awarded Contractor and the School District of Osceola County for any terms and conditions not specifically stated in this Invitation to bid.
30. **AVAILABILITY OF FUNDS:**
The obligations of the School District of Osceola County under this award are subject to the availability of funds lawfully appropriated for its purpose by the State of Florida and the School Board. All purchases are contingent upon available District funding.
31. **NO CONTACT:** Vendors, contractors, consultants, or their representatives shall not meet with, speak individually with, or otherwise communicate with School Board members, the Superintendent, or School District staff, other than the designated purchasing agent, and School Board members, the Superintendent, or School District staff, other than the designated purchasing agent, shall not meet with, speak individually with, or otherwise communicate with vendors, contractors, consultants, or their representatives, about potential contracts with the School Board once an Invitation to bid,

request for quote, invitation to bid, invitation to negotiate, or request for qualifications has been issued.

Any such communication shall disqualify the vendor, contractor, or consultant from responding to the subject Invitation to bid, request for quote, request for proposal, invitation to negotiate, or request for qualifications. (*School Board Rule 7.70.I.G*)

32. **DISTRICT DEMOGRAPHICS:** The District is coterminous with Osceola County. The annual budget for the District for 2009-2010 school year totals \$834,802,487, including an operating budget of \$419,985,284, and a capital budget of \$237,594,737. The District operates forty-three (43) schools, which include twenty-three (23) elementary schools, eight (8) middle schools, eight (8) high schools, and four (4) multi-level schools. The District is also responsible for nine (9) alternative education sites, and eight (8) charter schools. The total full-time K-12 enrollment of public school students as of November 2009 is 51,421.

33. **DEFINITIONS:**

RESPONDENT – The term “respondent” used herein refers to any dealer, manufacturer, representative, distributor, or business organization that will be or has been awarded a contract and/or purchase order pursuant to the terms and conditions of the invitation and accepted offer.

OFFEROR – The term “offeror” used herein refers to any dealer, manufacturer, representative, distributor, or business organization submitting an offer to the County in response to this invitation.

SCHOOL BOARD – The term “School Board” herein refers to the School Board of Osceola County, Florida, and its duly authorized representatives and any school, department, or unit within the School District.

USING AGENCY – The term “using agency” used herein refers to any school, department, committee, authority, or another unit in the School District using supplies or procuring contractual services as provided for in the Purchasing Department of the School District.

1.0 SCOPE

1.01 This Specification establishes the minimum requirements for this solicitation, listed and described in the body of these specifications, to be used as noted, by The School District of Osceola County (SDOC).

1.02 AWARD TERM

The School Board's goal is to promote partnership relationships within the policies and procedures of public procurement. Pursuant toward that end, the successful bidder(s) shall be awarded a contract for all phases of the Video Surveillance System Installations at the following schools:

1.03 PRODUCTS/SERVICES TO BE PROVIDED, AND APPLICABLE SPECIFICATIONS

1.03.1 Scope of Work:

- A.** This scope of work is for a selected primary video surveillance contractor to provide a comprehensive new construction / renovation installation quote for services requested including provision, installation, programming, labeling, testing and all adjustments for all video surveillance system components applicable to Phase One (1) of Three (3) at the Osceola High School Project, Phase One (1) of Two (2) at the St. Cloud High School Project and for the complete project installation at East lake Elementary School Project to the complete satisfaction of Osceola County School District Authorized Representatives.
- B.** All work accomplished shall be in complete compliance with all applicable sections and directives contained in the Osceola County School District Division 17 Technology Standards and Specifications (Latest Revision).with no exception.
- C.** The selected primary video surveillance contractor shall provide a fully operational and top quality system installed as specified in accordance with School District of Osceola County: Division 17- Voice, Video, Data and Security Specifications (Latest Revision).
- D.** Further, the selected primary video surveillance contractor shall provide a comprehensive new construction / renovation installation future quote at a date to be determined for provision, installation, programming, labeling, testing and all adjustments for all video surveillance system components applicable to future installation at Phase Two (2) and Phase Three (3) at the Osceola High School comprehensive new construction / renovation Project and Phase Two (2) at the St. Cloud High School comprehensive new construction / renovation Project.
- E.** Further, the selected primary video surveillance contractor shall provide a new construction / renovation installation future quote at a date to be determined to include other services requested for additional cameras and or parts as required at locations and

in support of any eventuality for these projects as not yet identified in keeping with the completion of these three specific projects.

- F. NOTE TO ALL PROSPECTIVE CONTRACTORS – THOROUGHLY READ YOUR SCOPE OF WORK:** This scope of work may contain redundant or repetitive information and excerpts from SDOC specifications used on past and present projects. However, from time to time new information and changes in the preference of products, inclusion of new specifications and the addition of new products and materials may be inserted and updated in this scope of work to improve SDOC systems installations. It is the responsibility of each contractor to thoroughly read each scope of work and all specifications and ensure any change that occurs is reflected and to modify your materials list to include changed added or updated information and products for SDOC projects. The selected primary video surveillance contractor is expected to provide a complete and comprehensive video surveillance installation inclusive of all parts, pieces, services, programming and installation to the total satisfaction of Osceola County School District. Errors in the omission, assumption or oversight on the part of the selected video surveillance contractor in the quote process shall not warrant the issuance of change requests and the contractor shall be required to deliver a fully functional and operational system regardless with no exception. There will be no change request issued regarding the expectations detailed in this scope of work.

1.03.2 Video Surveillance Systems Contractor qualification requirements:

- A.** The selected Video Surveillance Contractor shall provide to SDOC Media and Technology Services (MTS) Department written evidence from the Salient Company they are a manufacturer certified installer of Salient Video Surveillance Systems and authorized by the Salient Company to provide all applicable warranties. The selected Video Surveillance Contractor shall provide a minimum one (1) year unconditional parts and labor warranty for all installed video surveillance systems.
- B.** The selected Video Surveillance Contractor shall provide to SDOC MTS Department written evidence they are a licensed low voltage contractor Class EF or EG.
- C.** The selected Video Surveillance Contractor shall not sub-contract cabling installations to others. All portions of each and all installations shall be the sole responsibility of the primary Video Surveillance Contractor for the entire scope of every project.
- D.** In the event the selected the Video Surveillance Contractor shall be required to provide and install any Category Six cabling for all camera locations, cable support systems and UL approved penetration sleeving the selected Video Surveillance Contractor shall provide to SDOC MTS Department written evidence of current Category Six manufacturer authorization and certification to provide and install all applicable Category Six cabling and provide the manufacturers authorized minimum fifteen year warranty for one of only the following three network infrastructure solutions: PANDUIT, ORTRONICS or AMP/TYCO Solutions.
- E.** Where the selected the Video Surveillance Contractor shall provide, and install cabling, support systems and penetration sleeving the selected Video Surveillance Contractor shall provide to SDOC MTS Department evidence of a qualified BICSI RCDD currently certified and on staff for installation project management of Salient Video Surveillance Systems. The selected Video Surveillance Contractor shall not sub-contract out BICSI RCDD project management services to others. All portions of each and all installations shall be the sole responsibility of the primary Video Surveillance Contractor for the entire scope of every project.
- F.** Osceola County School District Division 17 Sections 17020 and 17070 detail and define the expectations of quality, specifics in manufactured components and installation practices for video surveillance system installations.

- G. The selected video surveillance contractor shall have sufficient technicians and facilities to be able to provide two hour on-site response time for all circumstances involving the video surveillance system. If unable to meet the two hour response time, please specify the best possible response time in the designated area on the price sheet. The contractor shall provide a toll free number for twenty-four hour on-call support service.
- H. It shall be understood by all contractors that installation and programming shall only be accomplished by technicians experienced to properly install the devices as designed.
- I. Video Surveillance Security Contractors shall have performed work of comparable scope at educational facilities within the last two years and submit proof of exemplary performance on demand as required at the request of School District Representatives and if required shall arrange site visits for review of installed systems.
- J. Video Surveillance Security Contractors shall have the ability to provide Auto CAD drawings of the system design and provide as-built drawings at project close out for owner retention in both electronic and paper format.
- K. The security contractor shall be responsible for full compliance with SDOC Standards and Specifications unless specific issues for each non-complying feature is identified by letter and are addressed prior to contract with SDOC ITSD regardless of approval of samples, cut sheets, shop drawings, and other matter submitted by the contractor.
- L. All equipment, components, cabling and hardware shall be new, of current SDOC specified manufacture and carry standard warranties. At least two complete shop repair manuals and parts lists must be furnished with each type of equipment at the time of project closeout and delivery.

- F. The selected Video Surveillance Contractor shall provide and install Certified Category Six Patch Cords "Blue in color only" for all camera connection locations.
- G. The selected Video Surveillance Contractor shall provide and install any project installation required multimode fiber optic Patch Cords for camera converter / server connection and or other locations.
- H. All aspects of all cameras installed to include the proper and SDOC approved installation of all pieces and parts for installation shall be the complete responsibility of and accomplished by the selected Video Surveillance Contractor. Locations / placement shall be determined by SDOC Media and Technology Services Department prior to date selected for installation.
- I. The selected Video Surveillance Contractor shall provide, install, label, program, test and adjust all applicable Salient product software and components at all points of installation.
- J. SDOC MTSD shall provide, install, program, test and adjust all applicable Video Surveillance System Servers and operational system software in preparation for installation of Salient System software.

1.03.4 Additional Installation notes for clarification:

- A. Site installation shall be coordinated through #1 - The Osceola County School District Construction Services Department Project Manager, #2 - The site project Construction General Contractor Project Manager and #3 - The Osceola County School District Media and Technology Services Department Technology Construction Project manager.
- B. The site project Construction General Contractor shall provide, install, label and , test all Category Six cables which shall be homerun installed from Category Six Patch Panel locations in the MDF and all applicable IDF locations to each interior and exterior camera location.
- C. It shall be the responsibility of the selected Video Surveillance Contractor to ensure the cable service slack and cable run in support provide by the general contractor are maintained in neat secure condition to SDOC satisfaction at installation completion at all interior and exterior camera cabling locations. Selected Video Surveillance Contractor shall secure all cable and other items with Velcro wrapping only. Use of cable ties or electrical tape, raw grid hangar, spare cable or other SDOC unauthorized means and methods are not acceptable.
- D. The site project Construction General Contractor shall provide and install labeled Category Six RJ45 modular connectors on the field end at all interior and exterior camera locations.
- E. The site project Construction General Contractor shall provide and install one (1) ½" EMT conduit sleeve from interior to all exterior locations at all buildings complete with bushing on interior building conduit end and attached to one (1) weather-proof duplex receptacle box on the exterior building end. The project General Contractor shall seal the exterior of the conduit on the inside and outside of each sleeve at both the interior and exterior locations after complete installation, testing and labeling of all cable.
- F. The site project Construction General Contractor shall include all drilling / coring from the exterior to interior at all designated locations (The site project Construction General Contractor shall repair and repaint to match any surface damaged at any location on the exterior of each building.
- G. It shall be the responsibility of the selected Video Surveillance Contractor to ensure repair and repainting to match any surface damaged at any location resultant from installation of

any camera supports and components provided to original condition to SDOC satisfaction at all interior and exterior camera cabling locations.

- H. The site project Construction General Contractor shall be responsible for cleanup of all debris resultant from construction process at all interior and exterior locations whether above or below ceiling tiles and covered walkways. The selected Video Surveillance Contractor shall be responsible for cleanup of all debris resultant from camera installation process at all interior and exterior locations whether above or below ceiling tiles and covered walkways including drilling dust and or debris, packaging and all forms of cable trimmings resultant from any on site corrective or other cable installation.
- I. It shall be the responsibility of the selected Video Surveillance Contractor with respect to all video surveillance cables installed or pre-installed and utilized to properly install or to ensure existing cables remain as properly installed and secured, supported, sleeved, and labeled throughout the installation on both ends. Any pre-existing cable installation issues shall be identified prior to installation or these issues will become the responsibility of the selected Video Surveillance Contractor for repair or restoration to SDOC satisfaction.

1.03.5 General Installation notes addressing other potential installation processes whether applicable to this project or not:

- A. Fiber Optic Backbone Cable Installations - Install tight-buffered "ONLY" MMFOC as applicable. **NOTE: Strain relief is to be braided and secured to SDOC satisfaction in all fiber tray locations. Strain relief shall be utilized to secure all MMFOC at all cable ends.**
- B. Grounding scenarios: new installations shall have a solid copper ground bus and supports as specified in the SDOC Technology Installation Guidelines. At a new MDF or IDF location install the copper ground bus in a location specified by SDOC Representative. Install the following to this copper ground bus – 1) Homerun in the shortest route possible, install, label and test one (1) #4 minimum stranded copper green jacketed ground wire from the ground bus to the electrical panel feeding the space. 2) Homerun in the shortest route possible, install, label and test one (1) #6 minimum stranded copper green jacketed ground wire from the ground bus to building steel. Install all ground connections that transition into the ceiling space each into their own sleeve and for EMT conduit sleeving ground one end of each sleeve with the same size conductor as is in the conduit. All CCTV and voice surge suppression require grounding connections. These grounding connections shall all be individual homerun connections from the applicable device to the copper ground bus. Other items such as free standing racks, ladder racks and wall mounted enclosures shall all be considered individual items and shall all be individual homerun connections to the ground bus. All homerun ground cabling shall be #6 minimum stranded copper green jacketed ground wire.
- C. Cable support is required throughout the installation for all cabling both interior and exterior in accordance with OCSD Division 17 specification guideline.
- D. UL approved Sleeving is required wherever wall or ceiling penetrations are required regardless of fire rating. However, for sleeving and penetrations through fire rated bulkheads the UL approved sleeving, caulking and other sealants utilized shall be appropriate to maintain the UL approved rating of the fire and or smoke rated walls. Seal all penetrations around the exterior and the opening of each sleeve. Properly support each sleeve with Kendorff and brackets or other **SDOC approved** devices.
- E. If required to install backboards for wall mount cabinets or MDF and or IDF wall fields all backboards shall be **Ready Spec** backboards light gray in color ¾" A/C grade virgin plywood with (2) two coats on all sides installed with manufacturer supplied fasteners and according to manufacturer's specifications. It is the responsibility of the contractor to install the appropriate project specific colors and amounts of **Ready Spec** backboard listed in

the Division 17 Technology Specifications under Appendix "C" for each system such as Fire Alarm equipment and others as identified.

- F. In the event of ceiling tile damage during any technology systems project installation it is the responsibility of the selected video surveillance contractor to obtain and replace the affected ceiling tile. Notify the Technology Construction Project Manager of the issue and they will attempt to make arrangements to obtain and provide a replacement tile for the systems contractor to install. If there are no tiles available or, if the tile is a special tile not readily supported it will remain the selected video surveillance contractor's sole responsibility to replace all tile damaged during their installation with a matching tile regardless of whether a replacement is provided for their installation or not. All locations where ceiling penetrations are made through ceiling tiles for all technology systems projects the penetration shall be cut, notched and neatly fit to seat around the sleeve or other penetration installed. In no instance will breaking or chipping of the tiles be an acceptable practice for providing access on technology systems installations from a space into a ceiling cavity. Further, in instances where cameras or other devices are contractor installed in a ceiling tile the camera or other device shall be installed with an appropriate manufacturer recommended tile bridge appropriately fastened to the adjacent ceiling grid. It shall be the responsibility of the contractor to install added support at any location where new camera plates and applicable devices are installed in adherence to manufacturer recommended installation guidelines.
- G. It is the responsibility of all SDOC contractors both technology systems and electrical to comply with all safety requirements and to provide and wear all applicable safety equipment according to site construction rules and regulations with no exception. Additionally to ensure the environment of the work site at both the interior and exterior locations is maintained in a clean, orderly and safe manner on a daily basis. No unsightly conditions shall exist more than on a same day basis. All ceiling tiles shall be closed on a daily basis. The contractor shall remove all materials and debris both interior and exterior from the site upon satisfactory final completion of the installation.
- H. Absolutely no unsafe condition such as open trenches, manholes or other hazards shall be left unattended at anytime during the work in progress and shall not remain open longer than the period of the day these hazards are being opened for work. Where possible all affected hazards shall be closed and or filled at close of business on the same day the work occurred. In the special circumstance where closing said trench or other hazard were not possible on the same day, it is the responsibility of the contractor to make the Technology Construction Project Manager aware of this issue with enough advance notice to permit proper notification for school administration. In all instances where this is necessary, it is the responsibility of the contractor to appropriately stake off, rope off and flag all effected hazardous areas with the appropriate caution or danger tape to the satisfaction of the Site Construction Superintendent, Construction Services Project manager and the Technology Construction Project Manager.
- I. The use of restroom facilities by contractors at any campus location is strictly prohibited. Use of these facilities unless authorized can result in dismissal as an approved contractor in the School District of Osceola County. Use only facilities within the confines of the construction site that the Construction Company and Site Superintendent deem permissible and will make available for utilization. It is not the responsibility of School District of Osceola County to provide restroom facilities for contractors. It is recommended that facilities be sought in the local area at off campus locations in the event none are made available on site.
- J. All aspects of this installation shall be properly installed, supported, tested and **labeled** with **typewritten labels** installed on all ends of all cabling at all connection / termination points. Consult the Technology Construction Project Manager for labeling schemes and specifics prior to labeling installation or you shall be subject to removal and replacement of

all labeling if not in accordance with SDOC labeling guidelines. All infrastructure cable labeling shall include labeling at each termination point, Building MDF and IDF identification numbers for all feeder and backbone cabling and FISH numbers on all feeder cabling with respect to portable installations (this is to include final destination location of specific cabling). No handwritten labeling will be accepted for final project completion. (See owner's representative for specific details relevant to each site-specific location) in accordance with the School District of Osceola County: Division 17- Voice, Video, Data and Security Specifications (Latest Revision). Consult SDOC Technology Installation Representatives for any questions prior to installation.

- K. System Labeling:** Cameras: all system cameras, housings, all cables (on both ends and all points of termination), power supplies, video adapters, and monitors shall be labeled with legible, permanent, typewritten labels with identification numbers corresponding to camera numbers indicated on the conformed drawings. Consult SDOC ITSD Technology Construction Project Manager in the event there is no numbering system for appropriate number plan which require prior SDOC ITSD approval. Failure to gain prior approval shall result in removal of the installed labeling and replacement with SDOC ITSD approved suitable selection at the sole expense of the installing contractor.
- L.** A permanent typewritten schedule of all camera numbers and their locations shall be laminated in clear plastic and fastened where directed by SDOC Representatives in each operator's station.
- M.** A campus map identifying each camera location shall be laminated and fastened where directed in each operator's station.
- N.** Contact the SDOC ITSD Technology Construction Project Manager for amplifying information and clarification where uncertain on how to proceed regarding labeling. This includes labeling specifics for any site specific device and to determine site specific cable labeling location requirements not clarified. Contact shall be made for label scheme approval prior to installation labeling. Failure to gain prior approval shall result in removal of the installed labeling and replacement with SDOC ITSD approved suitable selection at the sole expense of the installing contractor.
- O.** SDOC approved identification numbers shall be permanently labeled and installed on each device and all cable ends and points of termination. Labeling descriptions for all video surveillance system devices and cable shall be as follows:
- Exterior (C1) Cameras and cables shall be labeled - C1 – 1 through C1 - #? Whatever the number of Exterior (C1) Cameras there are on the conformed plans.
 - Interior (C2) Cameras and cables shall be labeled – C2 – 1 through C2 - #? Whatever the number of Interior (C2) Cameras there are on the conformed plans.
- P.** This scope of work outlines the installation requirements. In acceptance of this project the contractor agrees and shall provide all labor, equipment, and materials necessary to provide a complete, tested and fully functional system regardless of any omission by the owner.
- Q.** In acceptance of this contract the contractor agrees to commit to the installation deadline as established and to provide any and all manpower or material necessary to insure all installation requirements and the deadline set are met as specified.
- R.** The intent of this scope of work is to insure upon completion the delivery of a one hundred percent complete and functional, top quality installation ready for use. Omission of any essential detail from this scope regardless of the party at fault does not relieve the contractor of the obligation to furnish a one hundred per-cent complete, fully operational

and top quality system installed as specified in accordance with School District of Osceola County: Division 17- Voice, Video, Data and Security Specifications (Latest Revision).

1.03.6 Completion:

The system will be considered complete when all of the following requirements have been met:

- A. All devices are installed per the conformed plans and specifications.
- B. All dead end cables and unused ports are terminated and identified with typewritten labels on all ends.
- C. All equipment is installed to manufacturers' specifications.
- D. All cabling installed at each device, enclosure, cabinet and MDF and IDF location is terminated and identified with typewritten labels on all ends to SDOC satisfaction.
- E. Demolition of all dead end and obsolete or replaced pre-existing cabling and equipment has been accomplished by the security contractor.
- F. An as built plan indicating all devices and cabling with all changes from the "original design configuration to SDOC satisfaction has been submitted to the owner for retention.
- G. It shall be the responsibility of the security contractor to verify the condition of all ceiling tiles and the work spaces prior to installation. All broken or damaged ceiling tiles or other damages not previously documented and found by SDOC to be the fault of the security contractor at the end of each project shall be repaired and or replaced as applicable by the security contractor at no expense to SDOC prior to final payment authorization.
- H. It shall be the responsibility of the security contractor to repair any exposed surface which has been scratched or damaged, shall be restored to like-new condition. Upon completion of project all exterior surfaces of equipment shall be cleaned of fingerprints, paint splatters, and other foreign substances. All construction debris such as wire trimmings, mortar, and foreign debris shall be removed from equipment areas and any area directly affected during the installation or service of equipment.
- I. The security contractor shall provide a bound document complete with the as-built drawings, installed programming, component cut-sheets of the equipment installed and completed training information.

1.03.7 Acceptance Inspection:

SDOC ITSD Technology Construction Project Manager or Authorized Representative shall conduct both a substantial and final inspection of all video surveillance and other technology installations to ensure all installations are in compliance with all SDOC Standards and Specifications as well as those requirements specific to the installation of video surveillance systems. At substantial inspection all security contractors shall demonstrate the functionality and operation of the installed system in the following manner:

- A. Observe picture quality at all monitor locations and where software interfaces are installed. All cameras must be clear, focused and directed at the appropriate target.
- B. Inspection and observation of other tests deemed necessary to establish proper system operability.
- C. Verification that the above tests and measurements are documented in the operation and maintenance manuals as as-built conditions.

- D. Verification of formal instruction given to owner designated key personnel at a time selected by owner and that said instruction consists of no less than two (2) hours training delivered in two (2) separate sessions.
- E. Verification of training covering operation, programming, troubleshooting and maintenance.
- F. Verification in the form of formal written report, signed by the instructor and submitted to the owner detailing subjects covered, names of persons instructed, dates and amount of instruction each person has been received. This report shall be submitted within one week following the instruction.
- G. Upon completion of all issues identified as not complete to SDOC satisfaction at Substantial Inspection a Final inspection shall be conducted as applicable to verify all issues have been completed to SDOC satisfaction. When Final Inspection is complete to SDOC Satisfaction Final Payment for the project shall be authorized and a contractor evaluation sheet shall be completed by the SDOC ITSD Technology Construction Project Manager or Authorized Representative to evaluate the security contractor's performance. This evaluation sheet shall be submitted to the contractor for their information and retained in the project records by SDOC.

1.03.8 Warranty:

- A. All video surveillance system equipment and cabling shall be guaranteed in writing in the form of manufacturers certificate by the installing contractor to be free of defects in materials and workmanship for a period of one year from the date of final inspection completion for the installed system.
- B. Any system component showing evidence of failure, improper or incorrect operation during the warranty period shall be repaired or replaced by the installing contractor at no expense to SDOC as specified in the contract documentation.

1.03.9 Asbuilt Drawings:

General: A comprehensive video surveillance system as-built drawing shall be provided to SDOC for retention containing at a minimum the following information:

- A block diagram of the installed system indicating all cables, cable types, active and passive components.
- A block diagram of the building or campus sites indicating the camera layout of the system.
- If the site has as-built CAD drawings available the security contractor shall update the video surveillance system as-built to match the installed system as approved by SDOC ITSD Representatives.

1.04 NEW ITEMS AND/OR OPTIONS

New items and/or options may be included in this bid if they are standard items and/or options for this commodity. Items inadvertently left off the price sheet may be viewed as an option not known to exist at the time this bid was sent out, but are now available as an additional option. Awarded bidders wishing to provide additional options, may attach to their price sheet their list of options which are currently available. Since these products will be made to order on an as needed basis, each purchase could vary greatly since many will be site specific. As market and/or building code changes occur the awarded Bidders may contact the Purchasing Agent about additional options.

1.05 MODEL NUMBER CHANGES

During the term of this contract as items are updated with a newer/current model, the awarded bidder must notify the Purchasing Department with the new equipment specifications and price. If the Purchasing Department and the MTS Department approve the newer/current model, an amendment will be placed in the bid folder noting the newer/current model as the revised product model for the remainder of the contract term.

1.06 DAMAGED ITEMS

In the event an item or items is received and it is later determined there is concealed damage when the item or items is unpacked, the item or items must be replaced by the awarded bidder at no cost to the School Board.

1.07 QUANTITY

The estimated quantities that will be purchased during the first phases of the Video Surveillance System Installations are shown on the Bid Price Sheet. Please note that these are estimates only and in no way obligates the School Board to purchase these amounts. These estimates are intended as a guide in submitting your bid. The actual quantities purchased under this bid may be more or may be less.

1.08 ADDITIONAL QUANTITIES

The School District of Osceola County reserves the right to purchase any additional quantities of the bid item(s) from the successful bidder at this bid price for a period of one (1) year from the date of the award of the bid, provided the successful bidder is in agreement at time of order.

1.09 QUANTITY CHANGES

The School Board reserves the right to increase or decrease the total quantities necessary.

1.10 ORDERS

The School District of Osceola County will issue purchase orders directly to the successful bidder(s) for the purchase of *Video Surveillance System Installations*. The successful bidder(s) will be expected to honor these orders according to the discount terms and conditions listed in this bid. Each purchase order will be faxed or mailed to the awarded bidder. The order should be reviewed for correct prices, extensions, etc.

1.11 MINIMUM ORDER

Items shall be ordered as needed. There shall be no minimum amount to be ordered at one time.

1.12 EXEMPT FROM THIS BID

Purchases shall not include items available at lower prices on other School District bid awards or on Florida State Contracts. The School District reserves the right to bid separately any item if deemed to be in the best interest of the District.

1.13 SUBSTITUTES

Unapproved substitutes will not be allowed. If items are not available, the school or department noted on the purchase order must be contacted prior to shipment to determine if a substitute is acceptable.

1.14 STANDARDIZATION OF ITEMS

Some items have been standardized by the School District of Osceola County's MTS Department; All items indicated on the price sheet with the Manufacturer's name and part number are "ONLY", allowing no alternate submittals. Where there is no Manufacturer, model or part number indicated, just the description, please supply us with the Manufacturer name, model and part number you are bidding along with descriptive literature if required.

1.15 LIQUIDATED DAMAGES

In case of failure on the part of the Bidder to complete the work within the time(s) specified in the Contract, or within such additional time(s) as may be granted by formal action of the School

District of Osceola County or fails to prosecute the work, or any separable part thereof, with such diligence as will ensure its completion within the time(s) specified in the contract or any extensions thereof, the School District of Osceola County will suffer damage, the amount of which is difficult, if not impossible to ascertain. Therefore, the Bidder shall pay to the District, as liquidated damages, the sum of \$250.00 for each calendar day of delay that actual completion extends beyond the time limit specified until such reasonable time as may be required for final completion of the work. In no way shall costs for liquidated damages be construed as a penalty on the Bidder.

1.16 NO DAMAGES FOR DELAY

Bidder is not entitled to any additional compensation or increase in the contract sum for direct, indirect, impact, or any other damages arising because of any hindrance or delays caused by the owner or any other cause whatsoever. Bidders unable to meet this time line must submit with their bid, their best time frame for project completion. The time for project completion will be a factor in the bid evaluation.

1.18 BARRICADES

The Bidder shall provide all barricades and take all necessary precautions to protect building and personnel. All work shall be complete in every respect and accomplished in a workmanlike manner and Bidder shall provide for removal of all debris from the School District of Osceola County.

The School Board reserves the right to award the contract to the bidder(s) that the Board deems to offer the lowest responsive and responsible bid(s), as defined elsewhere in this solicitation. The Board is therefore not bound to accept a bid on the basis of lowest price. In addition, the Board has the sole discretion and reserves the right to cancel this Bid, to reject any and all bids, to waive any and all informalities and/or irregularities, or to re-advertise with either the identical or revised specifications, if it is deemed to be in the best interest of the Board to do so. The Board also reserves the right to make multiple awards based on experience and qualifications or to award only a portion of the items and/or services specified, if it is deemed to be in the Board's best interest.

2.09 DEFINITION OF RESPONSIVE AND RESPONSIBLE FOR THIS BID

Each bid submittal shall be evaluated for conformance as responsive and responsible using the following criteria:

- A. Proper submittal of ALL documentation as required by this bid. (Responsive)
- B. The greatest benefits to the School District as it pertains to: (Responsible)
 - 1. Total Cost.
 - 2. Delivery.
 - 3. Past Performance. In order to evaluate past performance, all bidders are required to submit:
 - a. A list of references with the bid and;
 - b. A list of relevant projects completed within the last 3 years that are the same or similar to the magnitude of this ITB.
 - 4. All technical specifications associated with this bid.
 - 5. Financial Stability: Demonstrated ability, capacity and/or resources to acquire and maintain required staffing.
 - 6. **Bidders are required to submit documentation that they are a manufacturer certified installer of Salient Video Surveillance Systems and authorized by the Salient Company to provide all applicable warranties.**
 - 7. **Bidders are required to submit documentation that they are a licensed low voltage contractor Class EF or EG.**

Bidders are reminded that award may not necessarily be made to the lowest bid. Rather, award will be made to the lowest responsive, responsible, bidder whose bid represents the best overall value to the School District when considering all evaluation factors.

2.10 OTHER AGENCIES

- A. All bidders awarded contracts from this Bid may, upon mutual agreement with the other agency, permit any school district/board, municipality or other governmental agency, to

include Public Charter Schools, to participate in the contract under the same prices, terms and conditions, if agreed to by both parties.

- B. Further, it is understood that each school district/board or agency will issue its own purchase order to the awarded bidder(s).

2.11 ASSIGNMENT

The Bidder shall not sell, assign or transfer any of its rights, duties or obligations under the Contract, or under any purchase order issued pursuant to the Contract, without the prior written consent of the School Board. In the event of any assignment, the Bidder remains secondarily liable for the performance of the Contract, unless the School Board expressly waives such secondary liability. The School Board may assign the Contract with prior written notice to Bidder of its intent to do so. For the purpose of this Contract, "assignment" means any voluntary, involuntary, direct or indirect assignment, sale, or other transfer by Bidder or its owner(s), of any interest in this Agreement, more than ten percent (10%) of the ownership interest in Bidder, or one of a series of transfers that in the aggregate constitute the transfer of more than ten percent (10%) of the ownership interest in Bidder. The term includes, without limitation: (1) transfer of ownership of capital stock or any partnership interest; (2) merger, consolidation, or issuance of additional securities representing more than ten percent (10%) of the ownership interest in Bidder; (3) sale of common stock of Bidder pursuant to a private placement or registered public offering, which transfers more than ten percent (10%) of the ownership interest in Bidder; (4) transfer of any interest in Bidder in a divorce proceeding or otherwise by operation of law; or (5) transfer of more than ten percent (10%) of the ownership interest in Bidder in the event of the death of an owner, by will, declaration of or transfer in trust, or under the laws of intestate succession.

2.12 CONTRACT

- A. The contents of this Bid and all provisions of the successful bidder's Submittal Form shall be considered a contract and become legally binding. A separate contract document, other than the purchase order, will not be issued.
- B. The Director of Purchasing and Warehouse, Superintendent, and Board Chair are the sole Contracting Officers for the School Board, and only they or their designee are authorized to make changes to any contract.
- C. The School Board shall be responsible for only those orders placed by the schools/departments on an authorized signed Purchase Order. The School Board shall not be responsible for any order, change substitution or any other discrepancy on the Purchase Order. If there is any question about the authenticity of a Purchase Order or change order, the bidder should promptly contact the Purchasing Department.

2.13 DISCLOSURE OF BID CONTENT

- A. All material submitted becomes the property of the School Board and may be returned only at the School Board's option. The School Board has the right to use any or all ideas presented in any reply to this Bid. Selection or rejection of any Bid Submittal does not affect this right.
- B. The School Board is governed by the Public Record Law, Chapter 119, Florida Statutes (F.S.). Only trade secrets as defined in Section 812.081(1)(c), F.S. or financial statements required by the School Board as defined in 119.071(1)(c), F.S. (hereinafter "Confidential Materials"), may be exempt from disclosure. If a respondent submits Confidential Materials, the information **must be segregated**, accompanied by an executed Non-disclosure Agreement for Confidential Materials and each pertinent page must be clearly labeled "confidential" or "trade secret." The School Board will not disclose such Confidential Materials, subject to the conditions detailed within the Agreement, which is attached to this solicitation. When such segregated and labeled

materials are received with an executed Agreement, the School Board shall execute the Agreement and send the respondent a "Receipt for Trade Secret Information."

RETURN THIS FORM ONLY IF CONFIDENTIAL MATERIALS ARE BEING INCLUDED IN THE SUBMITTAL. PLEASE READ THE SECTION IN THE BID DOCUMENT TO DETERMINE IF THIS APPLIES.

2.14 BIDDER'S RESPONSIBILITY

The bidder, by submitting a Bid represents that:

- A. The bidder has read and understands the Invitation To Bid in its entirety and that the Bid is made in accordance therewith, and;
- B. The bidder possesses the capabilities, resources, and personnel necessary to provide efficient and successful service to the School Board, and;
- C. Before submitting a Bid, each bidder shall make all investigations and examinations necessary to ascertain site and/or local conditions and requirements affecting the full performance of the contract and to verify any representations made by the School Board, upon which the bidder will rely. If the bidder receives an award because of its Bid Submittal, failure to have made such investigations and examinations will in no way relieve the bidder from its obligations to comply in every detail with all provisions and requirements of the contract, nor will a plea of ignorance of such conditions and requirements be accepted as a basis for any claim by the bidder for additional compensation or relief.
- D. The bidder will be held responsible for any and all discrepancies, errors, etc., in discounts or rebates which are discovered during the contract term or up to and including five (5) fiscal years following the School Board's annual audit.

2.15 PAYMENT TERMS

A. INVOICING

- A. The successful bidder will be required to submit invoices and reference purchase order numbers on all requests for payment. All statements must reference valid SDOC purchase order numbers. Invoices shall be mailed directly to: Accounts Payable, School District of Osceola County, 817 Bill Beck Blvd., Kissimmee, Florida 34744-4495. A separate invoice must be received for each purchase order number. Payment for partial shipments shall not be made unless specified. Invoices, which do not reference valid SDOC, purchase order numbers or which are erroneous (incorrect contract prices, minimum order charges, etc.) shall be returned to the vendor for resolution of the discrepancies. It is the sole responsibility of the vendor to reconcile the purchase order and the vendor's invoice and to notify the purchasing representative of any discrepancies prior to billing. The school board will only pay the dollar amounts authorized on the purchase order.
- B. The School Board will remit full payment on all undisputed invoices within 45 (forty-five) days from receipt by the appropriate person(s) (to be designated at time of contract) of the invoice(s) or receipt of all products or services ordered.
- C. Pursuant to Chapter 218, Florida Statutes, the School Board will pay interest, not to exceed one percent (1%) per month, on all undisputed invoices not paid within 45 (forty-five) days after receipt of the entire order of the commodity or service, AND a properly completed invoice, whichever is later.
- D. The School Board has the capabilities of Electronic Fund Transfer (EFT). List any additional discounts for payment using Electronic Funds Transfer (EFT) and/or any additional discounts to be applied to such payments.

E. ***By submitting a Bid (offer) to the School Board, the bidder expressly agrees that if awarded a contract, the School Board may withhold from any payment, monies owed by the bidder to the School Board for any legal obligation between the bidder and the School Board.***

F. **PARTIAL PAYMENT**

Partial payments in the full amount of the value of items received and accepted may be requested by the submission of a properly executed invoice with support documents if required.

G. **PAYMENT DISCOUNTS**

A bid price submitted indicating a discount if an invoice is paid within a certain number of days from the date of the invoice cannot be considered as a basis for the bid evaluation. All bid prices must be net and not contingent on terms.

2.16 CERTIFICATES

The School Board reserves the right to require proof that the bidder is an established business and is abiding by the ordinances, regulations, and laws of their community, the county, and the State of Florida, such as but not limited to: Business Tax Receipts, Business Licenses, Florida Sales Tax Registration, Federal Employers Identification Number.

2.17 INSURANCE, LICENSES AND CERTIFICATES

The bidder agrees to provide and maintain at all times during the term of this agreement, without cost or expense to the School Board, policies of insurance insuring the bidder against any and all claims, demands or causes of action whatsoever, for injuries received or damage to property relating to the performance of duties, services and/or obligations of the bidder under the terms and provisions of this agreement. The bidder will provide the School Board with copies of current appropriate business licenses.

2.18 INSURANCE

The bidder shall secure and maintain, at its sole cost and expense during the contract term, the following insurance:

- Commercial General Liability – in the amount of \$3 million aggregate / \$1 million per occurrence.
- Liability – Auto, in the amount of \$100,000/300,000 / Any Auto
- Workers Compensation – As required by Florida law.

Requirements for bidders that qualify for an exemption under the Florida Worker's Compensation law in Chapter 440 Florida Statutes are detailed below:

Incorporated or unincorporated firms with fewer than four employees shall be required to sign a Hold Harmless Agreement relieving the School Board of liability in the event they and/or their employees are injured while providing goods and/or services to the School Board.

Incorporated or unincorporated firms with four or more employees shall be required to provide a copy of their "Notice of Election to be Exempt", along with valid proof of coverage for non-exempt employees.

The Hold Harmless Agreement mentioned above is included as an attachment to this bid. Said Agreements shall be returned with the bid proposal as detailed in the Submittal Requirements.

The School Board reserves the right to request a copy of the complete insurance policy(ies) and any endorsements for the insurance referenced above. A certificate of insurance indicating that

the bidder has coverage in accordance with the requirements herein set forth shall be furnished by the bidder to the School Board Representative prior to the execution of the contract and annually upon renewal thereafter. **The Bidder shall either cover any subcontractors on its policy or require the subcontractors to obtain coverage to meet all requirements for insurance contained herein.**

Bidder agrees that School Board will make no payments pursuant to the terms of the contract until all required proof or evidence of insurance has been provided to the School Board Representative. Bidder agrees that the insurer shall waive its rights of subrogation, if any, against the School Board on Commercial General Liability and Workers Compensation insurance coverage. The ACORD certificate of Liability Insurance, with endorsements shall be completed by the authorized Resident Agent and returned to the Purchasing Department. This certificate shall be dated and show:

- A. The name of the insured bidder, the specified job by name, name of the insurer, the number of the policy, its effective date and its termination date.
- B. Statement that the Insurer will mail notice to the School Board at least thirty (30) days prior to any material changes in provisions or cancellation of the policy.
- C. School Board shall be named as an additional insured on Commercial General Liability Insurance.**

Loss Deductible Clause: The School Board shall be exempt from, and in no way liable for, any sums of money that may represent a deductible in any insurance policy. The payment of such deductible shall be the sole responsibility of the bidder and/or sub-consultant providing such insurance.

2.19 SAFETY

The bidder shall take the necessary precautions and bear the sole responsibility for the safety of the methods employed in performing the work. The bidder shall at all times comply with the regulations set forth by federal, state, and local laws, rules, and regulations concerning "OSHA" and all applicable state labor laws, regulations, and standards. Bidder shall take all necessary precautions to ensure all materials provided do not include Asbestos. The bidder shall indemnify and hold harmless the School Board from and against all liabilities, suits, damages, costs, and expenses (including attorney's fees and court costs) which may be imposed on the School Board because of the bidder, sub-contractor, or supplier's failure to comply with the regulations.

2.20 DEVIATIONS

All Bid Submittals must clearly and with specific detail, note all deviations to the exact requirements imposed upon the bidder by the specifications. Such deviations must be stated upon the Bid Submittal Form; otherwise the School Board will consider the subject Bid Submittals as being made in strict compliance with said Specifications to bidders, the bidder being held therefore accountable and responsible. Bidders are hereby advised that School Board will only consider Bid Submittals that meet the exact requirements imposed by the specifications; except, however, said Bid Submittals may not be subject to such rejection where, **at the sole discretion of The School Board**, the stated deviation is considered to be equal or better than the imposed requirement and where said deviation does not destroy the competitive character of the Bid process by affecting the amount of the Bid Submittal such that an advantage or benefit is gained to the detriment of the other bidders.

2.21 MATERIAL SAFETY DATA SHEET

In accordance with Chapter 442 of the Florida Statutes, it is the bidder's responsibility to identify and to provide to the School District Purchasing Department a Material Safety Data Sheet for any material, as may apply to this procurement.

2.22 WAIVER OF CLAIMS

Once this contract expires, or final payment has been requested and made, the awarded bidder shall have no more than thirty (30) calendar days to present or file any claims against the School Board concerning this contract. After that period, the School Board will consider the bidder to have waived any right to claims against the School Board concerning this agreement.

2.23 TERMINATION / CANCELLATION OF CONTRACT

The School Board reserves the right to cancel the contract without cause with a minimum thirty (30) days written notice.

Termination or cancellation of the contract will not relieve the bidder of any obligations for any deliverables entered into prior to the termination of the contract (i.e., reports, statements of accounts, etc., required and not received).

Termination or cancellation of the contract will not relieve the bidder of any obligations or liabilities resulting from any acts committed by the bidder prior to the termination of the contract.

The bidder may cancel the resulting contract with one hundred twenty (120) days **written** notice to the Director of Purchasing and Warehouse. Failure to provide proper notice may result in the bidder being barred from future business with the School District.

2.24 TERMINATION FOR DEFAULT

The School District's Contract Administrator shall notify, in writing, the bidder of deficiencies or default in the performance of its duties under the Contract. Three separate documented instances of deficiency or failure to perform in accordance with the specifications contained herein shall constitute cause for termination for default, unless specifically specified to the contrary elsewhere within this solicitation. It shall be at the School Board's discretion whether to exercise the right to terminate. Bidder shall not be found in default for events arising due to acts of God.

2.25 TERMINATION FOR SCHOOL BOARD'S CONVENIENCE

The performance of work under this contract may be terminated in accordance with this clause in whole, or from the time in part, whenever the School Board representative shall determine that such termination is in the best interest of the School Board. Any such termination shall be effected by the delivery to the bidder of a Notice of Termination specifying the extent to which performance of work under the contract is terminated, and the date upon which such termination becomes effective. Upon such termination for convenience, bidder shall be entitled to payment, in accordance with the payment provisions, for services rendered up to the termination date and the School Board shall have no other obligations to bidder. Bidder shall be obligated to continue performance of contract services, in accordance with this contract, until the termination date and shall have no further obligation to perform services after the termination date.

2.26 INCURRED EXPENSES

This ITB does not commit the School Board to award a contract, nor shall the School Board be responsible for any cost or expense which may be incurred by the bidder in preparing and submitting the Submittal called for in this ITB, or any cost or expense incurred by the bidder prior to the execution of a contract agreement.

2.27 MINIMUM SPECIFICATIONS

The specifications listed herein are the minimum required specifications for this ITB. They are not intended to limit competition nor specify any particular bidder, but to ensure that the School District receives quality products and services.

2.28 COMPLIANCE WITH LAWS AND REGULATIONS

The bidder shall be responsible to know and to apply all applicable federal and state laws, all local laws, ordinances, rules, regulations, and all orders and decrees of bodies or tribunals having jurisdiction or authority which in any manner affect the work, or which in any way affect the

conduct of the work. Bidder shall always observe and comply with all such laws, ordinances, rules, regulations, orders, and decrees. The bidder shall protect and indemnify School Board and all its officers, agents, servants, or employees against any claim or liability arising from or based on the violation of any such law, ordinance, rule, regulation, order, or decree caused or committed by bidder, its representatives, sub-contractors, sub-consultants, professional associates, agents, servants, or employees. Additionally, bidder shall obtain and maintain at its own expense all licenses and permits to conduct business pursuant to this contract from the federal government, State of Florida, Osceola County, or municipalities when legally required, and maintain same in full force and effect during the term of the contract.

2.29 RECORDS & RIGHT TO AUDIT

The bidder shall maintain such financial records and other records as may be prescribed by the School Board or by applicable federal and state laws, rules, and regulations. The bidder shall retain these records for a period of three (3) years after final payment, or until the School Board audits them, whichever event occurs first. These records shall be made available during the term of the contract and the subsequent three-year period for examination, transcription, and audit by the School Board, its designees, or other entities authorized by law.

2.30 CHANGES IN SCOPE OF WORK/SERVICE

- A. The School Board may order changes in the work/service consisting of additions, deletions, or other revisions within the general scope of the contract. No claims may be made by the bidder that the scope of the project or of the bidder's services has been changed, requiring changes to the amount of compensation to the bidder or other adjustments to the contract, unless such changes or adjustments have been made by written amendment to the contract signed by the School Board Chair and the bidder.
- B. If the bidder believes that any particular work/service is not within the scope of work/service of the contract, is a material change, or will otherwise require more compensation to the bidder, the bidder must immediately notify the School Board's Representative in writing of this belief. If the School Board's Representative believes that the particular work/service is within the scope of the contract as written, the bidder will be ordered to and shall continue with the work/service as changed and at the cost stated for the work/service within the scope. The bidder must assert its right to an adjustment under this clause within thirty (30) days from the date of receipt of the written order.
- C. The School Board reserves the right to negotiate with the awarded bidder(s) without completing the competitive bidding process for materials, products, and/or services similar in nature to those specified within this ITB for which requirements were not known when the ITB was released.

2.31 MODIFICATIONS DUE TO PUBLIC WELFARE OR CHANGE IN LAW

The School Board shall have the power to make changes in the contract as the result of changes in Florida law and/or ordinances of Osceola County to impose new rules and regulations on the bidder under the contract relative to the scope and methods of providing services as shall from time-to-time be necessary and desirable for the public welfare. The School Board shall give the bidder notice of any proposed change and an opportunity to be heard concerning those matters. The scope and method of providing services as referenced herein shall also be liberally construed to include, but is not limited to, the manner, procedures, operations and obligations, financial or otherwise, of the bidder. In the event any future change in Federal, State or County law or the ordinances of Osceola County materially alters the obligations of the bidder, or the benefits to the School Board, then the contract shall be amended consistent therewith. Should these amendments materially alter the obligations of the bidder, then the bidder or the School Board shall be entitled to an adjustment in the rates and charges established under the contract. Nothing contained in the contract shall require any party to perform any act or function contrary to law. The School Board and bidder agree to enter into good faith negotiations regarding modifications to the contract, which may be required in order to implement changes in the interest of the public welfare or due to change in law. When such modifications are made to the contract,

the School Board and the bidder shall negotiate in good faith, a reasonable and appropriate adjustment for any changes in services or other obligations required of the bidder directly and demonstrably due to any modification in the contract under this clause.

2.32 RIGHT TO REQUIRE PERFORMANCE

- A. The failure of the School Board at any time to require performance by the bidder of any provision hereof shall in no way affect the right of the School Board thereafter to enforce same, nor shall waiver by the School Board of any breach of any provision hereof be taken or held to be a waiver of any succeeding breach of such provision or as a waiver of any provision itself.
- B. In the event of failure of the bidder to deliver services in accordance with the contract terms and conditions, the School Board, after due written notice, may procure the services from other sources and hold the bidder responsible for any resulting additional purchase and administrative costs. This remedy shall be in addition to any other remedies that the School Board may have.

2.33 FORCE MAJEURE

The School Board and the bidder will exercise every reasonable effort to meet their respective obligations as outlined in this ITB and the ensuing contract, but shall not be liable for delays resulting from force majeure or other causes beyond their reasonable control, including, but not limited to, compliance with any government law or regulation, acts of God, acts or omissions of the other party, government acts or omissions, fires, strikes, national disasters, wars, riots, transportation problems and/or any other cause whatsoever beyond the reasonable control of the parties. Any such cause will extend the performance of the delayed obligation to the extent of the delay so incurred.

2.34 BIDDER'S PERSONNEL

During the performance of the contract, the bidder agrees to the following:

- A. The bidder shall not discriminate against any employee or applicant for employment because of race, religion, color, sex, age, handicap or national origin, except when such condition is a bona fide occupational qualification reasonably necessary for the normal operations of the bidder. The bidder agrees to post in conspicuous places, visible to employees and applicants for employment, notices setting forth the provisions of this nondiscrimination clause.
- B. The bidder, in all solicitations or advertisements for employees placed by or on behalf of the bidder, shall state that such bidder is an Equal Opportunity Employer.
- C. Notices, advertisements, and solicitations placed in accordance with federal law, rule, or regulation shall be deemed sufficient for the purpose of meeting the requirements of this section.
- D. The bidder shall include the provisions of the foregoing paragraphs A, B, and C, above, in every subcontract or purchase order so that the provisions will be binding upon each bidder.
- E. The bidder and any sub-contractor shall pay all employees working on this contract not less than minimum wage specified in the Fair Labor Standards Act (29 CFR 510-794) as amended.
- F. Any information concerning the School Board, its products, services, personnel, policies or any other aspect of its business learned by the bidder or personnel furnished by the bidder in the course of providing services pursuant to the Agreement, shall be held in confidence and shall not be disclosed by the bidder or any employee or agents of the bidder or personnel furnished by the bidder, without the prior written consent of the School Board.

- G. All employees assigned by the Bidder to the performance of work under this contract shall be physically able to do their assigned work. It shall be the Bidder's responsibility to insure that all employees meet the physical standards to perform the work assigned and are free from communicable diseases. This requirement also includes acceptable hygiene habits of Bidder's employees.
- H. The personnel employed by the Bidder shall be capable employees, age 18 years or above, qualified in this type of work.
- I. It is the Bidder's responsibility to ensure that all employees are legally allowed to work in the United States in accordance with Immigration Policies.
- J. The Bidder's employees shall be required to dress neatly, commensurate with the tasks being performed.
- K. All District facilities are smoke free. Smoking on District grounds is prohibited.
- L. It is the Bidders responsibility to see that every employee on the Bidder's work force is provided and wears an Identification Badge or company shirt/uniform in order to maintain security at the school's facility. It shall be Bidder's responsibility to inform the School District Representative(s) of all new employees promptly at time of employment.
- M. The Bidder shall require employees to be dressed in their appropriate work attire when reporting for duty.
- N. The Bidder shall prohibit their employees from disturbing papers on desks, opening desk drawers or cabinets, or using telephone or office equipment provided for official use.
- O. The Bidder shall require their employees to comply with the instructions pertaining to conduct and building regulations, issued by duly appointed officials, such as the building managers, guards, inspectors, etc.
- P. The School District's Representative(s) will determine how the Bidder will receive access to the facility.
- Q. If keys are provided and lost, the Bidder will be responsible for any and all costs associated with replacement keys and re-keying of the facility.
- R. When requested, the Bidder shall cooperate with any ongoing SCHOOL BOARD investigation involving economic loss or damage to SCHOOL BOARD buildings, or SCHOOL BOARD or personal property therein. The SCHOOL BOARD reserves the right to require any employee of the Bidder to submit to a polygraph test if the SCHOOL BOARD has a reasonable suspicion that the employee is or was involved in the incident or activity under investigation. The Bidder shall obtain a waiver from the employee authorizing the release to the SCHOOL BOARD of information acquired by the Bidder from the polygraph test. The SCHOOL BOARD, at its discretion, may require that the Bidder immediately remove the employee under investigation from working within SCHOOL BOARD buildings for the following reasons: 1) The employee's refusal to submit to a polygraph test in the above circumstances, or 2) an employee's refusal to sign the waiver referenced above or 3) an analysis of the polygraph test indicates that the employee is or was involved in the incident under investigation. If the test results show involvement on the part of the Bidder's employee, the Bidder will be obligated to cover the cost of the examination. If the test results indicate that the Bidder's employee was not involved in the incident, when the SCHOOL BOARD will pay for the cost of the examination.

- S. CONTROLLED SUBSTANCE OR ALCOHOL ABUSE ON SCHOOL BOARD PROPERTY: The successful Bidder(s) is hereby notified that the unlawful manufacture, distribution, dispensation, possession or use of a controlled substance or alcohol is prohibited on any school district property, or at any school board activities. Violations may subject the Bidder and/or the Bidder's employee(s) to prosecution, fines, imprisonment and/or cancellation of this or any other contract(s) that this Bidder presently holds. The Bidder(s) are required by this school board to take appropriate disciplinary action in such cases and/or require that the employee(s) satisfactory participation in a rehabilitation program.
- T. Any Bidder's employee convicted of violating a criminal drug statute in the workplace must report the conviction to the employer within five (5) workdays. Bidders (Employers) are required to report such convictions to the school board within ten (10) workdays of receiving this information.
- U. The School District of Osceola County, Florida, is committed to the education and safety of its students and employees. To that end, any bidder awarded a contract will be required to assure that the personnel assigned to the project, do not possess criminal records that would violate the School Board's standards for employment as set forth by the Florida Department of Education. Each bidder must certify that the company and its employees are or will be in compliance with those standards for the project awarded.
- V. The Bidder shall strictly prohibit interaction between their employees and the student(s).
- W. Bidder's employees may not solicit, distribute or sell products while on School District property.
- X. Friends, visitors or family members of the Bidder's employees are not permitted in the work area.
- Y. The Bidder shall adhere to all of the District's security standards.

2.35 COMPLIANCE WITH THE JESSICA LUNSFORD ACT

Recent changes to the Florida Statutes require that all persons or entities entering into contracts with the School Boards/School Districts/Charter Schools who may have personnel who will be on school grounds when students may be present, or who will have contact with students shall comply with the level 2 screening requirements of the Statute and School District Standards. The required level 2 screening includes fingerprinting that must be conducted by the District. Any individual who fails to meet the screening requirements shall not be allowed on school grounds. Failure to comply with the screening requirements will be considered a material default of this contract/agreement.

2.36 CLAIM NOTICE

The bidder shall immediately report in writing to the School Board's designated representative or agent any incident that might reasonably be expected to result in any claim under any of the coverage mentioned herein. The bidder agrees to cooperate with the School Board in promptly releasing reasonable information periodically as to the disposition of any claims, including a resume' of claims experience relating to all bidder operations at the School Board project site.

2.37 BANKRUPTCY / INSOLVENCY

At the time of bid submittal, vendor/firm shall not be in the process of or engaged in any type of proceedings in insolvency or bankruptcy, either voluntary or involuntary, or receivership proceedings. If the vendor/firm is awarded a contract for six (6) months or longer, and files for bankruptcy, insolvency or receivership, the District may, at its option, terminate and cancel said contract, in which event all rights hereunder shall immediately cease and terminate.

2.38 CONTRACT/BIDDER RELATIONSHIP

The School Board reserves the right to award one or more contracts to provide the required services as deemed to be in the best interest of the School Board.

Any awarded bidder shall provide the services required herein strictly under a contractual relationship with the School Board and is not, nor shall be, construed to be an agent or employee of the School Board. As an independent bidder the awarded bidder shall pay any and all applicable taxes required by law; shall comply with all pertinent Federal, State, and local statutes including, but not limited to, the Fair Labor Standards Act, The Americans with Disabilities Act, the Federal Civil Rights Act, and any and all relevant employment laws. The bidder shall be responsible for all income tax, FICA, and any other withholdings from its employees' or sub-bidder's wages or salaries. Benefits for same shall be the responsibility of the bidder including, but not limited to, health and life insurance, mandatory Social Security, retirement, liability/risk coverage, and workers' and unemployment compensation.

The independent bidder shall hire, compensate, supervise, and terminate members of its work force; shall direct and control the manner in which work is performed including conditions under which individuals will be assigned duties, how individuals will report, and the hours individuals will perform.

The independent bidder shall not be exclusively bound to the School Board and may provide professional services to other private and public entities as long as it is not in direct conflict and does not provide a conflict of interest with the services to be performed for the School Board.

2.39 NEW MATERIAL

Unless otherwise provided for in this specification, the bidder represents and warrants that the goods, materials, supplies, or components offered to the School District under this Bid solicitation are new, not used or reconditioned, and are not of such age or so deteriorated as to impair their usefulness or safety and that the goods, materials, supplies, or components offered are current production models of the respective manufacturer. If the bidder believes that furnishing used or reconditioned goods, materials, supplies, or components will be in the School Board's interest, the bidder shall so notify the School District Buyer in writing no later than ten (10) working days prior to the date set for opening of Bids. The notice shall include the reasons for the request and any benefits that may accrue to the School District if the Buyer authorizes the Bidding of used or reconditioned goods, materials, supplies, or components.

2.40 DAMAGES

Due to the nature of the services to be provided and the potential impact to the School District for loss of *Video Surveillance Systems*, the bidder cannot disclaim consequential or inconsequential damages related to the performance of this contract. The bidder shall be responsible and accountable for any and all damages, directly or indirectly, caused by the actions or inaction of its employees, staff, or sub-consultants. There are no limitations to this liability.

2.41 CONFLICT OF INTEREST FORM

All bidders shall complete and have notarized the attached disclosure form of any potential conflict of interest that the bidder may have due to ownership, other clients, contracts, or interest associated with this project.

2.42 LITIGATION

Bidders shall submit details of all litigation, arbitration or other claims, whether pending or resolved in the last five years, with the exception of immaterial claims which are defined herein as claims with a possible value of less than \$25,000.00 or which have been resolved for less than \$25,000.00. Notwithstanding the foregoing, all litigation, arbitration or other claims, of any amount, asserted by or against a state, city, county, town, school district, political subdivision of a state, special district or any other governmental entity shall be disclosed. Please indicate for each cease the year, name of parties, cause of litigation, matter in dispute, disputed amount, and whether the award was for or against the Bidder.

2.43 DIVISION OF CORPORATIONS REGISTRATION REQUIREMENTS

Respondents who are required to be registered with the Division of Corporations or who are incorporated within the State of Florida must furnish their Florida document number. All registered respondents must have an active status in order to be eligible to do business with the School Board. 2.44 RESOLUTION OF BID PROTESTS

The School Board Rule 7.70.V shall be followed as outlined below for the resolution of any bid protests:

- A. The School Board shall follow the procedure specified in Florida Statutes, Section 120.57(3) and as the same may be amended from time to time for the resolution of bid protests.
- B. The Purchasing Department shall provide notice of a decision or intended decision concerning a solicitation, contract award, or exceptional purchase by electronic posting.

The notice shall contain the following statement:

Failure to file a protest within the time prescribed in Section 120.57(3), Florida Statutes, or failure to post the bond or other security required by law within the time allowed for filing a bond shall constitute a waiver of proceedings under Chapter 120, Florida Statutes.

- C. Any person who is adversely affected by the intended award of a solicitation or contract by the School Board or the recommendation of the Director of Purchasing or other responsible employee of the School Board shall file with the Director of Purchasing as agent for the School Board a notice of protest in writing within 72 hours after the electronic posting of the award or intended decision, and shall file a formal written protest within ten (10) days after the date he or she has filed the notice of protest. With respect to a protest of the specifications contained in a solicitation, the notice of protest shall be filed in writing within 72 hours after the electronic posting of the solicitation, and the formal written protest shall be filed within ten (10) days after the date the notice of protest is filed. All formal written protests must be filed with a bond payable to the School District equal to 1% of the estimated contract amount (Florida Statute 287.042(2)©). Failure to file a notice of protest or failure to file a formal written protest and bond shall constitute a waiver of proceedings under Chapter 120, Florida Statutes. The School Board may, in its discretion, waive any procedural irregularity or defect in procedures so long as any opposing party is not materially prejudiced by such waiver. Saturdays, Sundays, and state holidays shall be excluded in the computation of the 72-hour time periods provided by this paragraph. The notice of protest and formal written protest shall be filed in the Purchasing Department between the hours of 8:00 a.m. and 4:30 p.m. upon any day the office is open for business.

The provisions specified herein constitute the exclusive remedy for any adversely affected party with respect to a bid protest. The formal written protest shall state with particularity the facts and law upon which the protest is based.

- D. Upon receipt of the formal written protest which has been timely filed, the Purchasing Director shall stop the bid solicitation process or the contract award process until the subject of the protest is resolved by final agency action, unless the School Board, by duly enacted resolution sets forth in writing the particular facts and circumstances which require the continuance of the bid solicitation process or the contract award process

without delay in order to avoid an immediate and serious danger to the public health, safety or welfare.

The School Board finds that a substantial interest in the public welfare is the timely award of contracts when required as a condition of receiving grants or funds from outside sources which will be in addition to the regular school budget.

- E. The Purchasing Director shall schedule a meeting to provide an opportunity to resolve the protest by mutual agreement between the parties within seven (7) days, excluding Saturdays, Sundays, and state holidays, after receipt of a formal written protest and bond.
- F. If the Purchasing Director cannot resolve the protest by mutual agreement within the seven (7) day period referred to in Paragraph E in this Section, the School Board shall conduct an informal administrative hearing, under Section 120.57(2), Florida Statutes, acting as the agency head, where there are no disputed issues of material fact. The informal hearing shall be held with notice of no less than 72 hours, excluding Saturdays, Sundays, and legal holidays within thirty (30) days of receipt of the formal written protest and bond, unless the parties, with the consent of the School Board, agree to extend the time for the hearing. The School Board shall have the right to schedule the hearing subject to these provisions.

2.45 DEFINITIONS

As used in this Bid, the following terms shall have the meanings set forth below:

Bidder: That person or entity, including employees, servants, partners, principals, agents and assignees of the person or entity that has submitted a bid proposal for the purpose of obtaining business with the School District to provide the product and/or services set forth herein.

Contract Administrator: The School District's Director of Purchasing and Warehouse or designee shall serve as Contract Administrator. The Contract Administrator shall be responsible for addressing any concerns within the scope of the contract. Any changes to the resulting contract shall be done in writing and authorized by the Director of Purchasing and Warehouse and/or the School Board Chair.

Contract: The document resulting from this solicitation between the School District and the Bidder, including this bid, along with any written addenda and other written documents, which are expressly incorporated by reference.

Day: The word "day" means each calendar day or accumulation of calendar days.

Director: The Director is the Director of Purchasing and Warehouse for the School District.

Exceptions to Bid: An exception is defined as the Bidder's inability or unwillingness to meet a term, condition, specification, or requirement in the manner specified in the bid.

Person or Persons: An individual, firm, partnership, corporation, association, executor, administrator, trustee, or other legal entity, whether singular or plural, masculine or feminine, as the context may require.

School Board: The word School Board refers to the elected officials of the School Board of Osceola County, Florida.

School Board's Project Manager(s): The Project Manager(s) have responsibility for the day-to-day administration of the resulting contract for the School District and will be designated prior to award of the resulting Purchase Order.

School District: The word School District refers to the entity, The School District of Osceola County, Florida.

 8. Nothing contained in the foregoing shall be construed to require establishment of a system of records in order to render in good faith the certification required by this clause. The knowledge and information of a participant is not required to exceed that which is normally possessed by a prudent person in the ordinary course of business dealings.
 9. Except for transactions authorized under paragraph 5 of these instructions, if a participant in a covered transaction knowingly enters into a lower tier covered transaction with a person who is suspended, debarred, ineligible, or voluntarily excluded from participation in this transaction, in addition to other remedies available to the Federal Government, the department or agency with which this transaction may pursue available remedies, including suspension and/or debarment.

This Agreement is entered into as of the date of the last signature set forth below between the School District of Osceola County, a political subdivision of the State of Florida (the "District"), and the above named Respondent (hereinafter the "Respondent"). The School District of Osceola County and the Respondent are collectively referred to as the "Parties" and may be referred to individually as a Party.

RECITALS

WHEREAS, the Respondent possesses certain confidential trade secret materials that it wishes to disclose to the School District of Osceola County for the purpose of responding to a invitation to bid or otherwise conducting business with the School District; and

WHEREAS, the School District desires to review such materials in order to evaluate the District's interest in negotiating and concluding an agreement for the purchase of certain products and services, or otherwise conducting business with the Respondent.

NOW THEREFORE, in consideration of the mutual promises and premises contained herein, the receipt and sufficiency of which are hereby acknowledged, the School District and the Respondent agree as follows:

1. Confidential Materials. The Respondent warrants and represents to the School District that the materials described in the attached Exhibit A (the "Confidential Materials") constitute trade secrets as defined by Section 812.081(1)(c), Florida Statutes, or financial statements required by the School District for projects as defined in 119.071(1)(c), Florida Statutes. Subject to the terms and conditions of this Agreement, the School District agrees not to disclose such Confidential Materials

- to third parties.
2. Additional Materials. During the course of the negotiations or the business relationship with the School District, the Respondent may disclose additional confidential or trade secret information to the District in which case the restrictions and obligations on the use and disclosure of the Confidential Materials imposed by this Agreement shall also apply to such additional information to the extent permitted by Florida law. Any such additional confidential or trade secret information shall be duly marked and stamped “confidential” or “trade secret” prior to delivery to the School District, and shall be subject to this Agreement and Section 812.081(2), Florida Statutes, only if written receipt is provided by the School District acknowledging receipt of such materials.
 3. Exclusions. For purposes of this Agreement, the term “Confidential Materials” does not include the following:
 - (a) Information already known or independently developed by the School District;
 - (b) Information in the public domain through no wrongful act of the School District;
 - (c) Information received by the School District from a third party who was legally free to disclose it;
 - (d) Information disclosed by the Respondent to a third party without restriction on disclosure;
 - (e) Information disclosed by requirement of law or judicial order, including without limitation Chapter 119 Florida Statutes; or
 - (f) Information that is disclosed with the prior written consent of the Respondent, but only to the extent permitted by such consent.
 4. Non Disclosure by Respondent. In the event that the School District discloses confidential or trade secret information to Respondent, the Respondent agrees to not disclose such information to any third party or copy such information or use it for any purpose not explicitly set forth herein without the School District’s prior written consent. Further, upon conclusion of discussions or business transactions between the School District and the Respondent, or at any time upon request of the School District, Respondent agrees to return such information (including any copies) to the School District.
 5. Duty of Care. Each Party agrees to treat the other Party’s confidential or trade secret information with the same degree of care, but not less than reasonable care, as the receiving Party normally

- takes to preserve and protect its own similar confidential information and to inform its employees of the confidential nature of the disclosing Party's information and of the requirement of nondisclosure. In the event either Party has actual knowledge of a breach of the nondisclosure requirements set forth in this Agreement, the Party acquiring such knowledge shall promptly inform the other Party and assist that Party in curing the disclosure, where possible, and preventing future disclosures.
6. Limitations of Florida Law. Respondent understands and agrees that its assertion that any item is confidential or a trade secret does not, in and of itself, render such material exempt from the Florida Public Records Law, Chapter 119 of the Florida Statutes, and that the School District's ability to prevent disclosure of confidential and trade secret information may be subject to determination by a Florida court that such materials qualify for trade secret protection under Florida law. In the event a third party makes a public records request for the Confidential Materials or other materials deemed by Respondent to be confidential or a trade secret, the School District may submit the materials to the court for inspection in camera as set forth in Section 119.07(1)(e) Florida Statutes. Respondent further understands that the School District may be required to disclose such information if directed by a court of competent jurisdiction.
 7. Indemnification by Respondent. In the event of any litigation instituted by a third party to compel the School District to disclose such materials, Respondent shall, at its sole cost and expense, provide assistance to the School District in defending the denial of the records request, and shall hold the School District harmless from any claim for statutory costs and attorneys fees arising from the School District's refusal to disclose such materials.
 8. No Additional Obligations. This Agreement shall not be construed in any manner to be an obligation for either Party to enter into any subsequent contract or agreement.
 9. Sovereign Immunity. Nothing in this Agreement shall be deemed as a waiver of immunity or limits of liability of the School District beyond any statutory limited waiver of immunity or limits of liability, which has been or which may be adopted by the Florida Legislature, regardless of the nature of any claim which may arise, including but not limited to a claim sounding in tort, equity or contract. In no event shall the School District be liable for any claim or claims for breach of contract, including without limitation the wrongful disclosure of confidential or trade secret information for an amount which exceeds, individually and collectively, the then current statutory limits of liability for tort claims. Nothing in this Agreement shall inure to the benefit of any third party for the purpose of allowing any claim against the School District, which would otherwise be barred under the Doctrine of Sovereign Immunity or by operation of law.

10. Notice. Whenever either Party desires to give notice unto the other, it must be given by written notice, sent by registered United States mail, with return receipt requested, addressed to the party for whom it is intended, at the place last specified, and the place for giving of notice in compliance with the provisions of this paragraph. For the present, the Respondent designates the address set forth above as its place for receiving notice, and the School District designates the following address for such notice:

This Agreement shall be governed by the laws of the State of Florida, and venue for any action arising out of or relating to the subject matter of this Agreement shall be exclusively in Osceola County, Florida, or the Federal District Court for the Middle District of Florida, Orlando Division.

12. Respondent and the School District hereby expressly waive any rights either may have to a trial by jury of any civil litigation related to this Agreement for any litigation limited solely to the parties of this Agreement.

**Notification Regarding Public Entity Crime and Discriminatory Vendor List Requirements
