Submittals will be reviewed and evaluated as to qualifications to perform the services required by a Selection Committee consisting of School District staff; the selection committee will make a recommendation and present it to the School Board for approval.

It is anticipated that two (2) firms shall be selected to provide the necessary services for the projects outlined in the Scope of Services. The top ranked firm will be awarded Project #1 and the second ranked firm will be awarded Project #2.

Expressions of interest and qualification data will be received at the School District of Osceola County's Purchasing Department located at 817 Bill Beck Blvd., Bldg. 2000, Kissimmee, FL 34744, <u>until 2:00 PM on Wednesday, February 10, 2010</u>. ### **PURPOSE**

This document shall serve to provide interested parties with specific information as to the Procedures for Selection of Firms where the method of compensation is a Negotiated Fee on a Guaranteed Maximum Price or other methods of compensation depending upon the scope of services. Pursuant to Chapter 1013, Florida Statutes, the Florida Consultant's Competitive Negotiation Act, Section 287.055 Florida Statutes, and Rule 6A-2.0010, Florida Administrative Code, the School District of Osceola County, Florida will consider the contracting of two (2) Firms to provide professional services as outlined in the Scope of Services.

In determining whether Firms are qualified, the School District of Osceola County, Florida shall consider such factors as the ability of professional personnel; past performance; willingness to meet time and budget requirements; location of supporting office; recent, current, and projected workloads of the Firms.

### PROJECT DESCRIPTION

The School District of Osceola County is seeking the services of HVAC Test and Balance Firms for the Highlands Elementary School and Gateway High School Construction Projects.

### SCOPE OF SERVICES

A general description of the Scope of Services required will include, but not be limited to the following:

- 1. Pre-construction plan review will be performed to identify items which may cause problems in obtaining the final balance conditions, as required by the design. The review will include but will not be limited to; finding overlooked or missing items, elimination of items which may not be required, mechanical items which have caused problems due to malfunction or erroneous data, duct work that could prevent proper distribution, placement of air distribution outlets, etc. Upon completion of the review, a written report of the recommendations will be submitted. Adopted recommendations will be forwarded to the Project Architect and School District Representative(s). The HVAC Test and Balance Consultant will perform a minimum two (2) plan reviews for each construction project. The plan reviews will be performed during the Phase I and Phase II reviews of the project, or as required by the School District Representative(s).
- 2. Periodic inspections during construction will be made as the job advances. The HVAC Test and Balance Consultant will be required to visit the jobsite and make general inspections of the work being performed. A jobsite checklist will be made during these inspections which will include all items installed. Any discrepancies noted regarding equipment, installation, or placement will be immediately reported in writing to the School District Representative(s). Inspections will continue until completion of the project and each subsequent report will list corrections made from previous reports. The HVAC Test and Balance Consultant will assist the School District Representative(s) with resolving discrepancies and making corrections.
- 3. Air distribution test and balance or re-balance will include balancing of the air conditioning, ventilating, and exhaust systems to achieve the air quality specified. Prior to proceeding with work, the HVAC Test and Balance Consultant will perform a full inspection of all mechanical systems to determine their compliance with design drawings. A written report of deficiencies will be submitted to the School District Representative(s). Tests and procedures may include, but not be limited to the following:
  - a. Test fan RPM to design requirements;
  - b. Test and record motor running amperage for each phase;
  - c. Make pitot tube traverse at main supply ducts and obtain design CFM at fans;
  - d. Test and record systems static pressures, suction and discharge;

- e. Test and adjust system for design re-circulated air CFM;
- f. Test and adjust system for design outside air CFM (heating and cooling);
- g. Test and record entering air temperatures (dry bulb for heating and cooling);
- h. Test and record entering air temperatures (wet bulb for cooling);
- i. Adjust all main supply and return air ducts to proper design CFM;
- j. Adjust all zones to proper design CFM, supply and return;
- k. Test and adjust each diffuser, grille, and register to within plus or minus 10 percent of design requirements, if possible. If not possible, balance to optimum performance capability of system and inform the School District Representative(s) in writing;
- I. In cooperation with the control manufacturer's representatives, setting adjustments of automatically operated dampers to operate as specified, indicated, and/or noted. The HVAC Test and Balance Consultant will check all controls for proper calibrations and list all controls requiring adjustment.
- m. All diffusers, grilles, and registers will be adjusted to minimize drafts in all areas;
- n. Fume hood fans will be adjusted to CFM requirements specified. Test of fume hood enclosures will be made to determine velocities across opening in accordance with applicable safety codes.
- 4. Hydronic systems test and balance or re-balance will include balancing of condenser, chilled and heating hot water circulating systems to obtain water quantities, and temperature differentials through all system components. The HVAC Test and Balance Consultant will perform the tests and adjustments, listed below, in balancing the hydronic systems. Prior to proceeding with work, the HVAC Test and Balance Consultant will perform a full inspection of all mechanical systems to determine their compliance with design drawings. A written report of deficiencies will be submitted to the School District Representative(s). Prior to commencing any tasks in this category, all water systems will be determined by the HVAC Test and Balance Consultant to be free of construction debris and/or any foreign materials. The work may include, but not be limited to, the following types of tests and procedures:
  - a. Perform when requested, performance evaluation of water chiller (centrifugal or reciprocal) in conformance with ARI 550-83 (or latest applicable procedure).
  - b. Test and record pump head at full flow and no flow.
  - c. Record pump motor running amps, volts, and brake horsepower.
  - d. Compare pump operating head and brake horsepower with pump curve for flow verification.
  - e. Test and record flow station pressure drop in corresponding GPM.
  - f. Test and record chiller and condenser pressure drops, and entering and leaving water temperatures.
  - g. Balance condenser water flow cooling tower particularly to each cooling tower basin, and perform an eight hour log study of cooling tower.
  - h. Test and record terminal elements pressure drop, entering and leaving wet and dry bulb temperatures.
  - i. Test and record terminal elements final total heat transfer.
  - j. List water metering device readings.
- 5. Sound analysis, if requested by Owner, the HVAC Test and Balance Consultant will conduct tests in selected areas of the building as specified. Sound level readings will be measured in decibels on the A and C scales of the General Radio Sound Level Meter or equal sound level meter that meets the current American Standard procedures based on the acoustic referenced power of db/re 10.13 watts. Readings will set forth the total

random sound level of the selected rooms or areas with the system in operation as compared to total background sound level with the system not in operation.

- 6. The system increase over the background level will be recorded in decibels on the A and C scales. If sound levels are above those specified, adjustments will be made to bring the sound level within the range set forth, if possible, with the equipment installed.
- 7. A corrective action report will include all test results by building number and room number where the various tests occurred. Reading and thermal analysis performed during the major component performance analysis will be stated and compared with the manufacturer's specifications of the components. Problems will be generally and specifically identified and recommendations for corrective action(s) will be provided to the School District Representative(s).
- 8. Corrective action inspection will occur upon completion of those items selected by the School District Representative(s) from the corrective action report for repair, adjustment, or clearing. The HVAC Test and Balance Consultant will submit a written report to the School District Representative(s) providing the results of the inspection prior to proceeding with the test and balance of air distribution and hydronic systems.
- Instruction of operation to School District personnel will occur upon completion of the testing and balancing of all systems. The HVAC Test and Balance Consultant will provide a thorough review of the final HVAC Test and Balance report including any open deficiencies and design concerns to the School District Representative(s).
- 10. The following services will be provided under work designated New Construction:
  - a. Pre-construction plan review;
  - b. Periodic inspection during construction;
  - c. Air distribution test and balance;
  - d. Hydronic systems test and balance;
  - e. Sound analysis, if requested;
  - f. Reporting results to the School District Representative(s) of inspections, tests, and/or work performed;
  - g. Instruction of operation to School District personnel.
- 11. The following services will be provided under any work designated Existing Facilities:
  - a. Major component performance analysis;
  - b. Corrective action report;
  - c. Corrective action inspection;
  - d. Air distribution test and balance;
  - e. Hydronic systems test and balance; and,
  - f. Reporting results of inspections, tests, and/or work performed to the School District Representative(s).
- 12. The following services will be provided under any work designated Consultations and Troubleshooting:
  - a. When directed, investigate problems of existing systems;
  - b. Report findings of investigation;
  - c. If directed, perform corrective work to make system operative or more efficient.

# COMMISSIONING SERVICES

Commissioning Services shall be provided in four (4) phases: Design, Construction, Acceptance, and Post-Acceptance, in accordance with the **ACG Commissioning Guideline**. The Scope of Services as described in each phase shall be provided for the following base building systems:

- 1. Supply/outdoor air.
- 2. Return air.
- 3. Exhaust air.
- 4. Chilled water.
- 5. Condenser water. (If Applicable)
- 6. Hot water.
- 7. HVAC control system.

ACG stands for A.A.B.C. (Associated Air Balance Council) Commissioning Group

### **Design Phase:**

During the design phase the commissioning agency shall carry out the following scope of work:

1. Review the design documents (drawings and specifications) as they are prepared to ensure inclusion of material covering the contractor's responsibilities for commissioning; provide comments and suggestions for designer and owners consideration

### Construction Phase:

During the construction phase the commissioning agency shall carry out the following scope of work:

- 1. Organize and lead the commissioning team.
- 2. Review shop drawings and equipment submittals for information affecting the commissioning process.
- 3. Update the commissioning plan to reflect equipment and controls data from the submittals, and provide commissioning schedule information that the contractor can integrate into the project schedule.
- 4. Schedule and lead commissioning meetings.
- 5. Establish and maintain a system for tracking issues needing resolution.
- 6. Review the project schedule periodically to ensure commissioning activities are properly incorporated; provide feedback to the designer and owner as needed.
- 7. Perform on-site observations during construction.
- 8. Monitor correct component and equipment installation; including controls point-to-point checkouts. Document all observations.
- 9. Witness equipment and system start-ups as deemed necessary. Ensure complete documentation of same.

### Acceptance Phase:

During the acceptance phase the commissioning agency shall carry out the following scope of work:

1. Conduct functional performance testing of sub-systems, systems, and interactions between systems, leading to acceptance of the completed work. Document results of all tests witnessed.

#### Post-Acceptance Phase:

During the post-acceptance phase the commissioning agency shall carry out the following scope of work:

- 1. Conduct functional performance testing of sub-systems, systems, and interactions between systems that could not be carried out prior to acceptance due to unsuitable weather conditions.
- 2. Prepare and submit a final commissioning report.
- 3. Provide follow-up for quality performance during the guarantee period.

### TEST & BALANCE QUALIFICATIONS

In order to be qualified to perform services under the HVAC Test and Balance Contract, a firm must meet the following basic requirements and provide documentation when required:

- 1. Minimum of five (5) years of documented experience in the field of services, in compliance with Florida Building Code Chapter 13.
- 2. Test & Balance experience with the School District of Osceola County or other school districts.
- Documentation as to the Respondent's personnel experience, which shall include the name and registration number of the staff's professional engineer(s), if applicable, and/or the resume(s) and certification(s) of the field technician(s) who will be performing the work.
- 4. Proposal shall address and assure the School District that all services performed and/or provided will be under the direction of a registered Florida State Professional Engineer or the organization itself has been approved and licensed by the Associated Air Balance Council, (A.A.B.C.), headquarters in Washington, D.C.; per the rules of Florida State Board of Educational Facilities, State Requirements for Educational Facilities.
- 5. Photocopy of the current annual A.A.B.C. certificate issued to the firm shall be provided in the proposal.

### SUBMITTAL REQUIREMENTS

Firms interested in providing the required professional services shall submit one (1) original, marked "ORIGINAL", Ten (10) each marked "COPY", and two (2) COMPLETE electronic copies on two separate CD's in PDF format, of the requested qualification data for evaluation.

\*\*\*\*\*If a Non-disclosure Agreement is signed and confidential materials are submitted, such confidential materials shall not be included on the master CD. Confidential materials shall be segregated on a separate CD, plainly labeled "Confidential Materials". \*\*\*\*\*

### QUESTIONS CONCERNING RFQ

Cheryl M. Jessee is the designated Purchasing Agent and will be responsible for facilitating the entire selection process. Ms. Jessee shall be the sole point of contact for all Respondents. Vendors, contractors, consultants, or their representatives shall not meet with, speak individually with, or otherwise communicate with School Board members, the Superintendent, or School District staff, other than the designated purchasing agent, and School Board members, the Superintendent, or School District staff, other than the designated purchasing agent, shall not meet with, speak individually with, or otherwise communicate with vendors, contractors, consultants, or their representatives, about potential contracts with the School Board once an invitation to bid, request for quote, request for proposal, invitation to negotiate, or request for qualifications has been issued.

Any such communication shall disqualify the vendor, contractor, or consultant from responding to the subject invitation to bid, request for quote, request for proposal, invitation to negotiate, or request for qualifications.

Failure by a potential Respondent to ask questions or request changes by the dates indicated shall constitute the Respondent's acceptance of the requirements set forth in this RFQ.

No answers given in response to questions submitted shall be binding upon this RFQ unless released in writing as an addendum to the RFQ.

Failure to provide the required copies and information may result in the proposal not being considered. Submittals shall be clear, concise, indexed by subject, typed on letter size paper, and individually bound. Submittals shall be mailed or delivered in a sealed package clearly marked on the outside with the project name, invitation number, and due date. Packages shall be received in the School District of Osceola County's Purchasing Department by the advertised deadline. Each respondent should ensure that they have received any/all addenda and amendments to this RFQ before submitting their proposal. Please check the School District's web site at

Opportunities- Construction" **for any addenda.** Delivery of a package to any School District location other than the Purchasing Department does not constitute official receipt by the School District of Osceola County. Any package delivered after the advertised deadline will not be considered. Proposals shall be submitted in the order listed below.

In the instance where a specific requirement(s) may not apply to the project in question, a statement must be inserted at the tab location stating the reason(s) of non-applicability.

During the entire solicitation and evaluation process all contact must be channeled through the designated Purchasing Agent. Failure to comply with these procedures shall be cause for disqualification of the Firm's expression of interest.

# ECONOMY OF PRESENTATION

Each qualifications package shall be prepared simply and economically, providing a straightforward, concise description of the Respondent's capabilities to satisfy the conditions and requirements of this RFQ. Fancy bindings, colored displays, and promotional material are not desired. Elaborate and verbose proposals are discouraged. Special and elaborate printing of proposals beyond that, which is normal for your profession, is discouraged. Information in addition to that specifically requested (i.e. videotapes, photographs, in-depth Firm history, lengthy and repetitive resumes, etc.) is strongly discouraged. The information requested should be submitted in a concise, easy to read format. Emphasis in each qualifications package must be on completeness and clarity of content. To expedite the evaluation of qualifications packages, it is **mandatory** that Respondents follow the format and instructions contained herein. The School District is not liable or responsible for any costs incurred by any Respondent in responding to this RFQ including, without limitation, costs for presentations and/or demonstrations if requested. Applications that do not comply with the instructions including information outlined in the Qualification Package Guidelines will not be considered. All information received will be maintained with the project file and cannot be returned.

# **QUALIFICATION PACKAGE GUIDELINES**

- 1. To facilitate analysis of its qualifications package, the Respondent shall prepare its qualifications package in accordance with the instructions outlined in this section. If the Respondent's qualifications package deviates from these instructions, such qualifications package may, in the School District's sole discretion, be rejected.
- 2. The School District emphasizes that the Respondent concentrate on accuracy, completeness, and clarity of content.
- 3. Cross Referencing To the greatest extent possible, each section shall be written on a stand-alone basis so that its contents may be evaluated with a minimum of cross-referencing to other sections of the qualifications package. Information required for evaluation of qualifications, which is not found in its designated section, will be assumed to have been omitted from the qualifications package.
- 4. Glossary of Abbreviations and Acronyms Each section shall contain a glossary of all abbreviations and acronyms used, with an explanation for each. If no abbreviations and/or acronyms are used, then a glossary is not required.

- 5. Page Size and Format Page size shall be 8.5 x 11 inches, not including foldouts. Pages shall be single-spaced. The text size shall be 11 point or larger. Use at least one (1) inch margins on the top and bottom and three-quarter (3/4) inch side margins. Pages shall be numbered sequentially by section.
- 6. Legible tables, charts, graphs and figures shall be used wherever practical to depict organizations, systems and layouts, implementation schedules, plans, etc. These displays shall be uncomplicated, legible and shall not exceed eleven (11) by seventeen (17) inches in size. Foldout pages shall fold entirely within the section, and count as a single page. Foldout pages may only be used for large tables, charts, graphs, diagrams and schematics; and not for pages of text.
- 7. Binding and Labeling All sections of the qualifications package should be spiral bound, with section tabs, which shall permit the qualifications package to lie flat when opened. Staples shall not be used.

# QUALIFICATION PACKAGE GUIDELINES - TABBED SECTIONS

# GENERAL REQUIREMENTS

Qualification Packages will be scored using Adjectival Rating times a weighted value. Adjectival Rating; Unsatisfactory (0), Marginal (1), Satisfactory (2), Good (3) and Excellent (4).

### Tab 1 Letter of Introduction and Table of Contents (non-scored)

A brief profile of the Firm, including a brief history of the company, location, project team location, corporate structure, ownership interest, and the length of company's existence shall be provided addressed in a letter to the Director of Purchasing, <u>not to exceed 3 single-sided pages maximum</u>.

### Tab 2 Insurance and Miscellaneous Forms (non-scored)

Attach evidence of required insurance coverage or proof of insurability in the amounts indicated. If available, a properly completed ACORD Form is preferable. Final forms must contain the correct solicitation and/or project number and School District of Osceola County contact person.

Firms that have owner/operators that have filed a "Notice of Election to be Exempt" shall submit a copy with the proposal.

Incorporated and unincorporated Firms that qualify for an exemption under the Florida Worker's Compensation law in Chapter 440 Florida Statutes shall submit an executed waiver relieving the School District of liability in the event they are injured while providing goods and/or services to the School District.

# <u>Prohibition Against Contingent Fees Statement and Certificate of Debarment</u> <u>Form</u> - See forms included in this package.

Each professional service contract entered into, shall include a prohibition against contingent fees as follows: "The Firm warrants that it has not employed or retained any company or person, other than a bona fide employee working solely for the Firm to solicit or secure this agreement and that it has not paid or agreed to pay any person, company, corporation, individual, or Firm, other than a bona fide employee working solely for any fee, commission, percentage, gift, or other consideration contingent upon or resulting from the award or making of this agreement." For the breach or violation of this provision, the School Board shall have the right to terminate the agreement without liability and, at its discretion, to deduct from the Contract price, or otherwise recover, the full amount of such fee, commission, percentage, gift, or consideration.

<u>Conflict of Interest Disclosure Form</u> - See form included in this package.

All Respondents shall properly complete, have notarized and attach with their proposal the attached notarized disclosure statement of any potential conflict of interest that the Respondent may have due to ownership, other clients, contracts or interests associated with this project.

**<u>Confidential Materials</u>** - Confidential materials shall be submitted in this section – any materials that qualify as "trade secrets" shall be segregated, clearly labeled and accompanied by an executed Non Disclosure Agreement for Confidential Materials.

### Tab 4Business Location (weighted value of 3 to 7 points)

**Principal Office Location** - Location of principal office which will be responsible for implementation of this Contract.

**Other Office Locations** - Location of other offices from which resources may be drawn.

### Firms shall only be able to qualify for one of the three following sections:

- **4.a.** To qualify as an "Osceola County Business" and to obtain a weighted value of 7 points a firm must meet the following criterion and submit the attached Affidavit of Eligibility:
  - **4.a.1.** Has its headquarters, manufacturing facility, or locally-owned franchise located within the legal boundaries of Osceola County for <u>at least one (1)</u> year prior to the issuance of the Request for Qualifications solicitation and
  - **4.a.2.** Maintains a required business license by a jurisdiction located in Osceola County.
- **4.b.**To qualify as a "Regional Business" and to obtain a weighted value of 5 points a firm must meet the following criterion and submit the attached Affidavit of Eligibility:
  - **4.b.1.** Has its headquarters, manufacturing facility, or locally-owned franchise located within the legal boundaries of Osceola County, Orange County, Seminole County, Brevard County, Lake County, Polk County or Volusia County for at least <u>one (1) year</u> prior to the issuance of the Request for Qualifications solicitation and
  - **4.b.2.** Maintains a required business license by at least one of the jurisdictions listed in Section 4.b.1.
- **4.c.**To qualify as a "Florida Business" and to obtain a weighted value of 3 points a firm must meet the following criterion and submit the attached Affidavit of Eligibility:
  - **4.c.1.** Has its headquarters, manufacturing facility, or locally-owned franchise located in Florida for at least <u>one (1) year</u> prior to the issuance of the Request for Qualifications solicitation and
  - **4.c.2.** Maintains a required business license by at least one jurisdiction in Florida.

# Tab 5 Business Structure (weighted value of 10 points)

Corporation, Joint Venture, or Partnership. Submit a copy of the State of Florida Department of State records indicating when the corporation organized, corporation number, and date and status of the most recent annual report. Respondents submitting as joint ventures shall submit a copy of their joint venture agreement. If a joint venture or prime/subcontractor arrangement of two Firms, indicate how the work will be distributed between the partners.

**Time in Business** - Length of time the Firm has been in business under same name.

Capabilities - Size, resources, and capabilities of responding entity:

- a. Organizational structure of business entity for this program (partners, associates, consultants, sub-contractors, other participation).

- **4.** The successful Firm shall not discriminate against any person in accordance with federal, state, or local law.
- 5. The School Board reserves the right to award the Contract to a single Firm or make multiple awards to multiple Firms.
- 6. Firms will be notified in writing as to whether or not they have been selected for this Contract.

# COMPLIANCE WITH THE JESSICA LUNSFORD ACT

The Firm shall secure and maintain, at its sole cost and expense during the contract term, insurance coverage as outlined in the attached draft contract.

Firm shall indemnify and shall hold School Board and School District harmless as provided in draft contract attached hereto as "Draft Contract".

A certificate of insurance indicating that the Firm has coverage in accordance with the requirements herein set forth shall be furnished by the Firm to the School District of Osceola County along with their qualification data. The Firm shall either cover any sub-contractors on its policy or require the sub-contractors to conform to all requirements for insurance contained herein.

Firm agrees that the School District of Osceola County will make no payments pursuant to the terms of the contract until all required proof or evidence of insurance has been provided to the Purchasing Representative. Firm agrees that the Insurer shall waive its rights of subrogation, if any, against the School District. These shall be completed by the authorized Resident Agent and returned to the Purchasing Representative.

Upon award: This certificate shall be dated and show:

- A. The name of the insured Firm, the specified job by name, name of the Insurer, the number of the policy, its effective date and its termination date.
- B. Statement that the Insurer will mail notice to the School District of Osceola County at least thirty (30) days prior to any material changes in provisions or cancellation of the policy.

# C. The School District of Osceola County shall be named as an additional insured on General Liability Insurance.

**Loss Deductible Clause**: The School District shall be exempt from, and in no way liable for, any sums of money that may represent a deductible in any insurance policy. The payment of such deductible shall be the sole responsibility of the Firm and/or sub-consultant providing such insurance.

# DISCLOSURE OF PROPOSAL CONTENT

- A. All material submitted becomes the property of the School District of Osceola County and may be returned only at the District's option. The School District has the right to use any or all ideas presented in any reply to this Request for Qualifications. Selection or rejection of any Proposal does not affect this right.
- B. The School District of Osceola County, Florida, is governed by the Public Records Law, Chapter 119, Florida Statutes (F.S.). Only trade secrets as defined in Section 812.081(1)(c), F.S. or financial statements required by the School District for projects as defined in 119.071(1)(c), F.S. (hereinafter "Confidential Materials"), may be exempt from disclosure. If a respondent submits Confidential Materials, the information **must be segregated**, accompanied by an executed Non Disclosure Agreement for Confidential Materials and each pertinent page must be clearly labeled "confidential" or "trade secret." The School District will not disclose such Confidential Materials, subject to the conditions detailed within the Agreement, which is attached to this solicitation. When such segregated and labeled materials are received with an executed Agreement, the School District shall execute the Agreement and send the Respondent a "Receipt for Trade Secret Information."

**EXPENSES INCURRED** This invitation does not commit the School District of Osceola County to award a contract. Nor shall the School District be responsible for any cost or expense incurred by any Respondent in preparing and submitting a reply, nor for any cost or expense incurred by any Respondent prior to the execution of a contract agreement

<u>AMERICANS WITH DISABILITIES ACT</u> Individuals covered by the Americans with Disabilities Act of 1990 in need of accommodations to attend public openings and meetings should contact the School District of Osceola County's Purchasing Department in Kissimmee, Florida at telephone (407) 870-4630 or fax (407) 870-4616 at least five (5) days prior to the date accommodations are required.

### RESOLUTION OF BID PROTESTS

The School Board Rule 7.70.V shall be followed as outlined below for the resolution of any bid protests:

- A. The School Board shall follow the procedure specified in Florida Statutes, Section 120.57(3) and as the same may be amended from time to time for the resolution of bid protests.
- B. The Purchasing Department shall provide notice of a decision or intended decision concerning a solicitation, contract award, or exceptional purchase by electronic posting.

The notice shall contain the following statement:

Failure to file a protest within the time prescribed in Section 120.57(3), Florida Statutes, or failure to post the bond or other security required by law within the time allowed for filing a bond shall constitute a waiver of proceedings under Chapter 120, Florida Statutes.

C. Any person who is adversely affected by the intended award of a solicitation or contract by the School Board or the recommendation of the Director of Purchasing or other responsible employee of the School Board shall file with the Director of Purchasing as agent for the School Board a notice of protest in writing within 72 hours after the electronic posting of the award or intended decision, and shall file a formal written protest within ten (10) days after the date he or she has filed the notice of protest. With respect to a protest of the specifications contained in a solicitation, the notice of protest shall be filed in writing within 72 hours after the electronic posting of the solicitation, and the formal written protest shall be filed within ten (10) days after the date the notice of protest is filed. All formal written protests must be filed with a bond payable to the School District equal to 1% of the estimated contract amount (Florida Statute 287.042(2)(c)). Failure to file a notice of protest or failure to file a formal written protest and bond shall constitute a waiver of proceedings under Chapter 120, Florida Statutes. The School Board may, in its discretion, waive any procedural irregularity or defect in procedures so long as any opposing party is not materially prejudiced by such waiver. Saturdays, Sundays, and state holidays shall be excluded in the computation of the 72hour time periods provided by this paragraph. The notice of protest and

formal written protest shall be filed in the Purchasing Department between the hours of 8:00 a.m. and 4:30 p.m. upon any day the office is open for business.

The provisions specified herein constitute the exclusive remedy for any adversely affected party with respect to a bid protest. The formal written protest shall state with particularity the facts and law upon which the protest is based.

D. Upon receipt of the formal written protest which has been timely filed, the Purchasing Director shall stop the bid solicitation process or the contract award process until the subject of the protest is resolved by final agency action, unless the School Board, by duly enacted resolution sets forth in writing the particular facts and circumstances which require the continuance of the bid solicitation process or the contract award process without delay in order to avoid an immediate and serious danger to the public health, safety or welfare.

The School Board finds that a substantial interest in the public welfare is the timely award of contracts when required as a condition of receiving grants or funds from outside sources which will be in addition to the regular school budget.

**HVAC Test and Balance-** A systematic process or service applied to heating, ventilating and air-conditioning (HVAC) systems and other environmental systems to achieve and document air and hydronic flow rates.

**HVAC Test and Balance Consultant-** Respondent's primary representative and project manager.

**National Environmental Balancing Bureau (NEBB)** - A nonprofit organization, founded in 1971 by contractors in the heating, ventilating and air conditioning (HVAC) industry. NEBB exists to help architects, engineers, building owners, and contractors produce great buildings with HVAC systems that perform in ways they have been visualized and designed. <u>http://www.nebb.org</u>

**Owner -** The School District, School Board, and or designated representative(s).

**Project Architect** - The Project Architect role usually indicates the individual who is responsible for overseeing the Architectural aspects of the development of the design and production of the construction documents ("plans") and specifications. The position generally involves coordinating the needs of the School District, designer and technical staff, and outside consultants such as Structural Engineers, Mechanical Engineers, Civil Engineers, and Landscape architects.

**Purchasing Representative** – Director of Purchasing & Warehouse or designee for the School District of Osceola County, Florida.

**Respondent -** The person, Firm, or corporation who submits a response.

School Board - The Osceola County Schools Board Members

School District- The School District Osceola County, Florida.

School District Project Manager - The user department Project Manager for the project.

**Scope of Services -** The complete details of the services involved in the design, fabrication, and assembly of the components of a project's deliverables into a working product.

**State Requirements For Educational Facilities (SREF)** - The SREF is generally organized by sequence of steps required in the facilities procurement process and covers general definitions, property acquisition/disposal, finance, lease and lease-purchase, historic buildings, program development, professional services, inspection services, design standards, and inspection standards.

# Notification Regarding Public Entity Crime and Discriminatory Vendor List

# **Requirements and Disqualification Provision**

A. Pursuant to Florida Statutory requirements, potential Respondents are notified:

287.133(2)(b) A public entity may not accept any bid, proposal, or reply from, award any contract to, or transact any business in excess of the threshold amount provided in s. 287.017 for CATEGORY TWO with any person or affiliate on the convicted vendor list for a period of 36 months following the date that person or affiliate was placed on the convicted vendor list unless that person or affiliate has been removed from the list pursuant to paragraph (3)(f). A public entity that was transacting business with a person at the time of the commission of a public entity crime resulting in that person being placed on the convicted vendor list may not accept any bid, proposal, or reply from, award any contract to, or transact any business with any other person who is under the same, or substantially the same, control as the person whose name appears on the convicted vendor list.

287.134(2)(a) An entity or affiliate who has been placed on the discriminatory vendor list may not submit a bid, proposal, or reply on a contract to provide any goods or services to a public entity; may not submit a bid, proposal, or reply on a contract with a public entity for the construction or repair of a public building or public work; may not submit bids, proposals, or replies on leases of real property to a public entity; may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity; and may not transact business with any public entity.

287.134(2)(b) A public entity may not accept any bid, proposals, or replies from, award any contract to, or transact any business with any entity or affiliate on the discriminatory vendor list for a period of 36 months following the date that entity or affiliate was placed on the discriminatory vendor list unless that entity or affiliate has been removed from the list pursuant to paragraph (3)(f). A public entity that was transacting business with an entity at the time of the discrimination resulting in that entity being placed on the discriminatory vendor list may not accept any bid, proposal, or reply from, award any contract to, or transact any business with any other entity who is under the same, or substantially the same, control as the entity whose name appears on the discriminatory vendor list.

- B. By submitting a proposal, the Respondent represents and warrants that the submission of its proposal does not violate Section 287.133, Florida Statutes, nor Section 287.134, Florida Statutes.
- C. In addition to the foregoing, the Respondent represents and warrants that Respondent, Respondent's subcontractors and Respondent's implementer, if any, is not under investigation for violation of such statutes.
- D. Respondent should read carefully all provisions of 287.133 and 287.134, Florida Statutes.

This Agreement is entered into as of the date of the last signature set forth below between the School District of Osceola County, a political subdivision of the State of Florida (the "District"), and the above named Respondent (hereinafter the "Respondent"). The School District of Osceola County and the Respondent are collectively referred to as the "Parties" and may be referred to individually as a Party.

# RECITALS

WHEREAS, the Respondent possesses certain confidential trade secret materials that it wishes to disclose to the School District of Osceola County for the purpose of responding to a request for proposal or otherwise conducting business with the School District; and

WHEREAS, the School District desires to review such materials in order to evaluate the District's interest in negotiating and concluding an agreement for the purchase of certain products and services, or otherwise conducting business with the Respondent.

NOW THEREFORE, in consideration of the mutual promises and premises contained herein, the receipt and sufficiency of which are hereby acknowledged, the School District and the Respondent agree as follows:

1. <u>Confidential Materials</u>. The Respondent warrants and represents to the School District that the materials described in the attached <u>Exhibit A</u> (the "Confidential Materials") constitute trade secrets as defined by Section 812.081(1)(c), Florida Statutes, or financial statements required by the School District for projects as defined in 119.071(1)(c), Florida Statutes. Subject to the terms and conditions of this Agreement, the School District agrees not to disclose such Confidential Materials to third parties.

2. <u>Additional Materials</u>. During the course of the negotiations or the business relationship with the School District, the Respondent may disclose additional confidential or trade secret information to the District in which case the restrictions and obligations on the use and disclosure of the Confidential Materials imposed by this Agreement shall also apply to such additional information to the extent permitted by Florida law. Any such additional confidential or trade secret information shall be duly marked and stamped "confidential" or "trade secret" prior to delivery to the School District, and shall be subject to this Agreement and Section 812.081(2), Florida Statutes, only if written receipt is provided by the School District acknowledging receipt of such materials.

3. <u>Exclusions</u>. For purposes of this Agreement, the term "Confidential Materials" does not include the following:

- (a) Information already known or independently developed by the School District;
- (b) Information in the public domain through no wrongful act of the School District;
- (c) Information received by the School District from a third party who was legally free to disclose it;
- (d) Information disclosed by the Respondent to a third party without restriction on disclosure;

- (e) Information disclosed by requirement of law or judicial order, including without limitation Chapter 119 Florida Statutes; or
- (f) Information that is disclosed with the prior written consent of the Respondent, but only to the extent permitted by such consent.

4. <u>Non Disclosure by Respondent</u>. In the event that the School District discloses confidential or trade secret information to Respondent, the Respondent agrees to not disclose such information to any third party or copy such information or use it for any purpose not explicitly set forth herein without the School District's prior written consent. Further, upon conclusion of discussions or business transactions between the School District and the Respondent, or at any time upon request of the School District, Respondent agrees to return such information (including any copies) to the School District.

5. <u>Duty of Care</u>. Each Party agrees to treat the other Party's confidential or trade secret information with the same degree of care, but not less than reasonable care, as the receiving Party normally takes to preserve and protect its own similar confidential information and to inform its employees of the confidential nature of the disclosing Party's information and of the requirement of nondisclosure. In the event either Party has actual knowledge of a breach of the nondisclosure requirements set forth in this Agreement, the Party acquiring such knowledge shall promptly inform the other Party and assist that Party in curing the disclosure, where possible, and preventing future disclosures.

6. <u>Limitations of Florida Law</u>. Respondent understands and agrees that its assertion that any item is confidential or a trade secret does not, in and of itself, render such material exempt from the Florida Public Records Law, Chapter 119 of the Florida Statutes, and that the School District's ability to prevent disclosure of confidential and trade secret information may be subject to determination by a Florida court that such materials qualify for trade secret protection under Florida law. In the event a third party makes a public records request for the Confidential Materials or other materials deemed by Respondent to be confidential or a trade secret, the School District may submit the materials to the court for inspection in camera as set forth in Section 119.07(1)(e) Florida Statutes. Respondent further understands that the School District may be required to disclose such information if directed by a court of competent jurisdiction.

7. <u>Indemnification by Respondent</u>. In the event of any litigation instituted by a third party to compel the School District to disclose such materials, Respondent shall, at its sole cost and expense, provide assistance to the School District in defending the denial of the records request, and shall hold the School District harmless from any claim for statutory costs and attorneys fees arising from the School District's refusal to disclose such materials.

8. <u>No Additional Obligations</u>. This Agreement shall not be construed in any manner to be an obligation for either Party to enter into any subsequent contract or agreement.

9. <u>Sovereign Immunity</u>. Nothing in this Agreement shall be deemed as a waiver of immunity or limits of liability of the School District beyond any statutory limited waiver of immunity or limits of liability, which has been or which may be adopted by the Florida Legislature, regardless of the nature of any claim which may arise, including but not limited to a claim sounding in tort, equity or contract. In no event shall the School District be liable for any claim or claims for breach of contract, including without limitation the wrongful disclosure of confidential or trade secret information for an amount which exceeds, individually and collectively, the then current statutory limits of liability for tort claims. Nothing in this Agreement shall inure to the benefit of any third party for the purpose of allowing any claim against the School District, which would otherwise be barred under the Doctrine of Sovereign Immunity or by operation of law.

10. <u>Notice</u>. Whenever either Party desires to give notice unto the other, it must be given by written notice, sent by registered United States mail, with return receipt requested, addressed to the party for whom it is intended, at the place last specified, and the place for giving of notice in compliance with the provisions of this paragraph. For the present, the Respondent designates the address set forth above as its place for receiving notice, and the School District designates the following address for such notice:

This Agreement shall be governed by the laws of the State of Florida, and venue for any action arising out of or relating to the subject matter of this Agreement shall be exclusively in Osceola County, Florida, or the Federal District Court for the Middle District of Florida, Orlando Division.

12. Respondent and the School District hereby expressly waive any rights either may have to a trial by jury of any civil litigation related to this Agreement for any litigation limited solely to the parties of this Agreement.
