### COURSE DESCRIPTION

The Equivalency of Training (EOT) Program permits an Out-of-State, Federal, or previously certified Florida officer with a break-in-service of 4-8 years to obtain their Florida Law Enforcement Officer's certification without completing a full basic recruit academy if they meet the standards of 943.131(2). This intensive 48-hour program requires all attendees to demonstrate proficiency skills and qualify in the high liability training areas of Defensive Tactics, Firearms, Vehicle Operations, and First Aid per Florida's CJSTC training standards. Individuals planning to attend should be in good physical condition prior to enrolling.

### COMPLETION REQUIREMENTS

Students must demonstrate proficiency in all high liability training areas. Remediation is not provided for students who cannot pass performance testing per required standards. All course completers must take and pass the State Officer Certification Exam prior to the one-year expiration date listed on their CJSTC-76 Forms. No exceptions!
